1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2020, section 119B.11, subdivision 2a, is amended to read:
1.8	Subd. 2a. Recovery of overpayments. (a) An amount of child care assistance paid to a
1.9	recipient or provider in excess of the payment due is recoverable by the county agency or
1.10	commissioner under paragraphs (b) and (c), even when the overpayment was caused by
1.11	agency error or circumstances outside the responsibility and control of the family or provider.
1.12	(b) An overpayment must be recouped or recovered from the family if the overpayment
1.13	benefited the family by causing the family to pay less for child care expenses than the family
1.14	otherwise would have been required to pay under child care assistance program requirements.
1.15	If the family remains eligible for child care assistance, the overpayment must be recovered
1.16	through recoupment as identified in Minnesota Rules, part 3400.0187, except that the
1.17	overpayments must be calculated and collected on a service period basis. If the family no
1.18	longer remains eligible for child care assistance, the county or commissioner may choose
1.19	to initiate efforts to recover overpayments from the family for overpayment overpayments

(c) The county or commissioner must recover an overpayment from a provider if the 2.12 overpayment did not benefit the family by causing it to receive more child care assistance 2.13 or to pay less for child care expenses than the family otherwise would have been eligible 2.14 to receive or required to pay under child care assistance program requirements, and benefited 2.15 the provider by causing the provider to receive more child care assistance than otherwise 2.16 would have been paid on the family's behalf under child care assistance program 2.17 requirements. If the provider continues to care for children receiving child care assistance, 2.18 the overpayment must be recovered through reductions in child care assistance payments 2.19 for services as described in an agreement with the county recoupment as identified in 2.20 Minnesota Rules, part 3400.0187. The provider may not charge families using that provider 2.21 more to cover the cost of recouping the overpayment. Sec. 2. Minnesota Statutes 2020, section 119B.125, subdivision 1, is amended to read: 3.15

Subdivision 1. Authorization. Except as provided in subdivision 5, A county or the 3.16 commissioner must authorize the provider chosen by an applicant or a participant before 3.17 the county can authorize payment for care provided by that provider. The commissioner 3.18 must establish the requirements necessary for authorization of providers. A provider must 3.19 be reauthorized every two years. A legal, nonlicensed family child care provider also must 3.20 be reauthorized when another person over the age of 13 joins the household, a current 3.21 household member turns 13, or there is reason to believe that a household member has a 3.22 factor that prevents authorization. The provider is required to report all family changes that 3.23 would require reauthorization. When a provider has been authorized for payment for 3.24 providing care for families in more than one county, the county responsible for 3.25 reauthorization of that provider is the county of the family with a current authorization for 3.26 that provider and who has used the provider for the longest length of time. 3.27

(b) Notwithstanding paragraph (a), children with documented medical conditions that 6.4 cause more frequent absences may exceed the 25 absent days limit, or ten consecutive 6.5 full-day absent days limit. Absences due to a documented medical condition of a parent or 6.6 sibling who lives in the same residence as the child receiving child care assistance do not 6.7 count against the absent days limit in a calendar year. Documentation of medical conditions 6.8 must be on the forms and submitted according to the timelines established by the 6.9 commissioner. A public health nurse or school nurse may verify the illness in lieu of a 6.10 medical practitioner. (c) Notwithstanding paragraph (a), children in families may exceed the absent days limit 6.14 if at least one parent: (1) is under the age of 21; (2) does not have a high school diploma or 6.15 commissioner of education-selected high school equivalency certification; and (3) is a 6.16 student in a school district or another similar program that provides or arranges for child 6.17 care, parenting support, social services, career and employment supports, and academic 6.18 support to achieve high school graduation, upon request of the program and approval of the 6.19 county. If a child attends part of an authorized day, payment to the provider must be for the 6.20 full amount of care authorized for that day. 6.21

6.22 (d) Child care providers must be reimbursed for up to ten federal or state holidays or
6.23 designated holidays per year when the provider charges all families for these days and the

# 119B.04 FEDERAL CHILD CARE AND DEVELOPMENT FUND.

Subdivision 1. Commissioner to administer program. The commissioner is authorized and directed to receive, administer, and expend funds available under the child care and development fund under Public Law 104-193, Title VI.

Subd. 2. **Rulemaking authority.** The commissioner may adopt rules under chapter 14 to administer the child care and development fund.

## **119B.125 PROVIDER REQUIREMENTS.**

Subd. 5. **Provisional payment.** After a county receives a completed application from a provider, the county may issue provisional authorization and payment to the provider during the time needed to determine whether to give final authorization to the provider.
