1.23 Subd. 8. Report. The commissioner must submit a report to the chairs of the house
1.24 of representatives and senate committees and divisions with jurisdiction over agriculture
1.25 and environment and natural resources by December 15 each year that details the total
1.26 amount of damages paid, by elk herd, in the previous two fiscal years.

1.27 Sec. 2. Minnesota Statutes 2014, section 16C.135, is amended by adding a subdivision
1.28 to read:

2.1 Subd. 4. **Certain vehicles and equipment.** The commissioner of natural resources
2.2 is not required to purchase or use ethanol-blended fuel for off-road vehicles, boats,

2.17 vehicle trail or use area unless the vehicle displays ~~a nonresident~~ an off-road vehicle state
2.18 trail pass sticker issued according to this section. The pass must be viewable by a peace
2.19 officer, a conservation officer, or an employee designated under section 84.0835.

2.20 (b) ~~The fee for an annual pass is \$20. The pass is valid from January 1 through~~
2.21 ~~December 31. The fee for a three-year pass is \$30.~~ The commissioner of natural resources
2.22 shall issue a pass upon application and payment of the fee. Fees collected under this
2.23 section, except for the issuing fee for licensing agents, shall be deposited in the state
2.24 treasury and credited to the off-road vehicle account in the natural resources fund and,
2.25 except for the electronic licensing system commission established by the commissioner
2.26 under section 84.027, subdivision 15, must be used for grants-in-aid to counties and
2.27 municipalities for off-road vehicle organizations to construct and maintain off-road

3.5 (d) The fee for an annual nonresident off-road vehicle state trail pass is \$20. The
3.6 nonresident pass is valid from January 1 through December 31. The fee for a nonresident
3.7 three-year pass is \$30.

3.8 (e) The fee for a resident off-road vehicle state trail pass is \$20. The resident pass is
3.9 valid for 30 consecutive days after the date of issuance.

3.10 Subd. 2. **License agents.** The commissioner may appoint agents to issue and
3.11 sell ~~nonresident~~ off-road vehicle state trail passes. The commissioner may revoke the
3.12 appointment of an agent at any time. The commissioner may adopt additional rules as
3.13 provided in section 97A.485, subdivision 11. An agent shall observe all rules adopted
3.14 by the commissioner for accounting and handling of passes pursuant to section 97A.485,
3.15 subdivision 11. An agent shall promptly deposit and remit all money received from the
3.16 sale of the passes, exclusive of the issuing fee, to the commissioner.

3.17 Subd. 3. **Issuance of passes.** The commissioner and agents shall issue and sell

3.21 Subd. 4. **Agent's fee.** In addition to the fee for a pass, an issuing fee of \$1 per pass
3.22 shall be charged. The issuing fee may be retained by the seller of the pass. Issuing fees for
3.23 passes issued by the commissioner shall be deposited in the off-road vehicle account in the
3.24 natural resources fund and retained for the operation of the electronic licensing system.

- (1) the development, restoration, and maintenance of suitable habitat for wild turkeys on public and private land including forest stand improvement and establishment of nesting cover, winter roost area, and reliable food sources;
- (2) acquisitions of, or easements on, critical wild turkey habitat;
- (3) reimbursement of expenditures to provide wild turkey habitat on public and private land;
- (4) trapping and transplantation of wild turkeys; and
- (5) the promotion of turkey habitat development and maintenance, population surveys and monitoring, and research.

(b) Money in the account may not be used for:

- (1) costs unless they are directly related to a specific parcel of land under paragraph (a), clauses (1) to (3), a specific trap and transplant project under paragraph (a), clause (4), or to specific promotional or evaluative activities under paragraph (a), clause (5); or
- (2) any permanent personnel costs.
