(a) \$4,235,000 in fiscal year 2021 is appropriated from the general fund to the
commissioner of human services to increase room and board rates under Minnesota Statutes,
chapter 256I, by 10.7 percent for purposes of maintaining access to room and board, including
activities necessary to comply with federal and state health and safety guidance in response
to the COVID-19 pandemic. This is a onetime appropriation.

(b) Prior to July 1, 2021, providers must submit documentation to the commissioner of human services demonstrating increased funding was used for needs related to COVID-19 for the time period during which the money appropriated under this section was expended.

**EFFECTIVE DATE.** This section is effective the day following final enactment.
