2.1	(n) Multipurpose community facility means a building that is designed to jointly and
2.2	directly enable work, education, and health monitoring by members of the public. This
2.3	includes but is not limited to full-service community schools that provide academic
2.4	programming to students and adult education in the community at large, health monitoring
2.5	to students and the community, and workforce training or career counseling services to

3.30	by a grantee on or before December 1, 2026, must be returned to the commissioner for
3.31	deposit in the coronavirus capital projects fund in the state treasury at the time and in the
3.32	form and manner as the commissioner prescribes.
