1.19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.20 **ARTICLE 1**

1.21 **GENERAL ASSISTANCE MEDICAL CARE**

1.22 Section 1. **[245.4862] MENTAL HEALTH URGENT CARE AND PSYCHIATRIC**
1.23 **CONSULTATION.**

1.24 **Subdivision 1. Mental health urgent care and psychiatric consultation.** The
1.25 commissioner shall include mental health urgent care and psychiatric consultation
1.26 services as part of, but not limited to, the redesign of six community-based behavioral
1.27 health hospitals and the Anoka-Metro Regional Treatment Center. These services must
1.28 not duplicate existing services in the region, and must be implemented as specified in
1.29 subdivisions 3 to 7.

2.1 Subd. 2. **Definitions.** For purposes of this section:

2.2 (1) mental health urgent care includes:

2.3 (i) initial mental health screening;

2.4 (ii) mobile crisis assessment and intervention;

2.5 (iii) rapid access to psychiatry, including psychiatric evaluation, initial treatment,
2.6 and short-term psychiatry;

2.7 (iv) nonhospital crisis stabilization residential beds; and

2.8 (v) health care navigator services which include, but are not limited to, assisting
2.9 uninsured individuals in obtaining health care coverage; and

2.10 (2) psychiatric consultation services includes psychiatric consultation to primary
2.11 care practitioners.

2.12 Subd. 3. **Rapid access to psychiatry.** The commissioner shall develop rapid access
2.13 to psychiatric services based on the following criteria:

2.14 (1) the individuals who receive the psychiatric services must be at risk of
2.15 hospitalization and otherwise unable to receive timely services;

2.16 (2) where clinically appropriate, the service may be provided via interactive video
2.17 where the service is provided in conjunction with an emergency room, a local crisis
2.18 service, or a primary care or behavioral care practitioner; and

2.19 (3) the commissioner may integrate rapid access to psychiatry with the psychiatric
2.20 consultation services in subdivision 4.

2.21 Subd. 4. **Collaborative psychiatric consultation.** (a) The commissioner shall
2.22 establish a collaborative psychiatric consultation service based on the following criteria:

2.23 (1) the service may be available via telephone, interactive video, e-mail, or other
2.24 means of communication to emergency rooms, local crisis services, mental health
2.25 professionals, and primary care practitioners, including pediatricians;

2.26 (2) the service shall be provided by a multidisciplinary team including, at a
2.27 minimum, a child and adolescent psychiatrist, an adult psychiatrist, and a licensed clinical
2.28 social worker;

2.29 (3) the service shall include a triage-level assessment to determine the most
2.30 appropriate response to each request, including appropriate referrals to other mental health
2.31 professionals, as well as provision of rapid psychiatric access when other appropriate
2.32 services are not available;

2.33 (4) the first priority for this service is to provide the consultations required under
2.34 section 256B.0625, subdivision 13j; and

2.35 (5) the service must encourage use of cognitive and behavioral therapies and other
2.36 evidence-based treatments in addition to or in place of medication, where appropriate.

3.1 (b) The commissioner shall appoint an interdisciplinary work group to establish
3.2 appropriate medication and psychotherapy protocols to guide the consultative process,
3.3 including consultation with the Drug Utilization Review Board, as provided in section
3.4 256B.0625, subdivision 13j.

3.5 Subd. 5. **Phased availability.** (a) The commissioner may phase in the availability
3.6 of mental health urgent care services based on the limits of appropriations and the
3.7 commissioner's determination of level of need and cost-effectiveness.

3.8 (b) For subdivisions 3 and 4, the first phase must focus on adults in Hennepin
3.9 and Ramsey Counties and children statewide who are affected by section 256B.0625,
3.10 subdivision 13j, and must include tracking of costs for the services provided and
3.11 associated impacts on utilization of inpatient, emergency room, and other services.

3.12 Subd. 6. **Limited appropriations.** The commissioner shall maximize use
3.13 of available health care coverage for the services provided under this section. The
3.14 commissioner's responsibility to provide these services for individuals without health care
3.15 coverage must not exceed the appropriations for this section.

3.16 Subd. 7. **Flexible implementation.** To implement this section, the commissioner
3.17 shall select the structure and funding method that is the most cost-effective for each county
3.18 or group of counties. This may include grants, contracts, direct provision by state-operated
3.19 services, and public-private partnerships. Where feasible, the commissioner shall make
3.20 any grants under this section a part of the integrated adult mental health initiative grants
3.21 under section 245.4661.

3.22 Sec. 2. Minnesota Statutes 2009 Supplement, section 256.969, subdivision 3a, is
3.23 amended to read:

3.24 Subd. 3a. **Payments.** (a) Acute care hospital billings under the medical
3.25 assistance program must not be submitted until the recipient is discharged. However,
3.26 the commissioner shall establish monthly interim payments for inpatient hospitals that
3.27 have individual patient lengths of stay over 30 days regardless of diagnostic category.
3.28 Except as provided in section 256.9693, medical assistance reimbursement for treatment
3.29 of mental illness shall be reimbursed based on diagnostic classifications. Individual
3.30 hospital payments established under this section and sections 256.9685, 256.9686, and
3.31 256.9695, in addition to third party and recipient liability, for discharges occurring during
3.32 the rate year shall not exceed, in aggregate, the charges for the medical assistance covered
3.33 inpatient services paid for the same period of time to the hospital. This payment limitation
3.34 shall be calculated separately for medical assistance and general assistance medical
3.35 care services. The limitation on general assistance medical care shall be effective for

4.1 admissions occurring on or after July 1, 1991. Services that have rates established under
4.2 subdivision 11 or 12, must be limited separately from other services. After consulting with
4.3 the affected hospitals, the commissioner may consider related hospitals one entity and
4.4 may merge the payment rates while maintaining separate provider numbers. The operating
4.5 and property base rates per admission or per day shall be derived from the best Medicare
4.6 and claims data available when rates are established. The commissioner shall determine
4.7 the best Medicare and claims data, taking into consideration variables of recency of the
4.8 data, audit disposition, settlement status, and the ability to set rates in a timely manner.
4.9 The commissioner shall notify hospitals of payment rates by December 1 of the year
4.10 preceding the rate year. The rate setting data must reflect the admissions data used to
4.11 establish relative values. Base year changes from 1981 to the base year established for the
4.12 rate year beginning January 1, 1991, and for subsequent rate years, shall not be limited
4.13 to the limits ending June 30, 1987, on the maximum rate of increase under subdivision
4.14 1. The commissioner may adjust base year cost, relative value, and case mix index data
4.15 to exclude the costs of services that have been discontinued by the October 1 of the year
4.16 preceding the rate year or that are paid separately from inpatient services. Inpatient stays
4.17 that encompass portions of two or more rate years shall have payments established based
4.18 on payment rates in effect at the time of admission unless the date of admission preceded
4.19 the rate year in effect by six months or more. In this case, operating payment rates for
4.20 services rendered during the rate year in effect and established based on the date of
4.21 admission shall be adjusted to the rate year in effect by the hospital cost index.

4.22 (b) For fee-for-service admissions occurring on or after July 1, 2002, the total
4.23 payment, before third-party liability and spenddown, made to hospitals for inpatient
4.24 services is reduced by .5 percent from the current statutory rates.

4.25 (c) In addition to the reduction in paragraph (b), the total payment for fee-for-service
4.26 admissions occurring on or after July 1, 2003, made to hospitals for inpatient services
4.27 before third-party liability and spenddown, is reduced five percent from the current
4.28 statutory rates. Mental health services within diagnosis related groups 424 to 432, and
4.29 facilities defined under subdivision 16 are excluded from this paragraph.

4.30 (d) In addition to the reduction in paragraphs (b) and (c), the total payment for
4.31 fee-for-service admissions occurring on or after August 1, 2005, made to hospitals for
4.32 inpatient services before third-party liability and spenddown, is reduced 6.0 percent
4.33 from the current statutory rates. Mental health services within diagnosis related groups
4.34 424 to 432 and facilities defined under subdivision 16 are excluded from this paragraph.
4.35 Notwithstanding section 256.9686, subdivision 7, for purposes of this paragraph, medical
4.36 assistance does not include general assistance medical care. Payments made to managed

5.1 care plans shall be reduced for services provided on or after January 1, 2006, to reflect
5.2 this reduction.

5.3 (e) In addition to the reductions in paragraphs (b), (c), and (d), the total payment for
5.4 fee-for-service admissions occurring on or after July 1, 2008, through June 30, 2009, made
5.5 to hospitals for inpatient services before third-party liability and spenddown, is reduced
5.6 3.46 percent from the current statutory rates. Mental health services with diagnosis related
5.7 groups 424 to 432 and facilities defined under subdivision 16 are excluded from this
5.8 paragraph. Payments made to managed care plans shall be reduced for services provided
5.9 on or after January 1, 2009, through June 30, 2009, to reflect this reduction.

5.10 (f) In addition to the reductions in paragraphs (b), (c), and (d), the total payment for
5.11 fee-for-service admissions occurring on or after July 1, 2009, through June 30, ~~2010~~ 2011,
5.12 made to hospitals for inpatient services before third-party liability and spenddown, is
5.13 reduced 1.9 percent from the current statutory rates. Mental health services with diagnosis
5.14 related groups 424 to 432 and facilities defined under subdivision 16 are excluded from
5.15 this paragraph. Payments made to managed care plans shall be reduced for services
5.16 provided on or after July 1, 2009, through June 30, ~~2010~~ 2011, to reflect this reduction.

5.17 (g) In addition to the reductions in paragraphs (b), (c), and (d), the total payment
5.18 for fee-for-service admissions occurring on or after July 1, ~~2010~~ 2011, made to hospitals
5.19 for inpatient services before third-party liability and spenddown, is reduced 1.79 percent
5.20 from the current statutory rates. Mental health services with diagnosis related groups
5.21 424 to 432 and facilities defined under subdivision 16 are excluded from this paragraph.
5.22 Payments made to managed care plans shall be reduced for services provided on or after
5.23 July 1, ~~2010~~ 2011, to reflect this reduction.

5.24 (h) In addition to the reductions in paragraphs (b), (c), (d), (f), and (g), the total
5.25 payment for fee-for-service admissions occurring on or after July 1, 2009, made to
5.26 hospitals for inpatient services before third-party liability and spenddown, is reduced
5.27 one percent from the current statutory rates. Facilities defined under subdivision 16 are
5.28 excluded from this paragraph. Payments made to managed care plans shall be reduced for
5.29 services provided on or after October 1, 2009, to reflect this reduction.

5.30 **EFFECTIVE DATE.** This section is effective April 1, 2010.

5.31 Sec. 3. Minnesota Statutes 2008, section 256.969, subdivision 27, is amended to read:

5.32 Subd. 27. **Quarterly payment adjustment.** (a) In addition to any other payment
5.33 under this section, the commissioner shall make the following payments effective July
5.34 1, 2007:

6.1 (1) for a hospital located in Minnesota and not eligible for payments under
6.2 subdivision 20, with a medical assistance inpatient utilization rate greater than 17.8
6.3 percent of total patient days as of the base year in effect on July 1, 2005, a payment
6.4 equal to 13 percent of the total of the operating and property payment rates, except that
6.5 Hennepin County Medical Center and Regions Hospital shall not receive a payment
6.6 under this subdivision;

6.7 (2) for a hospital located in Minnesota in a specified urban area outside of the
6.8 seven-county metropolitan area and not eligible for payments under subdivision 20, with
6.9 a medical assistance inpatient utilization rate less than or equal to 17.8 percent of total
6.10 patient days as of the base year in effect on July 1, 2005, a payment equal to ten percent
6.11 of the total of the operating and property payment rates. For purposes of this clause, the
6.12 following cities are specified urban areas: Detroit Lakes, Rochester, Willmar, Alexandria,
6.13 Austin, Cambridge, Brainerd, Hibbing, Mankato, Duluth, St. Cloud, Grand Rapids,
6.14 Wyoming, Fergus Falls, Albert Lea, Winona, Virginia, Thief River Falls, and Wadena;

6.15 (3) for a hospital located in Minnesota but not located in a specified urban area
6.16 under clause (2), with a medical assistance inpatient utilization rate less than or equal to
6.17 17.8 percent of total patient days as of the base year in effect on July 1, 2005, a payment
6.18 equal to four percent of the total of the operating and property payment rates. A hospital
6.19 located in Woodbury and not in existence during the base year shall be reimbursed under
6.20 this clause; and

6.21 (4) in addition to any payments under clauses (1) to (3), for a hospital located in
6.22 Minnesota and not eligible for payments under subdivision 20 with a medical assistance
6.23 inpatient utilization rate of 17.9 percent of total patient days as of the base year in effect
6.24 on July 1, 2005, a payment equal to eight percent of the total of the operating and property
6.25 payment rates, and for a hospital located in Minnesota and not eligible for payments
6.26 under subdivision 20 with a medical assistance inpatient utilization rate of 59.6 percent
6.27 of total patient days as of the base year in effect on July 1, 2005, a payment equal to
6.28 nine percent of the total of the operating and property payment rates. After making any
6.29 ratable adjustments required under paragraph (b), the commissioner shall proportionately
6.30 reduce payments under clauses (2) and (3) by an amount needed to make payments under
6.31 this clause.

6.32 (b) The state share of payments under paragraph (a) shall be equal to federal
6.33 reimbursements to the commissioner to reimburse expenditures reported under section
6.34 256B.199, paragraphs (a) to (d). The commissioner shall ratably reduce or increase
6.35 payments under this subdivision in order to ensure that these payments equal the amount
6.36 of reimbursement received by the commissioner under section 256B.199, paragraphs (a)

7.1 to (d), except that payments shall be ratably reduced by an amount equivalent to the state
7.2 share of a four percent reduction in MinnesotaCare and medical assistance payments
7.3 for inpatient hospital services. Effective July 1, 2009, the ratable reduction shall be
7.4 equivalent to the state share of a three percent reduction in these payments. Effective for
7.5 federal disproportionate share hospital funds earned on payments reported under section
7.6 256B.199, paragraphs (a) to (d), for services rendered on or after April 1, 2010, payments
7.7 shall not be made under this subdivision.

7.8 (c) The payments under paragraph (a) shall be paid quarterly based on each hospital's
7.9 operating and property payments from the second previous quarter, beginning on July
7.10 15, 2007, or upon federal approval of federal reimbursements under section 256B.199,
7.11 paragraphs (a) to (d), whichever occurs later.

7.12 (d) The commissioner shall not adjust rates paid to a prepaid health plan under
7.13 contract with the commissioner to reflect payments provided in paragraph (a).

7.14 (e) The commissioner shall maximize the use of available federal money for
7.15 disproportionate share hospital payments and shall maximize payments to qualifying
7.16 hospitals. In order to accomplish these purposes, the commissioner may, in consultation
7.17 with the nonstate entities identified in section 256B.199, paragraphs (a) to (d), adjust,
7.18 on a pro rata basis if feasible, the amounts reported by nonstate entities under section
7.19 256B.199, paragraphs (a) to (d), when application for reimbursement is made to the federal
7.20 government, and otherwise adjust the provisions of this subdivision. The commissioner
7.21 shall utilize a settlement process based on finalized data to maximize revenue under
7.22 section 256B.199, paragraphs (a) to (d), and payments under this section.

7.23 (f) For purposes of this subdivision, medical assistance does not include general
7.24 assistance medical care.

7.25 **EFFECTIVE DATE.** This section is effective for services rendered on or after
7.26 April 1, 2010.

7.27 Sec. 4. Minnesota Statutes 2008, section 256B.0625, subdivision 13f, is amended to
7.28 read:

7.29 Subd. 13f. **Prior authorization.** (a) The Formulary Committee shall review and
7.30 recommend drugs which require prior authorization. The Formulary Committee shall
7.31 establish general criteria to be used for the prior authorization of brand-name drugs for
7.32 which generically equivalent drugs are available, but the committee is not required to
7.33 review each brand-name drug for which a generically equivalent drug is available.

7.34 (b) Prior authorization may be required by the commissioner before certain
7.35 formulary drugs are eligible for payment. The Formulary Committee may recommend

8.1 drugs for prior authorization directly to the commissioner. The commissioner may also
8.2 request that the Formulary Committee review a drug for prior authorization. Before the
8.3 commissioner may require prior authorization for a drug:

8.4 (1) the commissioner must provide information to the Formulary Committee on the
8.5 impact that placing the drug on prior authorization may have on the quality of patient care
8.6 and on program costs, information regarding whether the drug is subject to clinical abuse
8.7 or misuse, and relevant data from the state Medicaid program if such data is available;

8.8 (2) the Formulary Committee must review the drug, taking into account medical and
8.9 clinical data and the information provided by the commissioner; and

8.10 (3) the Formulary Committee must hold a public forum and receive public comment
8.11 for an additional 15 days.

8.12 The commissioner must provide a 15-day notice period before implementing the prior
8.13 authorization.

8.14 (c) Except as provided in subdivision 13j, prior authorization shall not be required or
8.15 utilized for any atypical antipsychotic drug prescribed for the treatment of mental illness if:

8.16 (1) there is no generically equivalent drug available; and

8.17 (2) the drug was initially prescribed for the recipient prior to July 1, 2003; or

8.18 (3) the drug is part of the recipient's current course of treatment.

8.19 This paragraph applies to any multistate preferred drug list or supplemental drug rebate
8.20 program established or administered by the commissioner. Prior authorization shall
8.21 automatically be granted for 60 days for brand name drugs prescribed for treatment of
8.22 mental illness within 60 days of when a generically equivalent drug becomes available,
8.23 provided that the brand name drug was part of the recipient's course of treatment at the
8.24 time the generically equivalent drug became available.

8.25 (d) Prior authorization shall not be required or utilized for any antihemophilic factor
8.26 drug prescribed for the treatment of hemophilia and blood disorders where there is no
8.27 generically equivalent drug available if the prior authorization is used in conjunction with
8.28 any supplemental drug rebate program or multistate preferred drug list established or
8.29 administered by the commissioner.

8.30 (e) The commissioner may require prior authorization for brand name drugs
8.31 whenever a generically equivalent product is available, even if the prescriber specifically
8.32 indicates "dispense as written-brand necessary" on the prescription as required by section
8.33 151.21, subdivision 2.

8.34 (f) Notwithstanding this subdivision, the commissioner may automatically require
8.35 prior authorization, for a period not to exceed 180 days, for any drug that is approved by
8.36 the United States Food and Drug Administration on or after July 1, 2005. The 180-day

9.1 period begins no later than the first day that a drug is available for shipment to pharmacies
9.2 within the state. The Formulary Committee shall recommend to the commissioner general
9.3 criteria to be used for the prior authorization of the drugs, but the committee is not
9.4 required to review each individual drug. In order to continue prior authorizations for a
9.5 drug after the 180-day period has expired, the commissioner must follow the provisions
9.6 of this subdivision.

9.7 **EFFECTIVE DATE.** This section is effective April 1, 2010.

9.9 subdivision to read:

9.10 **Subd. 13j. Antipsychotic and attention deficit disorder and attention deficit**
9.11 **hyperactivity disorder medications.** (a) The commissioner, in consultation with the
9.12 Drug Utilization Review Board established in subdivision 13i and actively practicing
9.13 pediatric mental health professionals, must:

9.14 (1) identify recommended pediatric dose ranges for atypical antipsychotic drugs
9.15 and drugs used for attention deficit disorder or attention deficit hyperactivity disorder
9.16 based on available medical, clinical, and safety data and research. The commissioner
9.17 shall periodically review the list of medications and pediatric dose ranges and update
9.18 the medications and doses listed as needed after consultation with the Drug Utilization
9.19 Review Board;

9.20 (2) identify situations where a collaborative psychiatric consultation and prior
9.21 authorization should be required before the initiation or continuation of drug therapy
9.22 in pediatric patients including, but not limited to, high-dose regimens, off-label use of
9.23 prescription medication, a patient's young age, and lack of coordination among multiple
9.24 prescribing providers; and

9.25 (3) track prescriptive practices and the use of psychotropic medications in children
9.26 with the goal of reducing the use of medication, where appropriate.

9.27 (b) Effective July 1, 2011, the commissioner shall require prior authorization and
9.28 a collaborative psychiatric consultation before an atypical antipsychotic and attention
9.29 deficit disorder and attention deficit hyperactivity disorder medication meeting the criteria
9.30 identified in paragraph (a), clause (2), is eligible for payment. A collaborative psychiatric
9.31 consultation must be completed before the identified medications are eligible for payment
9.32 unless:

9.33 (1) the patient has already been stabilized on the medication regimen; or

9.34 (2) the prescriber indicates that the child is in crisis.

10.1 If clause (1) or (2) applies, the collaborative psychiatric consultation must be completed
10.2 within 90 days for payment to continue.

10.3 (c) For purposes of this subdivision, a collaborative psychiatric consultation must
10.4 meet the criteria described in section 245.4862, subdivision 4.

10.6 **256B.0644 REIMBURSEMENT UNDER OTHER STATE HEALTH CARE**
10.7 **PROGRAMS.**

10.8 (a) A vendor of medical care, as defined in section 256B.02, subdivision 7, and a
10.9 health maintenance organization, as defined in chapter 62D, must participate as a provider
10.10 or contractor in the medical assistance program, ~~general assistance medical care program,~~
10.11 and MinnesotaCare as a condition of participating as a provider in health insurance plans
10.12 and programs or contractor for state employees established under section 43A.18, the
10.13 public employees insurance program under section 43A.316, for health insurance plans
10.14 offered to local statutory or home rule charter city, county, and school district employees,
10.15 the workers' compensation system under section 176.135, and insurance plans provided
10.16 through the Minnesota Comprehensive Health Association under sections 62E.01 to
10.17 62E.19. The limitations on insurance plans offered to local government employees shall
10.18 not be applicable in geographic areas where provider participation is limited by managed
10.19 care contracts with the Department of Human Services.

10.20 (b) For providers other than health maintenance organizations, participation in the
10.21 medical assistance program means that:

10.22 (1) the provider accepts new medical assistance, ~~general assistance medical care,~~
10.23 and MinnesotaCare patients;

10.24 (2) for providers other than dental service providers, at least 20 percent of the
10.25 provider's patients are covered by medical assistance, ~~general assistance medical care,~~
10.26 and MinnesotaCare as their primary source of coverage; or

10.27 (3) for dental service providers, at least ten percent of the provider's patients are
10.28 covered by medical assistance, ~~general assistance medical care,~~ and MinnesotaCare as
10.29 their primary source of coverage, or the provider accepts new medical assistance and
10.30 MinnesotaCare patients who are children with special health care needs. For purposes
10.31 of this section, "children with special health care needs" means children up to age 18
10.32 who: (i) require health and related services beyond that required by children generally;
10.33 and (ii) have or are at risk for a chronic physical, developmental, behavioral, or emotional
10.34 condition, including: bleeding and coagulation disorders; immunodeficiency disorders;
10.35 cancer; endocrinopathy; developmental disabilities; epilepsy, cerebral palsy, and other

11.1 neurological diseases; visual impairment or deafness; Down syndrome and other genetic

22.36 nurse practitioner, a certified adult nurse practitioner, a certified obstetric/gynecological

23.1 nurse practitioner, a certified neonatal nurse practitioner, or a certified geriatric nurse
23.2 practitioner in independent practice, if (1) the service is otherwise covered under this
23.3 chapter as a physician service, (2) the service provided on an inpatient basis is not included
23.4 as part of the cost for inpatient services included in the operating payment rate, and (3) the

23.18 service to an enrolled recipient who has a hearing loss and uses interpreting services.

23.19 (b) Sex reassignment surgery is not covered under this section.

23.20 (c) Drug coverage is covered in accordance with section 256D.03, subdivision 3,
23.21 paragraph (b).

23.22 (d) The following co-payments shall apply for services provided:

23.23 (1) \$25 for nonemergency visits to a hospital-based emergency room; and

23.24 (2) \$3 per brand-name drug prescription, subject to a \$7 per month maximum for
