A bill for an act 1.1 relating to taxation; property tax; exempting certain properties from referendum 12 market value; modifying the requirements for class 1c property; modifying 1.3 leased seasonal-recreation land; amending Minnesota Statutes 2012, sections 1.4 126C.01, subdivision 3; 272.0213; 273.13, subdivision 22. 1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.6 Section 1. Minnesota Statutes 2012, section 126C.01, subdivision 3, is amended to read: 1.7

- Subd. 3. Referendum market value. "Referendum market value" means the 18 market value of all taxable property, excluding property classified as class 1c, 2, 4c(4), or 1.9 4c(12) under section 273.13. The portion of class 2a property consisting of the house, 1.10 garage, and surrounding one acre of land of an agricultural homestead is included in 1 11 referendum market value. For the purposes of this subdivision, in the case of class 1a, 1.12 1b, or 2a property, "market value" means the value prior to the exclusion under section 1 13 273.13, subdivision 35. Any class of property, or any portion of a class of property, that is 1.14 included in the definition of referendum market value and that has a class rate of less than 1.15 one percent under section 273.13 shall have a referendum market value equal to its market 1.16 value times its class rate, multiplied by 100. 1.17 1.18

1.20 (a) A county board may elect, by resolution, to Qualified lands, as defined in this

2.15	case of a duplex or triplex in which one of the units is used for homestead purposes, the
2.16	entire property is deemed to be used for homestead purposes. The market value of class 1a
2.17	property must be determined based upon the value of the house, garage, and land.
2.18	The first \$500,000 of market value of class 1a property has a net class rate of
2.19	one percent of its market value; and the market value of class 1a property that exceeds
2.20	\$500,000 has a class rate of 1.25 percent of its market value.
2.21	(b) Class 1b property includes homestead real estate or homestead manufactured

- Permanently and totally disabled for the purpose of this subdivision means a
  condition which is permanent in nature and totally incapacitates the person from working
  at an occupation which brings the person an income. The first \$50,000 market value of
  class 1b property has a net class rate of .45 percent of its market value. The remaining
  market value of class 1b property has a class rate using the rates for class 1a or class 2a
  property, whichever is appropriate, of similar market value.
- (c) Class 1c property is commercial use real and personal property that abuts public 3.7 water as defined in section 103G.005, subdivision 15, or abuts a state trail administered by 38 the Department of Natural Resources, and is devoted to temporary and seasonal residential 3.9 occupancy for recreational purposes but not devoted to commercial purposes for more 3.10 than 250 days in the year preceding the year of assessment, and that includes a portion 3.11 used as a homestead by the owner, which includes a dwelling occupied as a homestead 3.12 by a shareholder of a corporation that owns the resort, a partner in a partnership that 3.13 owns the resort, or a member of a limited liability company that owns the resort even 3.14 if, whether the title to the homestead is held by the corporation, partnership, or limited 3.15 liability company, or by a shareholder of a corporation who owns the resort, a partner in a 3.16 partnership who owns the resort, or a member of a limited liability company who owns 3.17 the resort. For purposes of this paragraph, property is devoted to a commercial purpose 3.18 on a specific day if any portion of the property, excluding the portion used exclusively 3.19 as a homestead, is used for residential occupancy and a fee is charged for residential 3.20 occupancy. Class 1c property must contain three or more rental units. A "rental unit" is 3.21 defined as a cabin, condominium, townhouse, sleeping room, or individual camping site 3.22 3.23 equipped with water and electrical hookups for recreational vehicles. Class 1c property must provide recreational activities such as the rental of ice fishing houses, boats and 3.24 motors, snowmobiles, downhill or cross-country ski equipment; provide marina services, 3.25 launch services, or guide services; or sell bait and fishing tackle. Any unit in which the 3.26 right to use the property is transferred to an individual or entity by deeded interest, or the 3.27 sale of shares or stock, no longer qualifies for class 1c even though it may remain available 3.28 for rent. A camping pad offered for rent by a property that otherwise qualifies for class 1c 3.29 is also class 1c, regardless of the term of the rental agreement, as long as the use of the 3.30 camping pad does not exceed 250 days. If the same owner owns two separate parcels that 3.31 are located in the same township, and one of those properties is classified as a class 1c 3.32 property and the other would be eligible to be classified as a class 1c property if it was 3.33 used as the homestead of the owner, both properties will be assessed as a single class 1c 3.34 property; for purposes of this sentence, properties are deemed to be owned by the same 3.35 owner if each of them is owned by a limited liability company, and both limited liability 3.36

companies have the same membership. The portion of the property used as a homestead 4.1 is class 1a property under paragraph (a). The remainder of the property is classified as 4.2 follows: the first \$600,000 of market value is tier I, the next \$1,700,000 of market value is 4.3 tier II, and any remaining market value is tier III. The class rates for class 1c are: tier I, 4.4 0.50 percent; tier II, 1.0 percent; and tier III, 1.25 percent. Owners of real and personal 4.5 property devoted to temporary and seasonal residential occupancy for recreation purposes 4.6 in which all or a portion of the property was devoted to commercial purposes for not more 4.7 than 250 days in the year preceding the year of assessment desiring classification as class 4.8 1c, must submit a declaration to the assessor designating the cabins or units occupied 4.9 for 250 days or less in the year preceding the year of assessment by January 15 of the 4.10 assessment year. Those cabins or units and a proportionate share of the land on which they 4.11 are located must be designated as class 1c as otherwise provided. The remainder of the 4.12 cabins or units and a proportionate share of the land on which they are located must be 4.13 designated as class 3a commercial. The owner of property desiring designation as class 4.14 1c property must provide guest registers or other records demonstrating that the units for 4.15 which class 1c designation is sought were not occupied for more than 250 days in the 4.16 year preceding the assessment if so requested. The portion of a property operated as a 4.17 (1) restaurant, (2) bar, (3) gift shop, (4) conference center or meeting room, and (5) other 4.18 nonresidential facility operated on a commercial basis not directly related to temporary 4.19 and seasonal residential occupancy for recreation purposes does not qualify for class 1c. 4.20 (d) Class 1d property includes structures that meet all of the following criteria: 4.21

- 4.22 (1) the structure is located on property that is classified as agricultural property under
  4.23 section 273.13, subdivision 23;
- 4.24 (2) the structure is occupied exclusively by seasonal farm workers during the time
  4.25 when they work on that farm, and the occupants are not charged rent for the privilege of
  4.26 occupying the property, provided that use of the structure for storage of farm equipment
  4.27 and produce does not disqualify the property from classification under this paragraph;
- 4.28 (3) the structure meets all applicable health and safety requirements for the4.29 appropriate season; and
- 4.30 (4) the structure is not salable as residential property because it does not comply4.31 with local ordinances relating to location in relation to streets or roads.
- 4.32 The market value of class 1d property has the same class rates as class 1a property4.33 under paragraph (a).
- 4.34 EFFECTIVE DATE. This section is effective for taxes payable in 2014 and
  4.35 thereafter.
