1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2020, section 60A.71, subdivision 7, is amended to read:

1.12 Subd. 7. **Duration; fees.** (a) Each applicant for a reinsurance intermediary license shall

1.13 pay to the commissioner a fee of \$200 for an initial two-year license and a fee of \$150 for

1.14 each renewal. Applications shall be submitted on forms prescribed by the commissioner.

1.15 (b) Initial licenses issued under this chapter are valid for a period not to exceed 24 months

1.16 and expire on October 31 of the renewal year assigned by the commissioner. Each renewal

1.17 reinsurance intermediary license is valid for a period of 24 months. ~~Licensees who submit~~

1.18 ~~renewal applications postmarked or delivered on or before October 15 of the renewal year~~

1.19 ~~may continue to transact business whether or not the renewal license has been received by~~

1.20 ~~November 1. Licensees who submit applications postmarked or delivered after October 15~~

1.21 ~~of the renewal year must not transact business after the expiration date of the license until~~

2.2 Subd. 10. **Duties of commissioner; report.** ~~The commissioner shall issue a report by~~
 2.3 ~~March 1 of each year, comparing the average rates charged by workers' compensation~~
 2.4 ~~insurers in the state to the pure premium base rates filed by the association, as reviewed by~~
 2.5 ~~the Rate Oversight Commission. The Rate Oversight Commission shall review the~~

 2.25 amount based on the transactions conducted with Minnesota consumers (purchases from
 2.26 and sales to consumers at retail) during the 12-month period prior to registration, or renewal,
 2.27 whichever is applicable.

 4.19 fraudulent, deceptive, or dishonest practices:

4.20 (1) act on behalf of more than one party to a transaction without the knowledge and
 4.21 consent of all parties;

4.22 (2) act in the dual capacity of licensee and undisclosed principal in any transaction;

4.23 (3) receive funds while acting as principal which funds would constitute trust funds if
 4.24 received by a licensee acting as an agent, unless the funds are placed in a trust account.

5.3 (7) represent membership in any real estate-related organization in which the licensee

5.5 (8) advertise in any manner that is misleading or inaccurate with respect to properties,
5.6 terms, values, policies, or services conducted by the licensee;

5.7 (9) make any material misrepresentation or permit or allow another to make any material
5.8 misrepresentation;

5.9 (10) make any false or misleading statements, or permit or allow another to make any
5.10 false or misleading statements, of a character likely to influence, persuade, or induce the
5.11 consummation of a transaction contemplated by this chapter;

5.12 (11) fail within a reasonable time to account for or remit any money coming into the
5.13 licensee's possession which belongs to another;

5.14 (12) commingle with ~~his or her~~ the individual's own money or property trust funds or
5.15 any other money or property of another held by the licensee;

5.16 (13) a demand from a seller for a commission ~~to~~ or compensation to which the licensee
5.17 is not entitled, knowing that ~~he or she~~ the individual is not entitled to the commission or
5.18 compensation;

5.19 (14) pay or give money or goods of value to an unlicensed person for any assistance or
5.20 information relating to the procurement by a licensee of a listing of a property or of a
5.21 prospective buyer of a property (this item does not apply to money or goods paid or given
5.22 to the parties to the transaction);

5.23 (15) fail to maintain a trust account at all times, as provided by law;

5.24 (16) engage, with respect to the offer, sale, or rental of real estate, in an anticompetitive
5.25 activity;

5.26 (17) represent on advertisements, cards, signs, circulars, letterheads, or in any other
5.27 manner, that ~~he or she~~ the individual is engaged in the business of financial planning unless
5.28 ~~he or she~~ the individual provides a disclosure document to the client. The document must
5.29 be signed by the client and a copy must be left with the client. The disclosure document
5.30 must contain the following:

6.1 (i) the basis of fees, commissions, or other compensation received by ~~him or her~~ an
6.2 individual in connection with rendering of financial planning services or financial counseling
6.3 or advice in the following language:

6.4 "My compensation may be based on the following:

6.13 The products will be traded, distributed, or placed through the clearing/trading firm(s)

6.16 (iii) the license(s) held by the person under this chapter or chapter 60A or 80A in the
6.17 following language:

6.18 "I am licensed in Minnesota as a(n):

6.19 (a) ... insurance agent;

6.20 (b) ... securities agent or broker/dealer;

6.21 (c) ... real estate broker or salesperson;

6.22 (d) ... investment adviser"; and

6.23 (iv) the specific identity of any financial products or services, by category, for example
6.24 mutual funds, stocks, or limited partnerships, the person is authorized to offer or sell in the
6.25 following language:

6.26 "The license(s) entitles me to offer and sell the following products and/or services:

6.27 (a) ... securities, specifically the following: [List];

6.28 (b) ... real property;

7.2 (b) **Determining violation.** A licensee shall be deemed to have violated this section if
7.3 the licensee has been found to have violated sections 325D.49 to 325D.66, by a final decision
7.4 or order of a court of competent jurisdiction.

7.5 (c) **Commissioner's authority.** Nothing in this section limits the authority of the
7.6 commissioner to take actions against a licensee for fraudulent, deceptive, or dishonest
7.7 practices not specifically described in this section.

7.8 Sec. 9. Minnesota Statutes 2020, section 82B.021, subdivision 18, is amended to read:

7.9 Subd. 18. **Licensed real property appraiser.** "Licensed real property appraiser" means
7.10 an individual licensed under this chapter to perform appraisals on noncomplex one-family
7.11 to four-family residential units or agricultural property having a transactional value of less
7.12 than \$1,000,000 and complex one-family to four-family residential units or agricultural
7.13 property having a transactional value of less than ~~\$250,000~~ \$400,000.

7.14 Sec. 10. Minnesota Statutes 2020, section 82B.11, subdivision 3, is amended to read:

7.15 Subd. 3. **Licensed residential real property appraiser.** A licensed residential real
7.16 property appraiser may appraise noncomplex residential property or agricultural property
7.17 having a transaction value less than \$1,000,000 and complex residential or agricultural
7.18 property having a transaction value less than ~~\$250,000~~ \$400,000.

7.19 Sec. 11. Minnesota Statutes 2020, section 332.33, subdivision 3, is amended to read:

7.20 Subd. 3. **Term and fees.** Licenses issued or renewed and registrations received by the
7.21 commissioner of commerce under sections 332.31 to 332.44 shall expire on June 30. Each
7.22 collection agency license shall plainly state the name and business address of the licensee,
7.23 and shall be posted in a conspicuous place in the office where the business is transacted.
7.24 The fee for each collection agency license is \$500, and renewal is \$400. The fee for each
7.25 collector registration and renewal is \$10, which entitles the individual collector to work at
7.26 a licensee's business location or in another location as provided under subdivision 5b. An
7.27 additional branch license is not required for a location used under subdivision 5b. A collection
7.28 agency licensee who desires to carry on business in more than one place shall procure a
7.29 license for each place where the business is to be conducted.

8.3 Subd. 5b. **Work from home.** An employee of a licensed collection agency may work
8.4 from a location other than the licensee's business location if the licensee and employee
8.5 comply with all requirements under this section that would apply if the employee were
8.6 working at the business location.

8.7 Sec. 13. **[332.61] INFORMATIVE DISCLOSURE.**

8.8 A lead generator must prominently make the following disclosure on all print, electronic,
8.9 and nonprint solicitations, including advertising on websites, radio, or television: "This
8.10 company does not actually provide any of the credit services you are seeking. We ONLY
8.11 refer you to companies that want to provide some or all of those services."

8.12 Sec. 14. Minnesota Statutes 2020, section 386.375, subdivision 3, is amended to read:

8.13 Subd. 3. **Consumer education information.** (a) A person other than the mortgagor or
8.14 fee owner who transfers or offers to transfer an abstract of title shall present to the mortgagor
8.15 or fee owner basic information in plain English about abstracts of title. This information
8.16 must be sent in a form prepared and approved by the commissioner of commerce and must
8.17 contain at least the following items:

8.18 (1) a definition and description of abstracts of title;

8.19 (2) an explanation that holders of abstracts of title must maintain it with reasonable care;

8.20 (3) an approximate cost or range of costs to replace a lost or damaged abstract of title;

45.017 MEDICAL MALPRACTICE INSURANCE REPORT.

(a) The commissioner of commerce shall provide to the legislature annually a brief written report on the status of the market for medical malpractice insurance in Minnesota. The report must summarize, interpret, explain, and analyze information on that subject available to the commissioner, through annual statements filed by insurance companies, information obtained under paragraph (c), and other sources.

(b) The annual report must consider, to the extent possible, using definitions developed by the commissioner, Minnesota-specific data on market shares; premiums received; amounts paid to settle claims that were not litigated, claims that were settled after litigation began, and claims that were litigated to court judgment; amounts spent on processing, investigation, litigation, and otherwise handling claims; other sales and administrative costs; and the loss ratios of the insurers.

(c) Each insurance company that provides medical malpractice insurance in this state shall, no later than June 1 each year, file with the commissioner of commerce, on a form prescribed by the commissioner and using definitions developed by the commissioner, the Minnesota-specific data referenced in paragraph (b), other than market share, for the previous calendar year for that insurance company, shown separately for various categories of coverages including, if possible, hospitals, medical clinics, nursing homes, physicians who provide emergency medical care, obstetrician gynecologists, and ambulance services. An insurance company need not comply with this paragraph if its direct premium written in the state for the previous calendar year is less than \$2,000,000.
