- person convicted of a misdemeanor, a gross misdemeanor, a nonfelony violation of chapter 2.5
- 152, or a felony that is not a violent crime under section 609.1095. 2.6
- (b) After notice to the requesting school district and contract provider of school bus transportation, the commissioner may waive the permanent cancellation requirement after ten years have elapsed since the person was convicted of a violation of section 609.582, 2.10 subdivision 2, 3, or 4.
