Section 1. Minnesota Statutes 2010, section 273.111, subdivision 4, is amended to read: 1.6 Subd. 4. Determination of value. (a) The value of any real estate described 1.7 in subdivision 3 shall upon timely application by the owner, in the manner provided 1.8 in subdivision 8, be determined solely with reference to its appropriate agricultural 1.9 classification and value notwithstanding sections 272.03, subdivision 8, and 273.11. 1.10 Furthermore, the assessor shall not consider any added values resulting from 1 11 nonagricultural factors. In order to account for the presence of nonagricultural influences 1.12 that may affect the value of agricultural land, the commissioner of revenue shall, in 1.13 consultation with the Department of Applied Economics at the University of Minnesota, 1.14 develop a fair and uniform method of determining the average value of agricultural 1.15 land for each county in the state consistent with this subdivision. The values must be 1 16 determined using appropriate sales data. When appropriate, the commissioner may 1 17 make reasonable adjustments to the values based on the most recent available county or 1.18 regional data for agricultural production, commodity prices, production expenses, rent, 1 19 and investment return. The commissioner shall annually assign the resulting countywide 1.20 1.21 average value to each county, and these values shall be used as the basis for determining the agricultural value for all properties in the county qualifying for tax deferment under 1.22 this section.
