1.14 **ARTICLE 1**

1.15 **PARENTING TIME**

1.16 Section 1. Minnesota Statutes 2022, section 257.025, is amended to read:

1.17 **257.025 CUSTODY AND PARENTING TIME DISPUTES.**

1.18 (a) In any custody or parenting time proceeding involving unmarried parents, the court

1.19 shall consider section 518.175 and evaluate all relevant factors in section 518.17, subdivision

1.20 1, to determine the best interests of the child.

1.21 (b) The fact that the parents of the child are not or were never married to each other shall

1.22 not be determinative of the custody and parenting time of the child.

1.23 (c) A person may seek custody of a child by filing a petition or motion pursuant to section

1.24 518.156.

1.25 (d) Section 518.619 applies to this section.

2.1 Sec. 2. [518.0011] PUBLIC POLICY STATEMENT.

2.2 The public policy of this state is to:

2.3 (1) ensure that each child has frequent and substantial contact with the child's parents,  
2.4 as long as the child's parents have shown the ability to act in the best interests of the child;

2.5 (2) ensure that parents and caregivers provide a safe and nurturing environment for each  
2.6 child; and

2.7 (3) encourage parents to share the rights and duties of raising their child.

2.8 Sec. 3. Minnesota Statutes 2022, section 518.131, subdivision 1, is amended to read:

2.9 Subdivision 1. **Permissible orders.** In a proceeding brought for custody, dissolution,  
2.10 or legal separation, or for disposition of property, maintenance, or child support following  
2.11 the dissolution of a marriage, either party may, by motion, request from the court and the  
2.12 court may grant a temporary order pending the final disposition of the proceeding to or for:

2.13 (a) Temporary custody and parenting time regarding the minor children of the parties.  
2.14 In addition to the requirements under section 518.17, subdivision 1, the court must consider  
2.15 the child's parenting time with each parent before the pending action commenced. If the  
2.16 child's access to a parent was limited or restricted before the action commenced, the court  
2.17 must determine the child's custody and parenting time in a manner that supports the child's  
2.18 opportunity to develop a relationship with both parents in accordance with sections 518.17  
2.19 and 518.175;

2.20 (b) Temporary maintenance of either spouse;

2.21 (c) Temporary child support for the children of the parties;

2.22 (d) Temporary costs and reasonable attorney fees;

2.23 (e) Award the temporary use and possession, exclusive or otherwise, of the family home,  
2.24 furniture, household goods, automobiles, and other property of the parties;

2.25 (f) Restrain one or both parties from transferring, encumbering, concealing, or disposing  
2.26 of property except in the usual course of business or for the necessities of life, and to account  
2.27 to the court for all such transfers, encumbrances, dispositions, and expenditures made after  
2.28 the order is served or communicated to the party restrained in open court;

2.29 (g) Restrain one or both parties from harassing, vilifying, mistreating, molesting,  
2.30 disturbing the peace, or restraining the liberty of the other party or the children of the parties;

3.1 (h) Restrain one or both parties from removing any minor child of the parties from the  
3.2 jurisdiction of the court;

3.3 (i) Exclude a party from the family home of the parties or from the home of the other  
3.4 party; and

3.5 (j) Require one or both of the parties to perform or to not perform such additional acts  
3.6 as will facilitate the just and speedy disposition of the proceeding, or will protect the parties  
3.7 or their children from physical or emotional harm.

3.9 Subd. 11. ~~Temporary support and maintenance~~ Cases given priority for temporary  
3.10 relief. ~~Temporary support and maintenance may be ordered during the time a parenting~~  
3.11 ~~plan is being developed under section 518.1705.~~ (a) While the proceeding is pending, the  
3.12 court must give priority to scheduling and holding an expedited hearing for temporary relief  
3.13 when a party credibly alleges that:

3.14 (1) the party has been denied parenting time with a child for 14 consecutive days or  
3.15 more; or

3.16 (2) the party has been unreasonably denied access to necessary financial resources or  
3.17 support during a pending marital dissolution.

3.18 (b) A court must hold a priority hearing under this subdivision within 30 days of the  
3.19 party's request.

3.20 (c) A court must consider credible allegations of domestic abuse, substance abuse,  
3.21 maltreatment findings, or neglect as a reasonable basis for a party who has denied parenting  
3.22 time to the other party.

3.23 (d) If temporary parenting time is ordered, the court may also order temporary child  
3.24 support if requested by the other party.

3.26 **518.14 COSTS AND DISBURSEMENTS; ATTORNEY FEES; COLLECTION**  
3.27 **COSTS.**

3.28 Subdivision 1. **General.** Except as provided in section 518A.735, in a proceeding under  
3.29 this chapter or chapter 518A, the court shall award attorney fees, costs, and disbursements  
3.30 in an amount necessary to enable a party to carry on or contest the proceeding, provided it  
3.31 finds:

4.1 (1) that the fees are necessary for the good faith assertion of the party's rights in the  
 4.2 proceeding and will not contribute unnecessarily to the length and expense of the proceeding;

4.3 (2) that the party from whom fees, costs, and disbursements are sought has the means  
 4.4 to pay them; and

4.5 (3) that the party to whom fees, costs, and disbursements are awarded does not have the  
 4.6 means to pay them.

4.7 Subd. 1a. **Other award.** Nothing in this section or section 518A.735 precludes The  
 4.8 court from awarding may award, in its discretion, additional fees, costs, and disbursements  
 4.9 against a party who unreasonably contributes to the length or expense of the proceeding or  
 4.10 whose unreasonable failure to comply with an order or decree causes the other party to seek  
 4.11 enforcement or other relief, including the reimbursement of fees and costs incurred before  
 4.12 filing a motion. In determining whether to award fees, the court must consider the  
 4.13 circumstances and any other factors that contributed to the length or expense of the  
 4.14 proceeding. Fees, costs, and disbursements provided for in this section and section 518A.735  
 4.15 may be awarded at any point in the proceeding, including a modification proceeding under  
 4.16 sections 518.18 and 518A.39. The court may adjudge costs and disbursements against either  
 4.17 party. The court may authorize the collection of money awarded by execution, or out of  
 4.18 property sequestered, or in any other manner within the power of the court. An award of  
 4.19 attorney's fees made by the court during the pendency of the proceeding or in the final  
 4.20 judgment survives the proceeding and if not paid by the party directed to pay the same may  
 4.21 be enforced as above provided or by a separate civil action brought in the attorney's own  
 4.22 name. If the proceeding is dismissed or abandoned prior to determination and award of  
 4.23 attorney's fees, the court may nevertheless award attorney's fees upon the attorney's motion.  
 4.24 The award shall also survive the proceeding and may be enforced in the same manner as  
 4.25 last above provided.

4.27 Subdivision 1. **Best interests of the child.** (a) In evaluating the best interests of the child  
 4.28 for purposes of determining issues of custody and parenting time, the court must consider  
 4.29 and evaluate all relevant factors, including:

4.30 (1) a child's physical, emotional, cultural, spiritual, and other needs, and the effect of  
 4.31 the proposed arrangements on the child's needs and development;

5.1 (2) any special medical, mental health, developmental disability, or educational needs  
5.2 that the child may have that may require special parenting arrangements or access to  
5.3 recommended services;

5.4 (3) the reasonable preference of the child, if the court deems the child to be of sufficient  
5.5 ability, age, and maturity to express an independent, reliable preference;

5.6 (4) whether domestic abuse, as defined in section 518B.01, has occurred in the parents'  
5.7 or either parent's household or relationship; the nature and context of the domestic abuse;  
5.8 and the implications of the domestic abuse for parenting and for the child's safety, well-being,  
5.9 and developmental needs;

5.10 (5) any physical, mental, or chemical health issue of a parent that affects the child's  
5.11 safety or developmental needs;

5.12 (6) the history and nature of each parent's participation in providing care for the child;

5.13 (7) the willingness and ability of each parent to provide ongoing care for the child; to  
5.14 meet the child's ongoing developmental, emotional, spiritual, and cultural needs; and to  
5.15 maintain consistency and follow through with parenting time;

5.16 (8) the effect on the child's well-being and development of changes to home, school,  
5.17 and community;

5.18 (9) the effect of the proposed arrangements on the ongoing relationships between the  
5.19 child and each parent, siblings, and other significant persons in the child's life;

5.20 (10) the benefit to the child in maximizing parenting time with both parents and the  
5.21 detriment to the child in limiting parenting time with either parent;

5.22 (11) except in cases in which domestic abuse as described in clause (4) has occurred,  
5.23 the disposition of each parent to support the child's relationship with the other parent and  
5.24 to encourage and permit frequent and continuing contact between the child and the other  
5.25 parent; and

5.26 (12) the willingness and ability of parents to cooperate in the rearing of their child; to  
5.27 maximize sharing information and minimize exposure of the child to parental conflict; and  
5.28 to utilize methods for resolving disputes regarding any major decision concerning the life  
5.29 of the child.

5.30 (b) Clauses (1) to (9) govern the application of the best interests of the child factors by  
5.31 the court:

6.1 (1) The court must make detailed findings on each of the factors in paragraph (a) based  
6.2 on the evidence presented and explain how each factor led to its conclusions and to the  
6.3 determination of custody and parenting time. The court may not use one factor to the  
6.4 exclusion of all others, and the court shall consider that the factors may be interrelated.

6.5 (2) The court shall consider that it is in the best interests of the child to promote the  
6.6 child's healthy growth and development through safe, stable, nurturing relationships between  
6.7 a child and both parents. In determining custody, the court must consider the best interests  
6.8 of the child and must not prefer one parent over the other solely on the basis of the gender  
6.9 of the parent.

6.10 (3) The court shall consider both parents as having the capacity to develop and sustain  
6.11 nurturing relationships with their children unless there are substantial reasons to believe  
6.12 otherwise. In assessing whether parents are capable of sustaining nurturing relationships  
6.13 with their children, the court shall recognize that there are many ways that parents can  
6.14 respond to a child's needs with sensitivity and provide the child love and guidance, and  
6.15 these may differ between parents and among cultures.

6.16 (4) The court shall not consider conduct of a party that does not affect the party's  
6.17 relationship with the child.

6.18 (5) Disability alone, as defined in section 363A.03, of a proposed custodian or the child  
6.19 shall not be determinative of the custody of the child.

6.20 (6) The court shall consider evidence of a violation of section 609.507 in determining  
6.21 the best interests of the child.

6.22 (7) There is no presumption for or against joint physical custody, except as provided in  
6.23 clause (9).

6.24 (8) Joint physical custody does not require an absolutely equal division of time.

6.25 (9) The court shall use a rebuttable presumption that upon request of either or both  
6.26 parties, joint legal custody is in the best interests of the child. However, the court shall use  
6.27 a rebuttable presumption that joint legal custody or joint physical custody is not in the best  
6.28 interests of the child if domestic abuse, as defined in section 518B.01, has occurred between  
6.29 the parents. In determining whether the presumption is rebutted, the court shall consider  
6.30 the nature and context of the domestic abuse and the implications of the domestic abuse for  
6.31 parenting and for the child's safety, well-being, and developmental needs. Disagreement  
6.32 alone over whether to grant sole or joint custody does not constitute an inability of parents  
6.33 to cooperate in the rearing of their children as referenced in paragraph (a), clause (12).

7.1 (c) In a proceeding involving the custodial responsibility of a service member's child, a  
7.2 court may not consider only a parent's past deployment or possible future deployment in  
7.3 determining the best interests of the child. For purposes of this paragraph, "custodial  
7.4 responsibility" has the meaning given in section 518E.102, paragraph (f).

7.5 Sec. 7. Minnesota Statutes 2022, section 518.17, subdivision 3, is amended to read:

7.6 Subd. 3. **Custody order.** (a) Upon adjudging the nullity of a marriage, or in a dissolution  
7.7 or separation proceeding, or in a child custody proceeding, the court shall make such further  
7.8 order as it deems just and proper concerning:

7.9 (1) the legal custody of the minor children of the parties ~~which~~ that shall be sole or joint;

7.10 (2) their physical custody, parenting time, and residence; and

7.11 (3) their support. ~~In determining custody, the court shall consider the best interests of~~  
7.12 ~~each child and shall not prefer one parent over the other solely on the basis of the sex of the~~  
7.13 ~~parent.~~

7.14 (b) The court shall grant the rights listed in subdivision 3a to each of the parties, regardless  
7.15 of custodial designation, unless specific findings are made under section 518.68, subdivision  
7.16 1. The court shall include in the custody order the notice under subdivision 3a.

7.17 (c) The court may waive any of the rights under this section if it finds it is necessary to  
7.18 protect the welfare of a party or child.

7.19 (d) If a court order or law prohibits contact by a party, the notifications and information  
7.20 required to be sent under subdivision 3a, clauses (1), (2), (3), (5), and (6), shall not be made  
7.21 by direct communication of the parties. Third-party communication shall be limited to the  
7.22 specific purposes delineated in this subdivision or subdivision 3a. Nothing in this subdivision  
7.23 or subdivision 3a shall modify, suspend, revoke, or terminate a court order or law that  
7.24 prohibits contact by a party.

7.25 (e) If one of the parties is a program participant under chapter 5B, the other party shall  
7.26 send all information and notifications required under subdivision 3a, clauses (1), (2), (3),  
7.27 (5), and (6), to the participant's designated address. The program participant is exempted  
7.28 from the requirements of subdivision 3a.

7.29 (f) Failure to notify or inform a party of rights under subdivision 3a does not form a  
7.30 basis for modification under section 518.18, paragraph (d), clause (iv), unless other grounds  
7.31 are alleged which would support a modification.

8.1 Sec. 8. Minnesota Statutes 2022, section 518.175, subdivision 1, is amended to read:

8.2 Subdivision 1. **General.** (a) In all proceedings for dissolution or legal separation,  
8.3 subsequent to the commencement of the proceeding and continuing thereafter during the  
8.4 minority of the child, the court shall, upon the request of either parent, grant such parenting  
8.5 time on behalf of the child and a parent as will enable the child and the parent to maintain  
8.6 a child to parent relationship that will be in the best interests of the child. The court, when  
8.7 issuing a parenting time order, may reserve a determination as to the future establishment  
8.8 or expansion of a parent's parenting time. In that event, the best interest standard set forth  
8.9 in subdivision 5, paragraph (a), shall be applied to a subsequent motion to establish or  
8.10 expand parenting time.

8.11 (b) If the court finds, after a hearing, that parenting time with a parent is likely to endanger  
8.12 the child's physical, mental, or emotional health or safety or impair the child's emotional  
8.13 development, the court shall restrict parenting time with that parent as to time, place, duration,  
8.14 or supervision and may deny parenting time entirely, as the circumstances warrant. The  
8.15 court shall consider the age of the child and the child's relationship with the parent prior to  
8.16 the commencement of the proceeding.

8.17 (c) A parent's failure to pay support because of the parent's inability to do so shall not  
8.18 be sufficient cause for denial of parenting time.

8.19 (d) The court may provide that a law enforcement officer or other appropriate person  
8.20 will accompany a party seeking to enforce or comply with parenting time.

8.21 (e) Upon request of either party, to the extent practicable an order for parenting time  
8.22 must include a specific schedule for regular parenting time, including the frequency and  
8.23 duration of ~~visitation~~ parenting time and ~~visitation~~ parenting time during holidays ~~and~~,  
8.24 vacations, and school breaks unless parenting time is restricted, denied, or reserved.

8.25 (f) The court administrator shall provide a form for a pro se motion regarding parenting  
8.26 time disputes, which includes provisions for indicating the relief requested, an affidavit in  
8.27 which the party may state the facts of the dispute, and a brief description of the parenting  
8.28 time expeditor process under section 518.1751. The form may not include a request for a  
8.29 change of custody. The court shall provide instructions on serving and filing the motion.

8.30 (g) In the absence of other evidence, there is a rebuttable presumption that a ~~parent is~~  
8.31 ~~entitled to~~ child must receive a minimum of at least 25 percent of the parenting time ~~for the~~  
8.32 ~~child~~ with each parent. For purposes of this paragraph, the percentage of parenting time  
8.33 may be determined by calculating the number of overnights that a child spends with a parent  
8.34 or by using a method other than overnights if the parent has significant time periods on

 9.2 The court may consider the age of the child in determining whether a child is with a parent  
 9.3 for a significant period of time.

9.5 Subd. 6. **Remedies.** (a) Each party must follow a court's order for custody and parenting  
 9.6 time unless the parties have made another agreement in writing as defined by section 645.44,  
 9.7 subdivision 14.

9.8 (b) For the purposes of this subdivision, "court-ordered parenting time" means:

9.9 (1) parenting time that a court has ordered, regardless of whether the order is temporary  
 9.10 or permanent and whether family court or juvenile court has issued the order;

9.11 (2) an order by a parenting time consultant, parenting coordinator, special master, or  
 9.12 other court-appointed individual who is authorized to establish or modify parenting time;  
 9.13 or

9.14 (3) a binding agreement or decision under section 518.1751, subdivision 3.

9.15 ~~(a)~~ (c) ~~The court may provide~~ shall fully consider providing compensatory parenting  
 9.16 time when a parent has intentionally made a substantial amount of court-ordered parenting

25.24 **Section 1. [257E.10] DEFINITIONS.**

25.25 **Subdivision 1. Definitions.** For purposes of this chapter, the following terms have the

25.27 **Subd. 2. Assisted reproduction.** "Assisted reproduction" means a method of causing  
 25.28 pregnancy other than sexual intercourse. The term includes:

25.29 (1) intrauterine, intracervical, or vaginal insemination;

25.30 (2) donation of gametes;

25.31 (3) donation of embryos;

26.1 (4) in vitro fertilization and transfer of embryos; and

26.2 (5) intracytoplasmic sperm injection.

26.3 Assisted reproduction does not include the use of a surrogate or a surrogacy agreement.

26.4 Subd. 3. **Birth.** "Birth" includes fetal deaths reportable under section 144.222.

26.5 Subd. 4. **Determination of parentage.** "Determination of parentage" means establishment  
26.6 of a parent-child relationship by a judicial proceeding or signing of a valid recognition of  
26.7 parentage under section 257.75.

26.8 Subd. 5. **Donor.** "Donor" means an individual who provides gametes intended for use  
26.9 in assisted reproduction, whether or not for consideration. The term does not include a parent  
26.10 or intended parent.

26.11 Subd. 6. **Gamete.** "Gamete" means a sperm or egg.

26.12 Subd. 7. **Genetic testing.** "Genetic testing" means an analysis of genetic markers to  
26.13 identify or exclude a genetic relationship.

26.14 Subd. 8. **Intended parent.** "Intended parent" means an individual, married or unmarried,  
26.15 who manifests an intent to be legally bound as a parent of a child conceived by assisted  
26.16 reproduction.

26.17 Subd. 9. **Parent.** "Parent" means an individual who is the legal parent of a child under  
26.18 the laws of the state.

26.19 Subd. 10. **Parentage; parent-child relationship.** "Parentage" or "parent-child  
26.20 relationship" means the legal relationship between a child and a parent of the child.

26.21 Subd. 11. **Presumed parent.** "Presumed parent" means an individual who under sections  
26.22 257.51 to 257.74 is presumed to be a parent of a child, unless the requirements of section  
26.23 257.57, subdivision 2, are met; the presumption is overcome in a judicial proceeding; a  
26.24 valid denial of parentage is made under this chapter; or a court adjudicates the individual  
26.25 to be a parent.

26.26 Subd. 12. **Transfer.** "Transfer" means a procedure for assisted reproduction by which  
26.27 an embryo or sperm is placed in the body of the individual who will give birth to the child.

26.28 Sec. 2. **[257E.15] ORDERS OF PARENTAGE.**

26.29 (a) If the court determines that an individual is a parent under this chapter, either because  
26.30 the individual gave birth to the child or the individual is a consenting intended parent under  
26.31 section 257E.23, the court shall adjudicate the individual to be a parent of the child.

27.1 (b) An individual who is or claims to be a parent under this section or the individual  
27.2 who gave birth to the child may commence a proceeding before or after the birth of the  
27.3 child in district court for an order or judgment:

27.4 (1) declaring that each intended parent is a parent of the child and ordering that parental

27.17 A donor is not a parent of a child conceived by assisted reproduction.

27.18 Sec. 4. **[257E.22] PARENTAGE OF CHILD OF ASSISTED REPRODUCTION.**

27.19 An intended parent who consents under section 257E.23 to assisted reproduction by  
27.20 another individual with the intent to be a parent of a child conceived by assisted reproduction  
27.21 is a parent of the child.

27.22 Sec. 5. **[257E.23] CONSENT TO ASSISTED REPRODUCTION.**

27.23 (a) Except as otherwise provided in paragraph (b), the consent described in section  
27.24 257E.22 must be in a record signed by the individual giving birth to a child conceived by  
27.25 assisted reproduction and an intended parent.

27.26 (b) Failure to consent in a record as required by paragraph (a), before, on, or after the  
27.27 birth of the child, does not preclude the court from finding consent to parentage if:

27.28 (1) the individual giving birth to a child or the intended parent proves by clear and  
27.29 convincing evidence the existence of an express agreement entered into before conception

28.1 that the intended parent and the individual giving birth to the child intended they both would  
 28.2 be parents of the child; or

28.3 (2) the individual giving birth to a child and the intended parent for the first two years

 28.15 child's birth, is the spouse of the parent who gave birth to the child by assisted reproduction  
 28.16 may not challenge the individual's parentage of the child unless:

29.2 to the individual giving birth to the child, a former spouse of the individual giving birth to

29.11 to a child conceived by assisted reproduction and to any clinic or health care provider  
29.12 facilitating the assisted reproduction. Failure to give notice to the clinic or health care  
29.13 provider does not affect a determination of parentage under this chapter.

29.14 (b) An individual who withdraws consent under paragraph (a) is not a parent of the child  
29.15 under this chapter.

29.16 **Sec. 9. [257E.27] PARENTAL STATUS OF DECEASED INDIVIDUAL.**

29.17 (a) If an individual who intends to be a parent of a child conceived by assisted  
29.18 reproduction dies during the period between the transfer of a gamete or embryo and the  
29.19 birth of the child, the individual's death does not preclude the establishment of the individual's  
29.20 parentage of the child if the individual otherwise would be a parent of the child under this  
29.21 chapter.

29.22 (b) If an individual who consented in a record to assisted reproduction by an individual  
29.23 who agreed to give birth to a child dies before a transfer of gametes or embryos, the deceased  
29.24 individual is a parent of a child conceived by the assisted reproduction only if:

29.26 (i) the individual consented in a record that if assisted reproduction were to occur after  
29.27 the death of the individual, the individual would be a parent of the child; or

29.28 (ii) the individual's intent to be a parent of a child conceived by assisted reproduction

30.2 Sec. 10. **REPEALER.**

30.3 Minnesota Statutes 2022, section 257.56, is repealed.

**257.56 ARTIFICIAL INSEMINATION.**

Subdivision 1. **Husband treated as biological father.** If, under the supervision of a licensed physician and with the consent of her husband, a wife is inseminated artificially with semen donated by a man not her husband, the husband is treated in law as if he were the biological father of a child thereby conceived. The husband's consent must be in writing and signed by him and his wife. The consent must be retained by the physician for at least four years after the confirmation of a pregnancy that occurs during the process of artificial insemination.

All papers and records pertaining to the insemination, whether part of the permanent record of a court or of a file held by the supervising physician or elsewhere, are subject to inspection only upon an order of the court for good cause shown.

Subd. 2. **Donor not treated as biological father.** The donor of semen provided to a licensed physician for use in artificial insemination of a married woman other than the donor's wife is treated in law as if he were not the biological father of a child thereby conceived.

**518A.39 MODIFICATION OF ORDERS OR DECREES.**

Subd. 3. **Maintenance on death or remarriage.** Unless otherwise agreed in writing or expressly provided in the decree, the obligation to pay future maintenance is terminated upon the death of either party or the remarriage of the party receiving maintenance.
