1.8	Subdivision 1. Program established. The Primary Care Case Management (PCCM)
1.9	program is established to achieve better health outcomes and reduce the cost of health care

1.11	for all medical assistance enrollees who are eligible under section 256B.055 and
1.12	MinnesotaCare enrollees eligible under section 256L.05. In counties where there is a

(a) In addition to paying providers under subdivision 2, the commissioner shall use the PCCM program to pay primary care providers for coordinating services for medical assistance and MinnesotaCare enrollees who have specific or complex medical conditions which require case management services, unless an enrollee is already receiving case management services. Under the program, patients may choose a primary care provider to act as the enrollee's case manager. Primary care physicians, nurses, and other qualified licensed or certified case management professionals may provide primary care case management. Specialists who routinely provide care for patients with specific or complex medical conditions shall also be considered primary care providers for purposes of case management. 2.10 Primary care providers who offer PCCM services shall receive a fee for performing case 2.11 management services.
