1.1 A bill for an act  
 1.2 relating to education finance; modifying early childhood and family education  
 1.3 home visiting levy; establishing a home visiting revenue program; amending  
 1.4 Minnesota Statutes 2014, section 124D.135, subdivision 6, by adding  
 1.5 subdivisions.

1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 Section 1. Minnesota Statutes 2014, section 124D.135, subdivision 6, is amended to  
 1.8 read:

1.9 Subd. 6. **Home visiting levy revenue.** (a) A district that is eligible to levy for early  
 1.10 childhood family education under subdivision 3 1 and that enters into a collaborative  
 1.11 agreement to provide education services and social services to families with young  
 1.12 children may levy an amount equal to \$1.60 is eligible for home visiting revenue.

1.13 (b) Total home visiting revenue for a district equals \$4.50 times the number of people  
 1.14 under five years of age residing in the district on September 1 of the last school year. Levy  
 1.15 Revenue under this subdivision must not be included as revenue under subdivision 1. The  
 1.16 revenue must be used for home visiting programs under section 124D.13, subdivision 4.

1.17 **EFFECTIVE DATE.** This section is effective for revenue in fiscal year 2018 and  
 1.18 later.

1.19 Sec. 2. Minnesota Statutes 2014, section 124D.135, is amended by adding a  
 1.20 subdivision to read:

1.21 Subd. 6a. **Home visiting levy.** To obtain home visiting revenue, a district may levy  
 1.22 an amount not more than the product of its home visiting revenue for the fiscal year times  
 1.23 the lesser of one or the ratio of its adjusted net tax capacity per adjusted pupil unit to the

2.1 home visiting equalizing factor. The home visiting equalizing factor equals \$23,100 for  
 2.2 fiscal year 2018 and later.

2.3 **EFFECTIVE DATE.** This section is effective for revenue in fiscal year 2018 and  
 2.4 later.

2.5 Sec. 3. Minnesota Statutes 2014, section 124D.135, is amended by adding a  
 2.6 subdivision to read:

2.7 Subd. 6b. **Home visiting aid.** A district's home visiting aid equals its home visiting  
 2.8 revenue minus its home visiting levy times the ratio of the actual amount levied to the  
 2.9 permitted levy.

2.10 **EFFECTIVE DATE.** This section is effective for revenue in fiscal year 2018 and  
 2.11 later.
