1.6	Section 1. [62Q.528] DRUG COVERAGE IN EMERGENCY SITUATIONS.
1.7	A health plan that provides prescription drug coverage must provide coverage for
1.8	a prescription drug dispensed by a pharmacist under section 151.221, under the terms
1.9	of coverage that would apply had the prescription drug been dispensed according to
1.10	a prescription.
1.11	EFFECTIVE DATE. This section is effective on January 1 of the first calendar
