1.1 A bill for an act
1.2 relating to solid waste; establishing Packaging Waste and Cost Reduction Act;
1.3 authorizing rulemaking; proposing coding for new law in Minnesota Statutes,
1.4 chapter 115A.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. [115A.144] SHORT TITLE.

1.7 Sections 115A.144 to 115A.1462 may be cited as the "Packaging Waste and Cost
1.8 Reduction Act."

1.9 Sec. 2. [115A.1441] DEFINITIONS.

1.10 Subdivision 1. Scope. For the purposes of sections 115A.144 to 115A.1462, the terms
1.11 in this section have the meanings given.

1.12 Subd. 2. Advisory board. "Advisory board" or "board" means the Producer
1.13 Responsibility Advisory Board established under section 115A.1444.

1.14 Subd. 3. Brand. "Brand" means a name, symbol, word, or mark that identifies a product
1.15 and attributes the product and its components, including packaging, to the brand owner.

1.16 Subd. 4. Brand owner. "Brand owner" means a person that owns or licenses a brand or
1.17 that otherwise has rights to market a product under the brand, whether or not the brand's
1.18 trademark is registered.

1.19 Subd. 5. Collection rate. "Collection rate" means the amount of a covered material by
1.20 covered materials type collected by service providers and transported for recycling or
1.21 composting divided by the total amount of the type of a covered material by covered materials

2.1 type sold or distributed into the state by the relevant unit of measurement established in  
2.2 section 115A.1451.

2.3 Subd. 6. **Compostable material.** "Compostable material" means a covered material  
2.4 that:

2.5 (1) meets, and is labeled to reflect that it meets, the American Society for Testing and  
2.6 Materials Standard Specification for Labeling of Plastics Designed to be Aerobically  
2.7 Composted in Municipal or Industrial Facilities (D6400) or its successor;

2.8 (2) meets, and is labeled to reflect that it meets, the American Society for Testing and  
2.9 Materials Standard Specification for Labeling of End Items that Incorporate Plastics and  
2.10 Polymers as Coatings or Additives with Paper and Other Substrates Designed to be  
2.11 Aerobically Composted in Municipal or Industrial Facilities (D6868) or its successor;

2.12 (3) is comprised of only wood without any coatings or additives; or

2.13 (4) is comprised of only paper without any coatings or additives.

2.14 Subd. 7. **Composting.** "Composting" means the controlled microbial degradation of  
2.15 source-separated compostable materials to yield a humus-like product.

2.16 Subd. 8. **Composting rate.** "Composting rate" means the amount of compostable covered  
2.17 material that is managed through composting, divided by the total amount of compostable  
2.18 covered material sold or distributed into the state by the relevant unit of measurement  
2.19 established in section 115A.1451.

2.20 Subd. 9. **Covered material.** "Covered material" means packaging and paper products  
2.21 introduced into the state. Covered material does not include exempt materials.

2.22 Subd. 10. **Covered materials type.** "Covered materials type" means a singular and  
2.23 specific type of covered material, such as paper, plastic, metal, or glass, that can be  
2.24 categorized based on distinguishing chemical or physical properties, including properties  
2.25 that allow for a covered materials type to be aggregated into a commonly defined discrete  
2.26 commodity category for purposes of reuse, recycling, or composting, and based on similar  
2.27 uses in the form of a product or package.

2.28 Subd. 11. **De minimis producer.** "De minimis producer" means a person that in the  
2.29 most recent fiscal year:

2.30 (1) introduced less than one ton of covered material into this state; or

2.31 (2) earned global gross revenues of less than \$2,000,000.

3.1 Subd. 12. **Drop-off collection site.** "Drop-off collection site" means a physical location  
3.2 where covered materials are accepted from the public and that is open a minimum of 12  
3.3 hours weekly throughout the year.

3.4 Subd. 13. **Environmental impact.** "Environmental impact" means the impact of a  
3.5 covered material on human health and the environment from extraction and processing of  
3.6 the raw materials composing the material through manufacturing; distribution; use; recovery  
3.7 for reuse, recycling, or composting; and final disposal.

3.8 Subd. 14. **Exempt materials.** "Exempt materials" means materials, or any portion of  
3.9 materials, that:

3.10 (1) are packaging for infant formula, as defined in United States Code, title 21, section  
3.11 321(z);

3.12 (2) are packaging for medical food, as defined in United States Code, title 21, section  
3.13 360ee(b)(3);

3.14 (3) are packaging for a fortified oral nutritional supplement used by persons who require  
3.15 supplemental or sole source nutrition to meet nutritional needs due to special dietary needs  
3.16 directly related to cancer, chronic kidney disease, diabetes, malnutrition, or failure to thrive,  
3.17 as those terms are defined by the International Classification of Diseases, Tenth Revision;

3.18 (4) are a product, including its peripheral accessories, and the packaging or packaging  
3.19 components for any investigational or approved product regulated as a drug or medical  
3.20 device by the United States Food and Drug Administration;

3.21 (5) are medical equipment or products or their components, including consumable  
3.22 medical equipment or products and their components, and the packaging or packaging  
3.23 components for any products used in health care settings, including hospitals and clinics  
3.24 that are regulated by the United States Food and Drug Administration or used for infection  
3.25 prevention and dispensing of medication;

3.26 (6) are medical equipment or products and the packaging or packaging components for  
3.27 any product intended for Research Use Only as defined in the Federal Food, Drug, and  
3.28 Cosmetic Act, United States Code, title 21, section 360 et seq.;

3.29 (7) are drugs, biological products, parasiticides, medical devices, or in vitro diagnostics  
3.30 used to treat, or administered to, animals and regulated by the United States Food and Drug  
3.31 Administration under the Federal Food, Drug, and Cosmetic Act, United States Code, title  
3.32 21, section 301 et seq., by the United States Department of Agriculture under the federal  
3.33 Virus-Serum-Toxin Act, United States Code, title 21, section 151 et seq.;

4.1 (8) are packaging for products regulated or by the United States Environmental Protection  
4.2 Agency under the Federal Insecticide, Fungicide, and Rodenticide Act, United States Code,  
4.3 title 7, section 136 et seq.;

4.4 (9) are packaging used to contain liquefied petroleum gas and are designed to be refilled;  
4.5 or

4.6 (10) are paper products used for a print publication that primarily includes content derived  
4.7 from primary sources related to news and current events.

4.8 Subd. 15. **Food packaging.** "Food packaging" has the meaning given in section 325F.075.

4.9 Subd. 16. **Independent auditor.** "Independent auditor" means an independent and  
4.10 actively licensed certified public accountant that is:

4.11 (1) retained by a producer responsibility organization;

4.12 (2) not otherwise employed by or affiliated with a producer responsibility organization;  
4.13 and

4.14 (3) qualified to conduct an audit under state law.

4.15 Subd. 17. **Infrastructure investment.** "Infrastructure investment" means an investment  
4.16 by a producer responsibility organization that funds or reimburses service providers for:

4.17 (1) equipment or facilities in which covered materials are prepared for reuse, recycling,  
4.18 or composting;

4.19 (2) equipment or facilities used for waste reduction, reuse, recycling, or composting of  
4.20 covered materials; or

4.21 (3) the expansion or strengthening of demand for and use of covered materials by  
4.22 responsible markets in the state or region.

4.23 Subd. 18. **Introduce.** "Introduce" means to sell, offer for sale, distribute, or use to ship  
4.24 a product within or into this state.

4.25 Subd. 19. **Living wage.** "Living wage" means the minimum hourly wage necessary to  
4.26 allow a person working 40 hours per week to afford basic needs.

4.27 Subd. 20. **Needs assessment.** "Needs assessment" means an assessment conducted  
4.28 according to section 115A.1450. Except where the context requires otherwise, needs  
4.29 assessment means the most recently completed needs assessment.

4.30 Subd. 21. **Nondisclosure agreement.** "Nondisclosure agreement" means an agreement  
4.31 that requires the parties to the agreement to treat private and nonpublic data submitted to

5.1 facilitate completion of a needs assessment according to the definitions and requirements  
5.2 established in section 115A.06, subdivision 13.

5.3 Subd. 22. **Packaging.** "Packaging" has the meaning given in section 115A.03 and  
5.4 includes food packaging and only includes those materials that are supplied to a residential  
5.5 consumer. Packaging does not include exempt materials.

5.6 Subd. 23. **Paper product.** "Paper product" means a product made primarily from wood  
5.7 pulp or other cellulosic fibers, except that paper product does not include bound books or  
5.8 products that recycling or composting facilities will not accept because of the unsafe or  
5.9 unsanitary nature of the paper product.

5.10 Subd. 24. **Postconsumer recycled content.** "Postconsumer recycled content" means  
5.11 the portion of a product composed of postconsumer material, expressed as a percentage of  
5.12 the total weight of the product.

5.13 Subd. 25. **Producer.** (a) "Producer" means the following person responsible for  
5.14 compliance with requirements under this act for a covered material sold, offered for sale,  
5.15 or distributed in or into this state:

5.16 (1) for items sold in or with packaging at a physical retail location in this state:

5.17 (i) if the item is sold in or with packaging under the brand of the item manufacturer or  
5.18 is sold in packaging that lacks identification of a brand, the producer is the person that  
5.19 manufactures the item;

5.20 (ii) if there is no person to which item (i) applies, the producer is the person that is  
5.21 licensed to manufacture and sell or offer for sale to consumers in this state an item with  
5.22 packaging under the brand or trademark of another manufacturer or person;

5.23 (iii) if there is no person to which item (i) or (ii) applies, the producer is the brand owner  
5.24 of the item;

5.25 (iv) if there is no person described in item (i), (ii), or (iii) within the United States, the  
5.26 producer is the person who is the importer of record for the item into the United States for  
5.27 use in a commercial enterprise that sells, offers for sale, or distributes the item in this state;  
5.28 or

5.29 (v) if there is no person described in items (i) to (iv), the producer is the person that first  
5.30 distributes the item in or into this state;

5.31 (2) for items sold or distributed in packaging in or into this state via e-commerce, remote  
5.32 sale, or distribution:

6.1 (i) for packaging used to directly protect or contain the item, the producer of the packaging  
6.2 is the same as the producer identified under clause (1); and

6.3 (ii) for packaging used to ship the item to a consumer, the producer of the packaging is  
6.4 the person that packages the item to be shipped to the consumer;

6.5 (3) for packaging that is a covered material and is not included in clauses (1) and (2),  
6.6 the producer of the packaging is the person that first distributes the item in or into this state;

6.7 (4) for paper products that are magazines, catalogs, telephone directories, or similar  
6.8 publications, the producer is the publisher;

6.9 (5) for paper products not described in clause (4):

6.10 (i) if the paper product is sold under the manufacturer's own brand, the producer is the  
6.11 person that manufactures the paper product;

6.12 (ii) if there is no person to which item (i) applies, the producer is the person that is the  
6.13 owner or licensee of a brand or trademark under which the paper product is used in a  
6.14 commercial enterprise, sold, offered for sale, or distributed in or into this state, whether or  
6.15 not the trademark is registered in this state;

6.16 (iii) if there is no person to which item (i) or (ii) applies, the producer is the brand owner  
6.17 of the paper product;

6.18 (iv) if there is no person described in item (i), (ii), or (iii) within the United States, the  
6.19 producer is the person that imports the paper product into the United States for use in a  
6.20 commercial enterprise that sells, offers for sale, or distributes the paper product in this state;  
6.21 or

6.22 (v) if there is no person described in items (i) to (iv), the producer is the person that first  
6.23 distributes the paper product in or into this state; and

6.24 (6) a person is the producer of a covered material sold, offered for sale, or distributed  
6.25 in or into this state, as defined in clauses (1) to (5), except:

6.26 (i) where another person has mutually signed an agreement with a producer as defined  
6.27 in clauses (1) to (5) that contractually assigns responsibility to the person as the producer,  
6.28 and the person has joined a registered producer responsibility organization as the responsible  
6.29 producer for that covered material under this act. In the event that another person is assigned  
6.30 responsibility as the producer under this subdivision, the producer under clauses (1) to (5)  
6.31 must provide written certification of that contractual agreement to the producer responsibility  
6.32 organization; and

7.1 (ii) if the producer described in clauses (1) to (5) is a business operated wholly or in part  
7.2 as a franchise, the producer is the franchisor if that franchisor has franchisees that have a  
7.3 commercial presence within the state.

7.4 (b) "Producer" does not include:

7.5 (1) government agencies, municipalities, or other political subdivisions of the state;

7.6 (2) registered 501(c)(3) charitable organizations and 501(c)(4) social welfare  
7.7 organizations;

7.8 (3) de minimis producers; or

7.9 (4) a mill that uses any virgin wood fiber in the products it produces.

7.10 Subd. 26. **Producer responsibility organization.** "Producer responsibility organization"  
7.11 means a nonprofit corporation that is tax exempt under chapter 501(c)(3) of the federal  
7.12 Internal Revenue Code and that is created by a group of producers to implement activities  
7.13 under this act.

7.14 Subd. 27. **Recycling.** "Recycling" has the meaning given in section 115A.03 except that  
7.15 recycling does not include reuse or composting, as defined in this act.

7.16 Subd. 28. **Recycling rate.** "Recycling rate" means the amount of covered material, in  
7.17 aggregate or by individual covered materials type, recycled in a calendar year divided by  
7.18 the total amount of covered materials sold or distributed into the state by the relevant unit  
7.19 of measurement established in section 115A.1451.

7.20 Subd. 29. **Refill.** "Refill" means the continued use of a covered material by a consumer  
7.21 through a system that is:

7.22 (1) intentionally designed and marketed for repeated filling of a covered material to  
7.23 reduce demand for new production of the covered material;

7.24 (2) supported by adequate logistics and infrastructure to provide convenient access for  
7.25 consumers; and

7.26 (3) compliant with all applicable state and local statute, rule, ordinance, or other law  
7.27 governing health and safety.

7.28 Subd. 30. **Responsible market.** "Responsible market" means a materials market that:

7.29 (1) reuses, recycles, composts, or otherwise recovers materials and disposes of  
7.30 contaminants in a manner that protects the environment and minimizes risks to public health  
7.31 and worker health and safety;

8.1 (2) complies with all applicable federal, state, and local statutes, rules, ordinances, or  
8.2 other laws governing environmental, health, safety, and financial responsibility;

8.3 (3) possesses all requisite licenses and permits required by government agencies;

8.4 (4) if the market operates in the state, manages waste according to the waste management  
8.5 goal and priority order of waste management practices stated in section 115A.02; and

8.6 (5) minimizes adverse impacts to environmental justice areas.

8.7 Subd. 31. **Return rate.** "Return rate" means the amount of reusable covered material in  
8.8 aggregate or by individual covered materials type, collected for reuse by the producer or  
8.9 service provider in a calendar year, divided by the total amount of reusable covered materials  
8.10 sold or distributed into the state by the relevant unit of measurement established in section  
8.11 115A.1451.

8.12 Subd. 32. **Reusable.** "Reusable" means capable of reuse.

8.13 Subd. 33. **Reuse.** "Reuse" means the return of a covered material to the marketplace and  
8.14 the continued use of the covered material by a producer or service provider when the covered  
8.15 material is:

8.16 (1) intentionally designed and marketed to be used multiple times for its original intended  
8.17 purpose without a change in form;

8.18 (2) designed for durability and maintenance to extend its useful life and reduce demand  
8.19 for new production of the covered material;

8.20 (3) supported by adequate logistics and infrastructure at a retail location, by a service  
8.21 provider, or on behalf of or by a producer, that provides convenient access for consumers;  
8.22 and

8.23 (4) compliant with all applicable state and local statutes, rules, ordinances, or other laws  
8.24 governing health and safety.

8.25 Subd. 34. **Reuse rate.** "Reuse rate" means the share of units of a covered material sold  
8.26 or distributed into the state in a calendar year that are deemed reusable by the commissioner  
8.27 according to section 115A.1451.

8.28 Subd. 35. **Service provider.** "Service provider" means an entity that collects, transfers,  
8.29 sorts, processes, recovers, or otherwise prepares covered materials for reuse, recycling, or  
8.30 composting. A political subdivision that provides or that contracts or otherwise arranges  
8.31 with another party to provide reuse, collection, recycling, or composting services for covered  
8.32 materials within its jurisdiction may be a service provider regardless of whether it provided,



9.1 contracted for, or otherwise arranged for similar services before the approval of the applicable  
 9.2 stewardship plan.

9.3 Subd. 36. **Third-party certification.** "Third-party certification" means certification by  
 9.4 an accredited independent organization that a standard or process required by this act, or a  
 9.5 stewardship plan approved under this act, has been achieved.

9.6 Subd. 37. **This act.** "This act" means sections 115A.144 to 115A.1462.

9.7 Subd. 38. **Toxic substance.** "Toxic substance" means hazardous waste, a problem  
 9.8 material, a chemical or chemical class regulated under section 115A.965, 116.943, 325F.075,  
 9.9 or 325F.172 to 325F.179, or a chemical of high concern identified under section 116.9402.

9.10 Subd. 39. **Waste reduction or source reduction.** "Waste reduction" or "source reduction"  
 9.11 has the meaning given in section 115A.03, except that waste reduction or source reduction  
 9.12 does not include reuse, but does include refill, as defined in this act.

9.13 **Sec. 3. [115A.1442] ESTABLISHMENT OF PROGRAM.**

9.14 Producers must implement and finance a statewide program for packaging and paper  
 9.15 products in accordance with this act that encourages packaging redesign to reduce the  
 9.16 environmental impacts and human health impacts and that reduces generation of covered  
 9.17 materials waste through waste reduction, reuse, recycling, and composting and by providing  
 9.18 for negotiation and execution of agreements to collect, transport, and process used covered  
 9.19 materials for reuse, recycling, and composting.

9.20 **Sec. 4. [115A.1443] REGISTRATION OF PRODUCER RESPONSIBILITY**  
 9.21 **ORGANIZATIONS AND SERVICE PROVIDERS.**

9.22 Subdivision 1. **Annual registration.** (a) By July 1, 2025, and each January 1 thereafter,  
 9.23 producers must appoint a producer responsibility organization. The producer responsibility  
 9.24 organization must register with the commissioner by July 1, 2026, and each January 1  
 9.25 thereafter by submitting the following:

9.26 (1) contact information for a person responsible for implementing an approved  
 9.27 stewardship plan;

9.28 (2) a list of all member producers that will operate under the stewardship plan  
 9.29 administered by the producer responsibility organization and, for each producer, a list of  
 9.30 all brands of the producer's covered materials introduced;

10.1 (3) copies of written agreements with each producer stating that each producer agrees  
10.2 to operate under an approved stewardship plan administered by the producer responsibility  
10.3 organization;

10.4 (4) a list of current board members and the executive director if different than the person  
10.5 responsible for implementing approved stewardship plans; and

10.6 (5) documentation demonstrating adequate financial responsibility and financial controls  
10.7 to ensure proper management of funds and payment of the annual fee required under  
10.8 subdivision 2.

10.9 (b) Following the approval of the initial producer responsibility organization and the  
10.10 initial stewardship plan, if more than a single producer responsibility organization is  
10.11 established, the producers and producer responsibility organizations must establish a  
10.12 coordinating body and process to prevent redundancy. The stewardship plans of all producer  
10.13 responsibility organizations must be integrated into a single stewardship plan that covers  
10.14 all requirements of this act and encompasses all producers when submitted to the  
10.15 commissioner for approval. The annual reports of all producer responsibility organizations  
10.16 must be integrated into a single annual report that covers all requirements of this act and  
10.17 encompasses all producers when submitted to the commissioner.

10.18 Subd. 2. **Registration fee.** (a) As part of its annual registration with the commissioner,  
10.19 a producer responsibility organization must submit to the commissioner an annual fee for  
10.20 the following year, as determined by the commissioner. Beginning October 1, 2026, and  
10.21 annually thereafter, the commissioner must notify registered producer responsibility  
10.22 organizations in writing of the amount of the fee for the following year. If there is more  
10.23 than one registered producer responsibility organization, the coordinating body described  
10.24 in subdivision 1, paragraph (b), must equitably apportion payment of the annual fee between  
10.25 all registered producer responsibility organizations. The annual fee must be set at an amount  
10.26 anticipated to in the aggregate meet but not exceed the commissioner's estimate of the costs  
10.27 required to perform the commissioner's duties as described in section 115A.1445 and to  
10.28 otherwise administer, implement, and enforce this act.

10.29 (b) The commissioner must reconcile the fees paid by a producer responsibility  
10.30 organization under this subdivision with the actual costs incurred by the agency on an annual  
10.31 basis, by means of credits or refunds to or additional payments required of a producer  
10.32 responsibility organization, as applicable.

10.33 Subd. 3. **Initial producer responsibility organization registration; implementation**  
10.34 fee. (a) By January 1, 2025, producers must appoint a producer responsibility organization.

11.1 The producer responsibility organization must register with the commissioner by submitting  
11.2 the following:

11.3 (1) contact information for a person responsible for implementing an approved  
11.4 stewardship plan;

11.5 (2) a list of current member producers and their written agreements confirming producers  
11.6 will operate under an approved stewardship plan administered by the producer responsibility  
11.7 organization;

11.8 (3) a plan for recruiting additional member producers and executing written agreements  
11.9 confirming producers will operate under an approved stewardship plan administered by the  
11.10 producer responsibility organization;

11.11 (4) a list of current board members and the executive director if different than the person  
11.12 responsible for implementing approved stewardship plans; and

11.13 (5) documentation demonstrating adequate financial responsibility and financial controls  
11.14 to ensure proper management of funds and payment of the annual fee required under  
11.15 subdivision 2.

11.16 (b) Notwithstanding the other provisions of this section, the commissioner may not allow  
11.17 registration of more than one producer responsibility organization under this section before  
11.18 the first stewardship plan approved by the commissioner expires. If more than one producer  
11.19 responsibility organization applies to register under this section before the first stewardship  
11.20 plan is approved by the commissioner, the commissioner must select the producer  
11.21 responsibility organization that will represent producers until the first stewardship plan  
11.22 expires and must return the registration fee paid by applicants who are not selected. When  
11.23 selecting a producer responsibility organization, the commissioner must consider whether  
11.24 the producer responsibility organization:

11.25 (1) has a governing board consisting of producers that represent a diversity of covered  
11.26 materials introduced; and

11.27 (2) demonstrates adequate financial responsibility and financial controls to ensure proper  
11.28 management of funds.

11.29 (c) By January 1, 2025, and annually until the first stewardship plan is approved, the  
11.30 commissioner must provide written notice to the initial producer responsibility organization  
11.31 appointed by producers of the commissioner's estimate of the cost of conducting the  
11.32 preliminary needs assessment, initial needs assessment, and the commissioner's costs to  
11.33 administer this act during the period prior to plan approval. The producer responsibility

12.1 organization must remit payment in full for these costs to the commissioner within 45 days  
 12.2 of receipt of this notice. The producer responsibility organization may charge each member  
 12.3 producer to cover the cost of its implementation fee according to each producer's unit-,  
 12.4 weight-, volume-, or sales-based market share or by another method it determines to be an  
 12.5 equitable determination of each producer's payment obligation.

12.6 Subd. 4. **Requirement for additional producer responsibility organizations.** After  
 12.7 the first stewardship plan approved by the commissioner expires, the commissioner may  
 12.8 allow registration of more than one producer responsibility organization if:

12.9 (1) producers of a covered materials type or a specific covered material appoint a producer  
 12.10 responsibility organization; or

12.11 (2) producers organize under additional producer responsibility organizations that meet  
 12.12 the criteria established in subdivision 3, paragraph (a).

12.13 Subd. 5. **Registration of service providers.** (a) By January 1, 2027, and annually  
 12.14 thereafter, a service provider seeking reimbursement for services provided under an approved  
 12.15 stewardship plan according to section 115A.1451 may elect to register with the commissioner  
 12.16 by submitting the following information:

12.17 (1) contact information for a person representing the service provider; and

12.18 (2) address of the service provider.

12.19 (b) A service provider may register at any time.

12.20 **Sec. 5. [115A.1444] ESTABLISHMENT OF PRODUCER RESPONSIBILITY**  
 12.21 **ADVISORY BOARD.**

12.22 Subdivision 1. **Establishment.** The Producer Responsibility Advisory Board is established  
 12.23 to review all activities conducted by producer responsibility organizations under this act  
 12.24 and to advise the commissioner and producer responsibility organizations regarding the

12.26 Subd. 2. **Membership.** (a) The membership of the advisory board consists of persons  
 12.27 appointed by the commissioner by January 1, 2025, as follows:

12.28 (1) two members representing manufacturers of covered materials or a statewide or  
 12.29 national trade association representing those manufacturers;

12.30 (2) two members representing recycling facilities that manage covered materials;

13.1 (3) one member representing a waste hauler or a statewide association representing waste  
13.2 haulers;

13.3 (4) one member representing retailers of covered materials or a statewide trade association  
13.4 representing those retailers;

13.5 (5) one member representing a statewide nonprofit environmental organization;

13.6 (6) one member representing a community-based nonprofit environmental justice  
13.7 organization;

13.8 (7) one member representing a waste facility that receives and sorts covered materials  
13.9 and transfers them to another facility for reuse, recycling, or composting;

13.10 (8) one member representing a waste facility that receives compostable materials for  
13.11 composting or a statewide trade association that represents such facilities;

13.12 (9) two members representing an entity that develops or offers for sale covered materials  
13.13 that are designed for reuse and maintained through a reuse system or infrastructure or a  
13.14 statewide or national trade association that represents such entities;

13.15 (10) three members representing organizations of political subdivisions, with at least  
13.16 one member representing a political subdivision outside the metropolitan area;

13.17 (11) two members representing other stakeholders or additional members of interests  
13.18 represented under clauses (1) to (10) as determined by the commissioner; and

13.19 (12) one member representing the commissioner.

13.20 (b) In making appointments under paragraph (a), the commissioner:

13.21 (1) may not appoint members who are state legislators or registered lobbyists;

13.22 (2) may not appoint members who are employees of a producer required to be members  
13.23 of a producer responsibility organization in this state under this act; and

13.24 (3) must endeavor to appoint members from all regions of the state.

13.25 Subd. 3. **Terms; removal.** A member of the advisory board appointed under subdivision  
13.26 2, paragraph (a), clause (12), serves at the pleasure of the commissioner. All other members  
13.27 serve for a term of four years, except that the initial term for nine of the initial appointees  
13.28 must be two years so that membership terms are staggered. Members may be reappointed

14.15 Subd. 10. **Administrative and operating support.** The commissioner must provide  
14.16 administrative and operating support to the advisory board and may contract with a third-party  
14.17 facilitator to assist in administering the activities of the advisory board, including establishing  
14.18 a website or landing page on the agency website.

14.19 Subd. 11. **Conflict of interest policies.** The commissioner must assist the advisory board  
14.20 in developing policies and procedures governing the disclosure of actual or perceived  
14.21 conflicts of interest that advisory board members may have as a result of their employment  
14.22 or financial holdings of themselves or of family members. Each advisory board member is  
14.23 responsible for reviewing the conflict of interest policies and procedures. An advisory board

- 15.14 (iii) the most recent needs assessments;
- 15.15 (iv) any stewardship plan or amendment submitted by a producer responsibility  
15.16 organization under section 115A.1451 that is in draft form during the public comment  
15.17 period;
- 15.18 (v) the most recent lists established according to section 115A.1453;
- 15.19 (vi) the list of exempt materials and covered materials exempt from performance targets  
15.20 and statewide requirements as approved in the stewardship plan;
- 15.21 (vii) links to producer responsibility organization websites;
- 15.22 (viii) comments of the public, advisory board, and producer responsibility organizations  
15.23 on the documents listed in items (iii), (iv), (v), and (ix), and the responses of the  
15.24 commissioner to those comments; and
- 15.25 (ix) links to adopted rules implementing this act;
- 15.26 (8) provide producer responsibility organizations with information regarding Minnesota

17.6 The producer responsibility organization must notify the commissioner when a producer

17.18 (14) reimburse service providers in a timely manner and according to reimbursement  
17.19 rates approved in a stewardship plan as established according to section 115A.1451; and

17.20 (15) comply with all other applicable requirements of this act.

17.21 **Sec. 9. [115A.1448] PRODUCER RESPONSIBILITIES.**

17.22 Subdivision 1. **Registration required; prohibition of sale.** (a) After January 1, 2025,  
17.23 a producer must be a member of a producer responsibility organization registered in this

19.2 Sec. 11. [115A.1450] NEEDS ASSESSMENTS.

19.3 Subdivision 1. Needs assessments required. (a) By December 31, 2025, and every five  
19.4 years thereafter, the commissioner must complete a preliminary needs assessment according  
19.5 to this section.

19.6 (b) By December 31, 2026, and every five years thereafter, the commissioner must  
19.7 complete a statewide needs assessment according to this section. The commissioner may  
19.8 adjust what is required to be included in a specific needs assessment to inform the next  
19.9 stewardship plan.

19.10 Subd. 2. Input from interested parties. In conducting a needs assessment, the

20.14 Subd. 4. **Content of needs assessment.** A needs assessment must include at least the

22.6 (8) an evaluation of options for third-party certification of activities to meet obligations

22.8 (9) an inventory of the current system including:

22.9 (i) infrastructure, capacity, performance, funding level, and method and sources of

 23.5 of contamination on service providers, including the cost to manage this contamination;

23.25 Subd. 5. **Needs assessment as baseline.** When determining the extent to which any  
 23.26 statewide requirement or performance target under this act has been achieved, information  
 23.27 contained in a needs assessment must serve as the baseline for that determination, when  
 23.28 applicable.

23.29 Subd. 6. **Participation required.** (a) A service provider or other person with data or  
 23.30 information necessary to complete a needs assessment must provide the data or information  
 23.31 to the commissioner upon request. A service provider or other person who does not want  
 23.32 to be identified with information submitted to the commissioner under this subdivision may  
 23.33 request to proceed under a nondisclosure agreement. A nondisclosure agreement is limited

 24.18 commissioner that describes the proposed operation by the organization of programs to  
 24.19 fulfill the requirements of this act and that incorporates the findings and results of needs  
 24.20 assessments. Once approved, a stewardship plan remains in effect for five years, as amended,

25.9 covered materials that cannot be waste reduced or made reusable, recyclable, or compostable  
25.10 due to federal or state health and safety requirements, identifying the specific federal or  
25.11 state requirements and their impact on the covered materials;
- 25.12 (4) a plan for how the producer responsibility organization will measure recycling, waste  
25.13 reduction, reuse, composting, and inclusion of postconsumer recycled content, according  
25.14 to subdivision 6 and by covered materials type as applicable;
- 25.15 (5) third-party certifications as required by the commissioner or voluntarily undertaken;
- 25.16 (6) a budget identifying funding needs for each of the five calendar years covered by  
25.17 the plan, producer fees, a description of the process used to calculate the fees, and an  
25.18 explanation of how the fees meet the requirements of section 115A.1454;
- 25.19 (7) goals for infrastructure investments, including a description of how the process to  
25.20 offer and select opportunities will be conducted in an open, competitive, and fair manner;  
25.21 how it will address gaps in the system not met by service providers; and potential financial  
25.22 and legal instruments to be used;
- 25.23 (8) an explanation of how the program will be paid for by the producer responsibility  
25.24 organization through fees from producers, without any new or additional consumer-facing  
25.25 fee to members of the public, businesses, service providers, the state or any political  
25.26 subdivisions, or any other person who is not a producer, unless the fee is:
- 25.27 (i) a deposit made in connection with a product's refill, reuse, or recycling that can be  
25.28 redeemed by a consumer; or
- 25.29 (ii) a charge for service by a service provider, regardless of whether registered;
- 25.30 (9) a description of activities to be undertaken during the next five calendar years, which  
25.31 must at a minimum describe how the producer responsibility organization, acting on behalf  
25.32 of producers, will:

26.1 (i) minimize the environmental impacts and human health impacts of covered materials,  
26.2 including assessing each covered material's generation of hazardous waste, generation of  
26.3 greenhouse gases, environmental justice impacts, public health impacts, and other impacts;

26.4 (ii) incorporate as program objectives the improved design of covered materials according  
26.5 to section 115A.1454, subdivision 1, clause (2);

26.6 (iii) provide funding to expand and increase the convenience of waste reduction, reuse,  
26.7 collection, recycling, and composting services according to the order of the waste  
26.8 management hierarchy under section 115A.02;

26.9 (iv) provide for reasonable reimbursement rates for statewide coverage of recycling  
26.10 services for covered materials on the lists established in section 115A.1453 to single-family  
26.11 residences, multifamily residences, and political subdivisions arranging for collection,  
26.12 transportation, and processing of recyclable materials at an equivalent level of convenience  
26.13 as services for mixed municipal solid waste according to section 115A.1455; and

26.14 (v) monitor to ensure that postconsumer recycled materials are delivered to responsible  
26.15 markets;

26.16 (10) a description of how the producer responsibility organization will promote the  
26.17 opportunity for all service providers to register with the commissioner and to submit for  
26.18 reimbursement with the producer responsibility organization;

26.19 (11) a description of how the program shall reimburse service providers under an  
26.20 approved stewardship plan, including but not limited to:

26.21 (i) the use of differentiated rates developed according to the requirements and factors  
26.22 established under section 115A.1455, subdivision 4;

26.23 (ii) clear and reasonable timelines for reimbursement, with a frequency of no less than  
26.24 monthly unless agreed to by a service provider and a producer responsibility organization;  
26.25 and

26.26 (iii) a process to resolve disputes that arise between the producer responsibility  
26.27 organization and a service provider regarding the determination and payment of  
26.28 reimbursements;

26.29 (12) performance standards for service providers that are reimbursed under an approved  
26.30 stewardship plan, including but not limited to the following, as applicable to the service  
26.31 provided:

- 27.1 (i) requirements that service providers must accept all covered materials on the lists  
27.2 established by the commissioner under section 115A.1453; and
- 27.3 (ii) labor standards and safety practices, including but not limited to safety programs,  
27.4 health benefits, and living wages;
- 27.5 (13) a description of how the producer responsibility organization will treat and protect  
27.6 nonpublic data submitted by service providers;
- 27.7 (14) a description of how the producer responsibility organization will provide technical  
27.8 assistance to:
- 27.9 (i) service providers in order to deliver covered materials to responsible markets;
- 27.10 (ii) producers regarding toxic substances in covered materials and actions producers can  
27.11 take to reduce intentionally added toxic substances in covered materials, including verification  
27.12 by suppliers through certificates of compliance, upon request; and
- 27.13 (iii) producers to make changes in product design that reduce the environmental impact  
27.14 of covered materials or that increase the recoverability or marketability of covered materials  
27.15 for reuse, recycling, or composting;
- 27.16 (15) a description of how the producer responsibility organization will increase public  
27.17 awareness, educate, and complete outreach activities accounting for culturally responsive  
27.18 materials and methods and evaluate the efficacy of these efforts including how the producer  
27.19 responsibility organization will:
- 27.20 (i) assist producers in improving product labels as a means of informing consumers  
27.21 about refilling, reusing, recycling, composting, and other environmentally sound methods  
27.22 of managing covered materials;
- 27.23 (ii) increase public awareness of how to use and manage covered materials in an  
27.24 environmentally sound manner and how to access waste reduction, reuse, recycling, and  
27.25 composting services; and
- 27.26 (iii) encourage behavior change to increase participation in waste reduction, reuse,  
27.27 recycling, and composting programs;
- 27.28 (16) a summary of consultations held with the advisory board and other stakeholders to  
27.29 provide input to the stewardship plan, a list of recommendations that were incorporated into  
27.30 the stewardship plan as a result, and a list of rejected recommendations and the reasons for  
27.31 rejection; and

28.1 (17) strategies to incorporate findings from any relevant studies required by the  
28.2 legislature.

28.3 Subd. 4. **Plan and amendment review and approval procedure.** (a) The commissioner  
28.4 must review and approve, deny, or request additional information for a draft stewardship  
28.5 plan or a draft plan amendment no later than 120 days after the date the commissioner  
28.6 receives it from a producer responsibility organization. The commissioner must post the  
28.7 draft plan or draft amendment on the agency's website and allow public comment for no  
28.8 less than 45 days before approving, denying, or requesting additional information on the  
28.9 draft plan or draft amendment.

28.10 (b) If the commissioner denies, or requests additional information for, a draft plan or  
28.11 draft amendment, the commissioner must provide the producer responsibility organization  
28.12 with the reasons, in writing, that the plan or plan amendment does not meet the plan  
28.13 requirements of subdivision 3. The producer responsibility organization shall have 60 days  
28.14 from the date that the rejection or request for additional information is received to submit  
28.15 to the commissioner any additional information necessary for the approval of the draft plan  
28.16 or draft amendment. The commissioner shall review and approve or disapprove the revised  
28.17 draft plan or draft amendment no later than 60 days after the date the commissioner receives  
28.18 it.

28.19 (c) A producer responsibility organization may resubmit a draft plan or draft amendment  
28.20 to the commissioner on not more than two occasions. If after the second resubmission, the  
28.21 commissioner determines that the draft plan or draft amendment does not meet the plan  
28.22 requirements of this act, the commissioner must modify the draft plan or draft amendment  
28.23 as necessary for it to meet the requirements of this act and approve it.

28.24 (d) Upon recommendation by the advisory board, or upon the commissioner's own  
28.25 initiative, the commissioner may require an amendment to a stewardship plan if the  
28.26 commissioner determines that an amendment is necessary to ensure that the producer  
28.27 responsibility organization maintains compliance with the requirements of this act.

28.28 Subd. 5. **Performance targets.** (a) The producer responsibility organization must propose  
28.29 performance targets based on the needs assessment that meet the statewide requirements in  
28.30 subdivision 7 that must be included in a stewardship plan approved under this section.  
28.31 Performance targets must include reuse rates, return rates, recycling rates, composting rates,  
28.32 and targets for waste reduction, and postconsumer recycled content by covered materials  
28.33 type that are to be achieved by the end of the stewardship plan's term. The producer

29.1 responsibility organization must select the unit that is most appropriate to measure each  
29.2 performance target as informed by the needs assessment.

29.3 (b) The commissioner may require that a producer responsibility organization obtain  
29.4 third-party certification of any activity or achievement of any standard required by this act.  
29.5 The commissioner must provide a producer responsibility organization with notice of at  
29.6 least one year prior to requiring use of third-party certification under this paragraph if such  
29.7 certifications are readily available, applicable, and of reasonable cost.

29.8 (c) Proposed performance targets must demonstrate continuous improvement in reducing  
29.9 environmental impacts and human health impacts of covered materials over time.

29.10 Subd. 6. Measurement criteria for performance targets. (a) For purposes of  
29.11 determining whether recycling performance targets are being met, except as modified by  
29.12 the commissioner, a stewardship plan must provide for the measurement of the amount of  
29.13 recycled material to be at the point at which material leaves a recycling facility and must  
29.14 account for:

29.15 (1) levels of estimated contamination documented by the facility;

29.16 (2) any exclusions for fuel or energy capture; and

29.17 (3) compliance with sections 115A.965, 116.943, 325F.075, and 325F.172 to 325F.179,  
29.18 and all other laws pertaining to toxic substances in covered materials.

29.19 (b) For purposes of determining whether waste reduction performance targets are being  
29.20 met, a stewardship plan must provide for the measurement of the amount of waste reduction  
29.21 of covered materials in a manner that can determine the extent to which the amount of  
29.22 material used for a covered material is eliminated beyond what is necessary to efficiently  
29.23 deliver a product without damage or spoilage, or other means of covered material redesign  
29.24 to reduce overall use and environmental impacts.

29.25 (c) For purposes of determining whether reuse targets are being met, a stewardship plan  
29.26 must provide for the measurement of the amount of reusable covered materials to be at the  
29.27 point at which reusable covered materials meet the following criteria as demonstrated by  
29.28 the producer and approved by the commissioner:

29.29 (1) whether the average minimum number of cycles of reuses within a recognized reuse  
29.30 system has been met based on the number of times an item must be reused for it to have  
29.31 lower environmental impacts than the single-use versions of those items; and

29.32 (2) whether the demonstrated or research-based anticipated return rate of the covered  
29.33 material to the reuse system has been met.

30.1 (d) For other targets, the producer responsibility organization must propose a calculation  
30.2 point for review and approval as part of the stewardship plan based on findings from the  
30.3 needs assessment.

30.4 Subd. 7. Statewide requirements. (a) The commissioner must establish or approve  
30.5 statewide requirements and the date the statewide requirements must be met for the following  
30.6 categories:

30.7 (1) recycling rate;

30.8 (2) composting rate;

30.9 (3) reuse rate;

30.10 (4) return rate;

30.11 (5) the percentage of covered materials introduced that must be waste reduced; and

30.12 (6) the percentage of postconsumer recycled content that covered materials introduced  
30.13 must contain, including an overall percentage for all covered materials, as applicable,  
30.14 excluding compostable materials that cannot include postconsumer recycled content because  
30.15 unique chemical or physical properties or health and safety requirements prohibit introduction  
30.16 of postconsumer recycled content.

30.17 (b) The commissioner may use the following information and criteria when establishing  
30.18 statewide requirements under paragraph (a):

30.19 (1) needs assessments under section 115A.1450;

30.20 (2) goals and requirements of the Waste Management Act under this chapter;

30.21 (3) statewide goals for greenhouse gas emission reductions under section 216H.02;

30.22 (4) need for continuous progress toward generating less waste from covered materials  
30.23 and the complete reuse, recycling, or composting of the covered materials that are generated,  
30.24 in doing so reducing impacts to human health and the environment;

30.25 (5) a preference for statewide requirements that accomplish and further the goals and  
30.26 requirements in clauses (2) to (4) as soon as practicable and to the maximum extent  
30.27 achievable; and

30.28 (6) information from packaging and paper producer responsibility programs operating  
30.29 in other jurisdictions.

30.30 (c) The commissioner must consult with the product stewardship organization on the  
30.31 proposed statewide requirements and must submit proposed statewide requirements under

31.1 paragraph (a) to the advisory board and consider the board's recommendations before  
 31.2 finalizing the statewide requirements.

31.3 (d) Every five years, the commissioner must review the statewide requirements established  
 31.4 under paragraph (a). If the commissioner decides an update is not warranted at that time,  
 31.5 the commissioner must submit the reasoning to the advisory board and consider the board's  
 31.6 recommendations before making a final decision. If the commissioner decides an update is  
 31.7 warranted, the process in paragraphs (b) and (c) must be utilized.

31.8 (e) The producer responsibility organization must ensure the statewide requirements are  
 31.9 met.

31.10 **Sec. 13. [115A.1453] RECYCLABLE OR COMPOSTABLE COVERED**  
 31.11 **MATERIALS LISTS.**

31.12 Subdivision 1. **List required.** By March 1, 2027, the commissioner must complete a  
 31.13 list of covered materials determined to be recyclable or compostable statewide through  
 31.14 systems where covered materials are commingled into a recyclables stream and a separate  
 31.15 compostables stream. These covered materials must be collected at the equivalent level of  
 31.16 service and convenience as collection services for mixed municipal solid waste.

31.17 Subd. 2. **Alternative collection list required.** By March 1, 2027, the commissioner  
 31.18 must complete a list of covered materials determined to be recyclable or compostable and  
 31.19 collected statewide through systems other than the system required for covered materials  
 31.20 on the list established in subdivision 1.

31.21 Subd. 3. **Input from interested parties.** The commissioner must consult with the  
 31.22 advisory board, producer responsibility organizations, service providers, political  
 31.23 subdivisions, and other interested parties to develop or amend the recyclable or compostable  
 31.24 covered materials lists and must review any petitions by interested parties for addition or  
 31.25 removal of covered materials from the lists created under this section.

31.26 Subd. 4. **Criteria.** In developing the lists under subdivisions 1 and 2, the commissioner  
 31.27 may consider the following criteria:

31.28 (1) current availability of recycling collection services;

31.29 (2) recycling collection and processing infrastructure;

31.30 (3) capacity and technology for sorting covered materials;

31.31 (4) availability of responsible end markets;

31.32 (5) presence and amount of processing residuals and contamination;

32.1 (6) quantity of material estimated to be available and recoverable;

32.2 (7) projected future conditions for clauses (1) to (6);

32.3 (8) if collected for recycling, the covered material type and form must be one that is

32.4 regularly sorted and aggregated into defined streams for recycling processes or the packaging

32.5 format must be specified in a relevant Institution of Scrap Recycling Industries specification;

32.6 and

32.7 (9) other criteria or factors determined by the commissioner.

32.8 Subd. 5. **Amendment.** The commissioner may amend a list completed under this section

32.9 at any time and must provide amended lists to producer responsibility organizations as soon

32.10 as possible after adopting an amendment. Producer responsibility organizations must provide

32.11 amended lists to service providers as soon as possible after receiving the amendment and

32.12 work to incorporate changes in relevant service provider reimbursement rates within a year.

32.13 Sec. 14. **[115A.1454] PRODUCER FEES.**

32.14 Subdivision 1. **Annual fee.** A producer responsibility organization must annually collect

32.15 a fee from each producer that must:

32.16 (1) be based on the total amount of covered materials each producer introduces in the

32.17 prior year calculated on a per-unit basis, such as per ton, per item, or another unit of

32.18 measurement;

32.19 (2) incentivize using materials and design attributes that reduce the environmental impacts

32.20 and human health impacts, as determined by the commissioner, of covered materials by the

32.21 following methods:

32.22 (i) eliminating intentionally added toxic substances in covered materials;

32.23 (ii) reducing the amount of packaging per individual covered material that is necessary

32.24 to efficiently deliver a product without damage or spoilage without reducing its ability to

32.25 be recycled or reducing the amount of paper used to manufacture individual paper products;

32.26 (iii) increasing covered materials managed in a reuse system;

32.27 (iv) increasing the proportion of postconsumer material in covered materials;

32.28 (v) enhancing recyclability or compostability of a covered material; and

32.29 (vi) increasing the amount of inputs derived from renewable and sustainable sources;



33.1 (3) discourage using materials and design attributes in a producer's covered materials  
 33.2 whose environmental impacts and human health impacts, as determined by the commissioner,  
 33.3 can be reduced by the methods listed under clause (2);

33.4 (4) prioritize reuse by charging covered materials that are managed through a reuse  
 33.5 system only once, upon initial entry into the marketplace; and

33.6 (5) generate revenue sufficient to pay in full:

33.7 (i) the annual registration fee required under section 115A.1443;

33.8 (ii) financial obligations to complete activities described in an approved stewardship  
 33.9 plan and to reimburse service providers under section 115A.1455;

33.10 (iii) the operating costs of the producer responsibility organization; and

33.11 (iv) for the establishment and maintenance of a financial reserve that is sufficient to  
 33.12 operate the program in a fiscally prudent and responsible manner.

33.13 Subd. 2. **Overcollections.** Revenue collected under this section that exceeds the amount  
 33.14 needed to pay the costs described in subdivision 1, clause (5), must be used to improve or  
 33.15 enhance program outcomes or to reduce producer fees according to provisions of an approved  
 33.16 stewardship plan.

33.17 Subd. 3. **Prohibited conduct.** Fees collected under this section may not be used for  
 33.18 lobbying, as defined in section 3.084, subdivision 1.

33.19 Sec. 15. **[115A.1455] SERVICE PROVIDER; REIMBURSEMENT.**

33.20 Subdivision 1. **Service provider reimbursement required.** The reimbursements  
 33.21 provided for waste reduction, reuse, processing, recycling, or composting services under  
 33.22 an approved stewardship plan shall only be provided to service providers that meet the  
 33.23 performance standards requirements established under an approved stewardship plan.

33.24 Subd. 2. **Collection of recyclables.** If a household does not have access to collection  
 33.25 services at a comparable level of convenience as collection services for mixed municipal  
 33.26 solid waste for covered materials on the recyclable covered materials list established under  
 33.27 section 115A.1453, subdivision 1, the producer responsibility organization must ensure that  
 33.28 collection service is available to the household through a service provider.

33.29 Subd. 3. **Bidding processes.** (a) For infrastructure investments included under an  
 33.30 approved stewardship plan, a producer responsibility organization must use the competitive  
 33.31 bidding processes established in section 16C.28, subdivision 1, and publicly post bid  
 33.32 opportunities, except that preference must be given to existing facilities, providers of services,

34.1 and holders of service accounts in the state for waste reduction, reuse, collection, recycling,  
 34.2 and composting of covered materials.

34.3 (b) No producer or producer responsibility organization may own or partially own  
 34.4 infrastructure that is used to fulfill obligations under this act except in the following  
 34.5 circumstances:

34.6 (1) a producer may hold an ownership stake in infrastructure used to fulfill obligations  
 34.7 under this act so long as the stake was held prior to enactment of this act and said ownership  
 34.8 stake is fully disclosed by the producer to the producer responsibility organization; or

34.9 (2) if, after a bidding process described in paragraph (a), no service provider bids on the  
 34.10 contract, the producer responsibility organization may make infrastructure investments  
 34.11 identified under an approved stewardship plan to implement the requirements in this act.

34.12 Subd. 4. **Reimbursement rates.** (a) An approved stewardship plan must provide  
 34.13 reimbursement rates for services, collection, transportation, and management of covered  
 34.14 materials, exclusive of exempt materials, and incorporate relevant cost information identified  
 34.15 by the initial needs assessment. Reimbursement rates shall be established equivalent to 50  
 34.16 percent of the cost per ton by July 1, 2027, 75 percent of the cost per ton by July 1, 2028,  
 34.17 and 90 percent of the cost per ton by July 1, 2029, and each year thereafter and varied per  
 34.18 ton, as follows:

34.19 (1) a fixed amount for each ton of covered material collected by a service provider that  
 34.20 reflects conditions that affect collection, recycling, and composting costs in the region or  
 34.21 jurisdiction in which the services are provided, including but not limited to:

34.22 (i) the number and size of households;

34.23 (ii) population density;

34.24 (iii) collections methods employed;

34.25 (iv) public education efforts;

34.26 (v) distance to consolidation or transfer facilities; to reuse, recycling, or composting  
 34.27 facilities; or to responsible markets;

34.28 (vi) other factors that may contribute to regional or jurisdictional cost differences;

34.29 (vii) proportion of covered compostable materials within all source-separated compostable  
 34.30 materials collected or managed through composting; and

34.31 (viii) the general quality of materials recycled or composted by service providers;

35.1 (2) a fixed amount for each ton of covered material recycled or composted by a service  
35.2 provider in the prior calendar year based upon:

35.3 (i) the average costs associated with the transportation and processing from a central  
35.4 location within a political subdivision, of collected covered material from the political  
35.5 subdivision to a recycling or composting facility;

35.6 (ii) the processing of and removal of contamination from covered material by a recycling  
35.7 or composting facility;

35.8 (iii) the recycling or composting of covered materials in the state or in another jurisdiction  
35.9 less the average fair market value for that covered material based on the market indices for  
35.10 the region, updated monthly;

35.11 (iv) costs associated with the management of contaminated materials removed from  
35.12 collected covered material; and

35.13 (v) the proportion of covered compostable materials within all source-separated  
35.14 compostable materials collected or managed through composting;

35.15 (3) an additional fixed amount, in excess of the rate provided under clause (2), for each  
35.16 material type per ton for covered materials that are not included on the lists established  
35.17 according to section 115A.1453, subdivision 1, that are recycled or composted by a service  
35.18 provider in the prior calendar year less the average fair market value for that covered material  
35.19 based on the market indices for the region, updated monthly;

35.20 (4) a fixed amount for mixed recycling tons that are managed through a process that  
35.21 includes percentages of covered materials included on the lists established according to  
35.22 section 115A.1453, subdivision 1, and additional covered materials. The per ton fixed  
35.23 amount shall be prorated for the values in clause (2), items (i) and (ii), based upon the most  
35.24 recent waste characterization for mixed recycling ton averages;

35.25 (5) a fixed amount, based on population served, for administrative costs of service  
35.26 providers, including education, public awareness campaigns, and outreach program costs  
35.27 as applicable; and

35.28 (6) a fixed amount for the cost of managing covered materials capable of refill or reusable  
35.29 covered materials and for the costs associated with collection, cleaning, sanitation,  
35.30 distribution, and management of contamination.

35.31 (b) A service provider may retain all revenue from the sale of covered materials. Nothing  
35.32 in this act restricts a service provider from charging a fee for collection or processing of  
35.33 covered materials to the extent that reimbursement from a producer responsibility

36.1 organization does not cover all costs of services, including operating profits and returns on  
36.2 investments required by a service provider to provide sustainability of the services.

36.3 Subd. 5. **Local government authority.** (a) Nothing in this section shall be construed to  
36.4 require a political subdivision to agree to operate under a stewardship plan, nor does it  
36.5 restrict the authority of a political subdivision to provide waste management services to  
36.6 residents or to contract with any entity to provide waste management services. Any political  
36.7 subdivision that is also a service provider is eligible to be registered with the commissioner  
36.8 and reimbursed per the rates and schedule approved in subdivision 4. If a majority of political  
36.9 subdivisions in the state chooses not to participate in the program by January 1, 2030, the  
36.10 commissioner shall revise the statewide requirements established under section 115A.1451,  
36.11 subdivision 7.

36.12 (b) Nothing in this act restricts the authority of a political subdivision to provide waste  
36.13 management services to residents, to contract with any entity to provide waste management  
36.14 services, or to exercise its authority granted under section 115A.94. A producer responsibility  
36.15 organization may not restrict or otherwise interfere with a political subdivision exercising  
36.16 its authority under section 115A.94 to organize collection of solid waste, including materials  
36.17 collected for recycling or composting, or to extend, renew, or otherwise manage any contracts  
36.18 entered into as a result of exercising such authority or otherwise resulting from a competitive  
36.19 procurement process.

36.20 Subd. 6. **Dispute resolution.** There must be a dispute resolution process for disputes  
36.21 related to reimbursements utilizing third-party mediators.

36.22 Sec. 16. **[115A.1456] REPORTING.**

36.23 Subdivision 1. **Producer responsibility organization annual report.** (a) By July 1,  
36.24 2031, and each July 1 thereafter, a producer responsibility organization must submit a written  
36.25 report to the commissioner that contains, at a minimum, the following information for the  
36.26 previous calendar year:

36.27 (1) the amount of covered materials introduced by each covered materials type, reported  
36.28 in the same units used to establish fees under section 115A.1454, subdivision 1, clause (1);

36.29 (2) progress toward the performance targets reported in the same units used to establish  
36.30 producer fees under section 115A.1454, subdivision 1, clause (1), and reported statewide  
36.31 and for each county including:

36.32 (i) the amount of covered materials successfully waste reduced, reused, recycled, and  
36.33 composted by covered materials type and the strategies or collection method used; and

- 37.1 (ii) information about third-party certifications obtained;
- 37.2 (3) the total cost to implement the program and a detailed description of program
- 37.3 expenditures including:

38.8 Subd. 2. **Report following unmet target.** A producer responsibility organization that

39.2 WEBSITES.

39.3 A producer responsibility organization must maintain a website that uses best practices  
39.4 for accessibility that contains at least:

39.5 (1) information regarding a process that members of the public can use to contact the  
39.6 producer responsibility organization with questions;

39.7 (2) a directory of all service providers operating under the stewardship plan administered  
39.8 by the producer responsibility organization, grouped by location or political subdivision,  
39.9 and information about how to request service;

39.10 (3) registration materials submitted to the commissioner under section 115A.1443;

39.11 (4) the draft and approved stewardship plan and any draft and approved amendments;

39.12 (5) information on how to manage materials included in lists established under section

40.2 A producer responsibility organization that arranges collection, recycling, composting,  
40.3 waste reduction, or reuse services under this act may engage in anticompetitive conduct to  
40.4 the extent necessary to plan and implement collection, recycling, composting, waste  
40.5 reduction, or reuse systems to meet the obligations under this act, and is immune from  
40.6 liability under state laws relating to antitrust, restraint of trade, and unfair trade practices.

40.8 The commissioner may adopt rules to implement this act. The 18-month time limit under  
40.9 section 14.125 does not apply to the commissioner's rulemaking authority under this section.

40.11 Upon request of the commissioner for purposes of determining compliance with this

41.2 (a) The commissioner must enforce this act as provided under this section and sections

41.5 (b) Notwithstanding the penalty limits contained in section 115.071, subdivision 3, and  
41.6 except as otherwise provided in paragraph (c), a person that violates or fails to perform a

41.22 a study of the recycling, composting, and reuse facilities operating in the state. The study  
41.23 must analyze, at a minimum information about:

41.24 (1) working conditions, wage and benefit levels, and employment levels of minorities

42.13 under Minnesota Statutes, section 115A.1455.

42.14 **Sec. 24. COVERED MATERIALS POLLUTION AND CLEANUP STUDY.**

42.15 (a) By January 1, 2032, the commissioner of the Pollution Control Agency, in consultation  
42.16 with the commissioners of health and natural resources, must contract with a third party  
42.17 that is not a producer or a producer responsibility organization to conduct a study to identify  
42.18 the contribution of covered products to litter and water pollution in Minnesota. The report  
42.19 must at a minimum:

42.20 (1) analyze historical and current environmental and human health impacts of littered  
42.21 covered materials and their associated toxic substances in the environment;

42.22 (2) estimate the cost of cleanup and prevention; and

42.23 (3) provide recommendations for how to reduce and mitigate the impacts of litter in the

42.25 (b) The contracted third party must consult with units of local government, the
