Workforce Development 30,231,000 1.7 Appropriations by Fund 1.8 General \$6,239,000 \$5,889,000 1.9 Workforce 1.10 Development \$25,259,000 \$24,342,000 1.11 (a) \$500,000 each year is for the 1.12 1.13 youth-at-work competitive grant program under Minnesota Statutes, section 116L.562. 1.14 1.15 Of this amount, up to five percent is for administration and monitoring of the youth 1.16 workforce development competitive grant 1.17 1.18 program. This requirement includes, but is 2.28 2.29 not limited to, an expansion of programs to provide experience in different crafts to youth 2.30 and young adults throughout the state; 2.31 (2) increase the number of high schools in 2.32 Minnesota offering construction classes during 2.33 the academic year that utilize a multicraft 2.34 curriculum; 2.35

Grants made 4.8 under this section must focus on low-income 4.9 communities, young adults from families with 4.10 a history of intergenerational poverty, and 4.11 communities of color. Of this amount, up to 4 12 four percent is for administration and 4.13 monitoring of the program.
