1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **ENVIRONMENT AND NATURAL RESOURCES TRUST FUND**

1.6 **APPROPRIATION EXTENSIONS.**

1.7 (a) The availability of the appropriations and transfers from the environment and natural

1.8 resources trust fund for the following projects is extended to June 30, 2024:

1.10 paragraph (e), National Loon Center;

1.11 (2) Laws 2021, First Special Session chapter 6, article 5, section 2, subdivision 20,

1.13 (3) Laws 2021, First Special Session chapter 6, article 5, section 2, subdivision 20,

1.14 paragraph (a), clause (2), Wastewater Pond Optimization;

1.15 (4) Laws 2021, First Special Session chapter 6, article 5, section 2, subdivision 20,

1.16 paragraph (a), clause (3), Applied Research in State Mineral and Water Resources;

2.7 (b) Notwithstanding Minnesota Statutes, section 16A.28, or any other law to the contrary,
2.8 the availability of any appropriation or grant of money from the environment and natural
2.9 resources trust fund that would otherwise cancel, lapse, or expire on June 30, 2022, is
2.10 extended to June 30, 2023, if the recipient or grantee does both of the following:

2.11 (1) by May 15, 2022, notifies the Legislative-Citizen Commission on Minnesota
2.12 Resources in the manner specified by the commission that the recipient or grantee intends
2.13 to avail itself of the extension available under this section; and

2.14 (2) modifies the applicable work plan where required by Minnesota Statutes, section
2.15 116P.05, subdivision 2, in accordance with the work plan amendment procedures adopted
2.16 under that section.

2.17 (c) The commission must notify the commissioners of management and budget and
2.18 natural resources of any extension granted under paragraph (b).

2.19 **EFFECTIVE DATE.** This section is effective the day following final enactment.
