 family. Active efforts include reasonable efforts as required by Title IV-E of the Social
 Security Act, United States Code, title 42, sections 670 to 679e are required for all Indian
 child placement proceedings and for all voluntary Indian child placements that involve a
 child-placing agency regardless of whether the reasonable efforts would have been relieved

convincing evidence, including testimony by a qualified expert witness, that custody of the
Indian child by the Indian child's parent or Indian custodian is likely to result in serious
emotional or physical damage to the Indian child.

(c) In no instance shall emergency removal or emergency placement of an Indian child
extend beyond 30 days unless the court finds by a showing of clear and convincing evidence
that: (1) continued emergency removal or placement is necessary to prevent imminent
physical damage or harm to the Indian child; (2) the court has been unable to transfer the
proceeding to the jurisdiction of the Indian child's Tribal court; and (3) it has not been
possible to initiate a child placement proceeding with all of the protections under sections
260.751 to 260.835, including obtaining the testimony of a qualified expert witness.

(2) proceed with the case as if the child is an Indian child until it is determined on the 7.15 record that the child does not meet the definition of Indian child. 7.16

Subd. 2. Notice to Tribes of services or court proceedings involving an Indian 7.17 child. (a) When a child-placing agency or petitioner has information that a family assessment, 7.18 investigation, or noncaregiver sex trafficking assessment being conducted may involve an 7.19 Indian child, the child-placing agency or petitioner shall notify the Indian child's Tribe of 7.20 the family assessment, investigation, or noncaregiver sex trafficking assessment according 7.21 to section 260E.18. The child-placing agency or petitioner shall provide initial notice by 7.22 telephone and by email or facsimile and shall include the child's full name and date of birth; 7.23 the full names and dates of birth of the child's biological parents; and if known the full 7.24 names and dates of birth of the child's grandparents and of the child's Indian custodian. If 7.25 information regarding the child's grandparents or Indian custodian is not immediately 7.26 available, the child-placing agency or petitioner shall continue to request this information 7.27 and shall notify the Tribe when it is received. Notice shall be provided to all Tribes to which 7.28 the child may have any Tribal lineage. The child-placing agency or petitioner shall request 7.29 that the Tribe or a designated Tribal representative participate in evaluating the family 7.30 circumstances, identifying family and Tribal community resources, and developing case 7.31 plans. The child-placing agency or petitioner shall continue to include the Tribe in service 7.32 planning and updates as to the progress of the case. 7.33

(b) When a child-placing agency or petitioner has information that a child receiving 8.1 services may be an Indian child, the child-placing agency or petitioner shall notify the Tribe 8.2 by telephone and by email or facsimile of the child's full name and date of birth, the full 8.3 names and dates of birth of the child's biological parents, and, if known, the full names and 8.4 dates of birth of the child's grandparents and of the child's Indian custodian. This notification 8.5 must be provided for the Tribe to determine if the child is a member or eligible for Tribal 8.6 membership, and the child-placing agency or petitioner must provide this notification to 8.7 the Tribe within seven days of receiving information that the child may be an Indian child. 8.8 If information regarding the child's grandparents or Indian custodian is not available within 8.9 the seven-day period, the child-placing agency or petitioner shall continue to request this 8.10 information and shall notify the Tribe when it is received. (c) In all child placement proceedings, when a court has reason to believe that a child 8.13 placed in emergency protective care is an Indian child, the court administrator or a designee 8.14 shall, as soon as possible and before a hearing takes place, notify the Tribal social services 8.15 agency by telephone and by email or facsimile of the date, time, and location of the 8.16 emergency protective care or other initial hearing. The court shall make efforts to allow 8.17 appearances by telephone or video conference for Tribal representatives, parents, and Indian 8.18 eustodians allow appearances by telephone, video conference, or other electronic medium 8.19 for Tribal representatives, the Indian child's parents, or the Indian custodian. 8.20

(d) In all child placement proceedings, when a court has reason to believe the child is 8.21 an Indian child, the child-placing agency or individual petitioner shall effect service of any 8.22 petition governed by sections 260.751 to 260.835 provide notice of the proceedings and a 8.23 copy of any petition to the Indian child's parents, Indian custodian, and the Indian child's 8.24 Tribe and shall effect service of any notice and petition governed by sections 260.751 to 8.25 260.835 upon the parent, Indian custodian, and the Indian child's Tribe by certified mail or 8.26 registered mail, return receipt requested upon the Indian child's parents, Indian custodian, 8.27 and Indian child's Tribe at least 10 days before the admit-deny hearing is held. (f) (g) A child-placing agency or individual petitioner must provide the notices required 10.1 under this subdivision at the earliest possible time to facilitate involvement of the Indian 10.2 child's Tribe. Nothing in this subdivision is intended to hinder the ability of the child-placing 10.3 agency, individual petitioner, and the court to respond to an emergency situation. Lack of 10.4 participation by a Tribe shall not prevent the Tribe from intervening in services and 10.5 proceedings at a later date. A Tribe may participate in a case at any time. At any stage of 10.6 the child-placing agency's agency or petitioner's involvement with an Indian child, the 10.7 10.8 child-placing agency or petitioner shall provide full cooperation to the Tribal social services agency, including disclosure of all data concerning the Indian child. In an involuntary permanent transfer of legal and physical custody proceeding, permanent custody to the agency proceeding, temporary custody to the agency, or other permanency proceeding, the court must determine by clear and convincing evidence, including testimony of a qualified expert witness, that the continued custody of the Indian child by the Indian child's parent or parents or Indian custodian is likely to result in serious emotional damage or serious physical damage to the <u>Indian</u> child. Qualified expert witness testimony is not required where custody is transferred to the Indian child's parent.

Testimony of a qualified expert witness shall be provided for involuntary foster care
 <u>child</u> placement and permanency proceedings independently.

(b) The child-placing agency, individual petitioner, or any other party shall make diligent
efforts to locate and present to the court a qualified expert witness designated by the Indian
child's Tribe. The qualifications of a qualified expert witness designated by the Indian child's
Tribe are not subject to a challenge in Indian child placement proceedings.

(c) If a party cannot obtain testimony from a Tribally designated qualified expert witness,

260.755 DEFINITIONS.

Subd. 13. Local social services agency. "Local social services agency" means the local agency under the authority of the county welfare or human services board or county board of commissioners which is responsible for human services.
