OFFICIAL STATUS

1.1 A bill for an act
1.2 relating to capital investment; appropriating money for water improvements in the
1.3 city of South Haven; authorizing the sale and issuance of state bonds.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **SOUTH HAVEN; WATER IMPROVEMENTS.**

1.6 Subdivision 1. **Appropriation.** \$3,500,000 is appropriated from the bond proceeds fund
1.7 to the Public Facilities Authority for a grant to the city of South Haven to design, engineer,
1.8 construct, and equip improvements and upgrades to the city's clean drinking water system,
1.9 including the replacement of water mains, service lines, meters, and improvements to lift
1.10 stations and main lift station access road.

1.11 Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond
1.12 proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.13 the state in an amount up to \$3,500,000 in the manner, upon the terms, and with the effect
1.14 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
1.15 Constitution, article XI, sections 4 to 7.

1.16 **EFFECTIVE DATE.** This section is effective the day following final enactment.
