119.1 The request must be made in writing and must be made on a form prescribed by the  
119.2 executive director.

119.3 (c) The cost analysis of the prospective retirement coverage by the statewide  
119.4 retirement plan must be based on the service pension amount under section 353G.11  
119.5 closest to the service pension amount provided by the volunteer firefighters' relief  
119.6 association, if there is one, or to the lowest service pension amount under section 353G.11  
119.7 if there is no volunteer firefighters' relief association, rounded up, and any other service  
119.8 pension amount designated by the requester or requesters. The cost analysis must be  
119.9 prepared using a mathematical procedure certified as accurate by an approved actuary  
119.10 retained by the Public Employees Retirement Association.

119.11 (d) If a cost analysis is requested and a volunteer firefighters' relief association exists  
119.12 that has filed the information required under section 69.051 in a timely fashion, upon  
119.13 request by the executive director, the state auditor shall provide the most recent data  
119.14 available on the financial condition of the volunteer firefighters' relief association, the most  
119.15 recent firefighter demographic data available, and a copy of the current relief association  
119.16 bylaws. If a cost analysis is requested, but no volunteer firefighters' relief association  
119.17 exists, the chief administrative officer of the entity operating the fire department shall  
119.18 provide the demographic information on the volunteer firefighters serving as members  
119.19 of the fire department requested by the executive director.

119.20 (e) If a cost analysis is requested, the executive director of the State Board of  
119.21 Investment shall review the investment portfolio of the relief association, if applicable,

119.24 State Board of Investment. If the prospective retirement coverage change is approved

120.5 **FIREFIGHTERS' RELIEF ASSOCIATION SPECIAL FUND UPON**  
120.6 **RETIREMENT COVERAGE CHANGE.**

120.7       Subdivision 1. **Special fund disestablishment.** (a) On the date immediately prior  
120.8 to the effective date of the coverage change, the special fund of the applicable volunteer  
120.9 firefighters' relief association, if one exists, ceases to exist as a pension fund of the  
120.10 association and legal title to the assets of the special fund transfers to the State Board of  
120.11 Investment, with the beneficial title to the assets of the special fund remaining in the  
120.12 applicable volunteer firefighters.

120.13       (b) If the market value of the special fund of the volunteer firefighters' relief  
120.14 association for which retirement coverage changed under this chapter declines in the

121.20 time service credit for the previous calendar year of each firefighter rendering active  
121.21 service with the fire department.

121.22 (b) The fire chief shall provide to each firefighter rendering active service with

122.20 Sec. 17. **[353G.08] RETIREMENT PLAN FUNDING; DISBURSEMENTS.**

122.21 (a) Annually, the executive director shall determine the funding requirements of  
122.22 each account in the voluntary statewide lump-sum volunteer firefighter retirement plan  
122.23 on or before August 1. The funding requirements as directed under this section, must be  
122.24 determined using a mathematical procedure developed and certified as accurate by an

123.27 (6) If the account has a surplus over full funding, the financial requirement of  
123.28 the account for the following calendar year is the financial requirement of the account  
123.29 calculated as though the account was fully funded under clause (4) and, if the account has  
123.30 also had a surplus over full funding during the prior two years, additionally reduced by an  
123.31 amount equal to one-tenth of the amount of the surplus over full funding of the account.

123.32 (d) The required contribution of the entity or entities associated with the fire  
123.33 department whose active firefighters are covered by the retirement plan is the annual  
123.34 financial requirements of the account of the retirement plan under paragraph (c) reduced  
123.35 by the amount of any fire state aid payable under sections 69.011 to 69.051 reasonably
