

## CHAPTER 67.

AN ACT TO AMEND SECTION ONE (1), CHAPTER FIFTY-TWO (52) OF THE GENERAL STATUTES ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT, (1878). RELATING TO THE ESTATES OF DECEASED PERSONS.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That section one (1) of chapter fifty-two (52), General Statutes one thousand eight hundred and seventy-eight (1878), be amended by adding to the end of said section the following:

Estates of deceased persons

*Provided*, that if no inventory shall be filed the executor or administrator shall pay into the county treasury of the county where administration is had, to reimburse said county, the highest rate specified for such purpose in section eight (8) of chapter seven (7), General Statutes one thousand eight hundred and seventy eight (1878).

SEC. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 68.

AN ACT TO AMEND CHAPTER EIGHT (8) OF THE GENERAL STATUTES OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT, (1878). RELATING TO COUNTIES AND COUNTY OFFICERS.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That section one hundred and forty-two (142) of chapter eight (8) of the General Statutes of one thousand eight hundred and seventy-eight (1878) be amended by adding to the end thereof the following proviso, viz:

Auditor's clerk hire.

*Provided*, that the County Commissioners of Otter Tail county be and they are hereby authorized in their discretion to allow clerk hire for the auditor's clerk in said Otter Tail county in any sum not to exceed one thousand dollars per annum.

SEC. 2. That section one hundred and seventy-two (172) of said chapter eight (8) be amended by adding to the end thereof the following proviso, viz:

*Provided*, that the County Commissioners of Otter Tail county may in their discretion allow the County Treasurer of said Otter Tail county such sum as they shall deem just, not to exceed in any year the sum of three hundred dollars (\$300) for clerk hire and expenses in visiting towns in said county to collect personal property tax.

SEC. 3. This act shall take effect and be in force from and after its passage.

## CHAPTER 69.

AN ACT TO AMEND SECTION TWO (2) OF CHAPTER NINETY-ONE (91), OF THE GENERAL LAWS OF THE YEAR ONE THOUSAND EIGHT HUNDRED AND SEVENTY-FOUR (1874), RELATING TO TERMS OF THE DISTRICT COURT IN THE COUNTY OF ROCK.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That section two (2), of chapter ninety-one (91), of the General Laws of the year one thousand eight hundred and seventy-four (1874) be and the same is hereby amended so as to read as follows:

SEC. 2. General terms of the District Court shall be held in and for the county of Rock on the first (1st) Tuesday of May in each year.

## CHAPTER 70.

AN ACT TO AMEND SECTION FORTY-FOUR (44) OF CHAPTER ONE HUNDRED AND TWENTY (120) OF THE GENERAL STATUTES.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. Section forty-four (44) of chapter one hundred and twenty (120), be, and the same is hereby amended by striking out the word eighteen (18) and inserting in lieu thereof twenty-five (25).
