CHAPTER 83.

AN ACT TO FIX THE TIMES FOR HOLDING THE GENERAL TERMS OF THE DISTRICT COURT IN THE EIGHTH JUEICIAL DISTRICT.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. General terms of the District Court shall be held in the several counties comprising the Eighth Judicial District as follows:

General terms.

In the county of Sibley, on the first (1st) Monday of March and the second (2d) Monday of September in each year.

In the county of Carver, on the first (1st) Monday of April -

and the second (2d) Monday of October in each year.

In the county of McLeod, on the second (2d) Monday of May and the second (2d) Monday of November of each year.

In the county of Le Speur on the fourth (4th) Monday of

In the county of Le Sueur, on the fourth (4th) Monday of May and the fourth (4th) Monday of November of each year.

In the county of Scott, on the second (2d) Monday of June and on the second (2d) Monday of December of each year

year.

SEC. 2. All written process, bonds, continuances, appeals, notices, proceedings and recognizances, issued, made or returnable to the general terms of court in and for said counties, as respectively fixed by law prior to the passage of this act, shall be deemed and construed as made, taken and returnable to the proper term of said court in the said counties respectively, as fixed by this act.

SEC. 3. All acts and parts of acts inconsistent with this

act are hereby repealed.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 84.

AN ACT TO DETACH THE COUNTY OF GRANT FROM THE THE SEVENTH (7TH) JUDICIAL DISTRICT, AND FROM THE COUNTY OF DOUGLAS, FOR JUDICIAL PURPOSES.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That the county of Grant be and the same is hereby detached from the Seventh (7th) Judicial District, and from the county of Douglas, for judicial purposes, and that the

said county of Grant form a part and parcel of the Twelfth (12th) Judicial District and be attached to the county of

Stevens for judicial purposes.

SEC. 2. At the time of giving notice of the next general election, in said Grant county, it shall be the duty of the several officers in said county required by law to give such notice, in like manner to provide that at said election the question will be submitted to the electors of said county as to whether this law shall be adopted.

Giving notice

SEC. 3. At said election the electors of said county of Grant in favor of the adoption of this law shall have distinct—shall read ly written or printed, or partly written and partly printed in their ballots, "For change of Judicial District." Those opposed to such adoption the words "Against change of Judicial District." Such votes shall be received and canvassed at the same time and in the same manner and returned to the same officers by the judges of election as votes for county officers.

Sec. 4. The county canvassing board of said Grant county to whom the returns of election are made shall canvass the returns upon said question in the same manner and at the same time as returns for county officers, and the abstracts thereof shall be made out on one sheet and signed and certified in the same manner as in the case of abstracts of votes for said officers, and shall be deposited in the office of the county auditor of said Grant county immediately thereafter, and copies thereof duly certified by said auditor forwarded by him to the Secretary of State, and the Governor shall thereupon, if this law is adopted, make proclamation to that effect in such manner as he may deem advisable.

Sec. 5. This act shall take effect and be in force from and after the proclamation of the Governor of the adoption thereof by said Grant county as provided in section four (4) of this act, and the balance thereof from and after its passage.

AN ACT TO DETACH THE COUNTY OF LINCOLN FROM THE COUNTY OF LYON, AND TO ORGANIZE THE SAME FOR JUDI-CIAL PURPOSES. AND TO PROVIDE FOR A GENERAL TERM OF THE DISTRICT COURT THEREIN.
