

CHAPTER 128.

AN ACT to amend section one (1) of chapter three hundred and thirty (330) of the Special Laws of eighteen hundred and seventy-nine (1879), relating to compensation of county officers.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. Section one (1) of chapter three hundred and thirty (330) of the Special Laws of one thousand eight hundred and seventy-nine (1879), is hereby amended by adding to the end thereof, the following words, to-wit: *Provided further*, that no county officer of the county of Meeker shall be allowed or paid out of the county treasury of said county, any sum as clerk hire until the officer in whose favor such allowance is to be made, has made and filed with the county auditor of said county a true and correct itemized statement of the amount paid by such officer as and for clerk hire for three (3) months immediately preceding the date of such allowance, such statement to be subscribed and verified by the oath of such officer and of the clerk or person who receives such allowance, and any county commissioner making or ordering any allowance for clerk hire contrary to the provisions of this act shall be deemed guilty of malfeasance in office, and may be removed from office for such malfeasance or may be punished for such malfeasance by both fine, not exceeding twenty (20) dollars, or by imprisonment not exceeding ninety (90) days, or both such fine and imprisonment in the discretion of any court of competent jurisdiction.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 129.

AN ACT to amend section three (3) of chapter two hundred and eleven (211) of the Special Laws of one thousand eight hundred and seventy-eight (1878).

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section three (3) of chapter two hundred and eleven (211) of the Special Laws of one thousand eight hundred

and seventy-eight (1878), as the same is amended by section one (1) of chapter two hundred and seventy (270) of the Special Laws of one thousand eight hundred and seventy-nine (1879,) be so amended as to read as follows:

Sec. 1. That section three (3) of chapter two hundred and eleven (211) of the Special Laws of one thousand eight hundred and seventy-eight (1878), be and the same is hereby amended by inserting after the last word in said section the following provision, to-wit: *Provided, further*, that nothing herein contained shall apply to the townships of Camp Lake and Kirkhoven in said county of Swift.

SEC. 2. This act shall be in force from and after its passage.

CHAPTER 130.

AN ACT to amend section seven (7) of an act entitled an "act to regulate the salary, compensation and fees of the county officers of the county of Houston," approved March fourth (4th), eighteen hundred and seventy-nine (1879).

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section seven (7) of an act entitled "an act to regulate the salary, compensation and fees of the county officers of the county of Houston," approved March fourth (4th), A. D. eighteen hundred and seventy-nine (1879) be, and the same is hereby amended so as to read as follows:

Sec. 7. The superintendent of schools shall receive the compensation and allowances provided for county superintendents of schools by the General Laws of the State.

SEC. 2. The compensation and allowances provided for in section one (1) of this act for the superintendent of schools shall be computed from the first (1st) day of January, eighteen hundred and eighty-one (1881), and the county auditor of said county is hereby authorized and required to draw his warrants upon the county treasurer of said county in accordance with the provisions of this act.

SEC. 3. This act shall take effect and be in force from and after its passage.
