

ever such suit or proceedings shall be commenced, it shall be the duty of the clerk to forthwith notify the president of the board, and at the next meeting of the board thereafter, he shall communicate all information he may have in relation to such suit or proceeding.

SEC. 16. In all cases where, by the General School Laws of this State, special notice of the object of a school meeting is required, like notice shall be given under this act.

SEC. 17. All acts or parts of acts contained in the charter of the village of Cannon Falls, or elsewhere, inconsistent with this act, are, so far as they affect said school district, hereby repealed.

SEC. 18. This act shall be deemed a public act, and shall take effect and be in force from and after its passage.

CHAPTER 171.

AN ACT to create a special school district in Sibley county, to be known as number one (1) and located in Sibley county on the southwest quarter of section twenty-three (23) in township one hundred and fourteen (114), range twenty-five (25) in the township of Faxon.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That a special school district to be known as number one (1), and located in Sibley county on the southwest quarter ($\frac{1}{4}$) of section twenty-three (23) in township one hundred and fourteen (114) range twenty-five (25) in the township of Faxon, and to comprise within its limits for taxation purposes the following real estate lying and being in the counties of Carver and Sibley, to-wit: The southwest quarter ($\frac{1}{4}$) of section twenty-three (23) town one hundred and fourteen (114), range twenty-five (25), west half ($\frac{1}{2}$) of southeast quarter ($\frac{1}{4}$) section twenty-two (22) and southwest quarter ($\frac{1}{4}$) section twenty-four (24) and west half ($\frac{1}{2}$) of northeast quarter ($\frac{1}{4}$) and north half ($\frac{1}{2}$) southwest quarter ($\frac{1}{4}$) section twenty-five (25) southeast quarter ($\frac{1}{4}$) northeast quarter ($\frac{1}{4}$) northwest quarter ($\frac{1}{4}$) northeast quarter ($\frac{1}{4}$) southwest quarter ($\frac{1}{4}$) northeast quarter ($\frac{1}{4}$) northeast quarter ($\frac{1}{4}$) of northeast quarter ($\frac{1}{4}$) and northeast quarter of southeast quarter ($\frac{1}{4}$) section twenty-four (24) and west half ($\frac{1}{2}$) of northwest quarter ($\frac{1}{4}$) northwest quarter ($\frac{1}{4}$), of northwest quarter ($\frac{1}{4}$) section twenty-four (24) and east quarter ($\frac{1}{4}$) of northeast quarter ($\frac{1}{4}$), section twenty-four (24) all in town one hundred and fourteen (114) range twenty-five (25).

Also in town of Faxon, Sibley county, west half ($\frac{1}{2}$) southwest quarter ($\frac{1}{4}$) section eighteen (18) and north half ($\frac{1}{2}$) northwest quarter ($\frac{1}{4}$), section thirty (30) town of Hancock one hundred and fourteen (114), Carver county, range twenty-four (24), the west half ($\frac{1}{2}$) southeast quarter ($\frac{1}{4}$) and southeast of southeast section twenty-four (24), east half ($\frac{1}{2}$) of northeast quarter ($\frac{1}{4}$) and northeast quarter ($\frac{1}{4}$) of southeast, section twenty-five (25) and southeast of northwest quarter ($\frac{1}{4}$), section thirty-six (36) in Faxon township one hundred and fourteen (114) range twenty-five (25), the southeast quarter ($\frac{1}{4}$), section twenty-seven (27) northeast quarter ($\frac{1}{4}$) section twenty-two (22) and southwest quarter ($\frac{1}{4}$) northeast lot number three (3) containing twenty-three (23), section thirty-four (34) and east twenty-five (25) acres of northwest of northeast quarter ($\frac{1}{4}$) section thirty-four (34) northwest quarter ($\frac{1}{4}$) southeast quarter ($\frac{1}{4}$) and northeast quarter ($\frac{1}{4}$) of section twenty-three (23) northwest quarter ($\frac{1}{4}$) and northeast quarter ($\frac{1}{4}$) section twenty-six (26), in town one hundred and fourteen (114) of Faxon, range twenty-five (25), Sibley county; the northwest quarter ($\frac{1}{4}$) section nineteen (19), northeast quarter ($\frac{1}{4}$) and north half ($\frac{1}{2}$) of southeast quarter ($\frac{1}{4}$) section nineteen (19) town one hundred and fourteen (114) Hancock, Carver county range twenty-four (24); the northwest quarter ($\frac{1}{4}$) of northeast lots two (2), three (3) and four (4), containing one hundred and fifty-seven (157) acres in section thirty-one (31) and west half ($\frac{1}{2}$) of southwest quarter ($\frac{1}{4}$), section thirty (30), east half ($\frac{1}{2}$) of southwest quarter ($\frac{1}{4}$), section thirty (30) in town one hundred and fourteen (114), Hancock, Carver county, range twenty-four (24); the east half ($\frac{1}{2}$) of southwest quarter ($\frac{1}{4}$) south half ($\frac{1}{2}$) of southeast quarter ($\frac{1}{4}$), section sixteen (16); all section fifteen (15) except one hundred and twenty (120) acres; the north and south half ($\frac{1}{2}$) of section eleven (11), and south half ($\frac{1}{2}$) of section twelve (12), and all of sections thirteen (13) and fourteen (14), and also sixty (60) acres of the southwest quarter ($\frac{1}{4}$) of northwest quarter ($\frac{1}{4}$), section eighteen (18), all in town one hundred and fourteen (114), (Hancock, Carver county), range twenty-four (24) and twenty-five (25); also east sixty (60) acres of northeast quarter ($\frac{1}{4}$) section twenty-three (23), town one hundred and fourteen (114), range twenty-five (25) in Faxon, Sibley county.

SEC. 2. The aforesaid school district shall elect its officers and have the same powers and privileges as the common schools in this State.

SEC. 3. This act shall take effect and be in force from and after its passage.
