

said road may pass, and if any person feels aggrieved by such appraisalment, he may within thirty (30) days after notice of such appraisalment, by himself or agent, appeal to the district court of the county in which such land is located, in the manner provided for appeals from justices' courts.

*Provided*, that posting in three conspicuous places for a period of thirty (30) days, in each of the counties through which the said road may run, a statement of the damages awarded by said commissioners, or the publication for three weeks of the said statement of damages in any newspaper published in either of the counties through which said road may run, shall be sufficient notice, as required by this act.

SEC. 7. A majority of the commissioners named in this act shall have full authority to act as herein required; and in case a majority of the said commissioners cannot be found to act, then, upon the notification of such fact by either of the said commissioners, the governor of the state may appoint to fill vacancies.

SEC. 8. This act shall take effect and be in force from and after its passage.

## CHAPTER 281.

AN ACT to provide for surveying, locating, opening and establishing a county road in the towns of Rose and New Canada, in Ramsey county.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That Joshua Robinson, John Hardy and Lorenzo Hoyt, of Ramsey county, are hereby appointed commissioners to survey, locate and establish a county road beginning at the west boundary of Ramsey county at the section post of sections eight (8) and seventeen (17), in the town of Rose, in said county, running east on section line between sections eight (8) and seventeen (17), nine (9) and sixteen (16), ten (10) and fifteen (15), eleven (11) and fourteen (14), twelve (12) and thirteen (13), in the town of Rose; thence east between sections seven (7) and eighteen (18), eight (8) and seventeen (17) to the corner section post of sections eight (8) and seventeen (17), nine (9) and sixteen (16), in the town of New Canada; thence north on section line to the quarter (¼) section post of sections eight (8) and nine (9); thence due east to intersect with the White Bear road, running north and south on section nine (9) in the town of New Canada, in said Ramsey county.

SEC. 2. It shall be the duty of said commissioners, and they, or a majority of them, shall have the power to meet at the city of St. Paul, in said county, on the second (2d) Monday of March, one thousand eight hundred and eighty-one (1881), or as soon thereafter as practicable, and proceed to the discharge of their duties under and carry out the provisions and objects of this act.

SEC. 3. The said commissioners are hereby authorized to employ, in discharging their duties under this act, one (1) chainman, one (1) axeman and one (1) surveyor; *provided*, that said commissioners, axeman and chainman shall not receive more than two dollars (\$2) per day, each, nor the surveyor more than five dollars (\$5) per day for such services.

SEC. 4. Any damages sustained and benefits received by the owners of real estate along the line of said road by reason of laying out and opening of said road, shall be assessed and determined by said commissioners, and shall be paid and collected in the manner now provided by law for the assessment and collection of damages and benefits for the laying out and opening of roads, and said damages shall be paid by the townships through which said road runs.

SEC. 5. Said commissioners shall cause an accurate plat and map of the survey and location of said road to be made, which, together with a statement of their appraisal of damages, shall be filed in the office of the county auditor in Ramsey county, and thereupon the establishment of said road shall be deemed complete, and the supervisors of the several towns through which said road shall pass shall cause to be opened and worked so much of said road as there lies in their respective towns upon being notified by the county auditor aforesaid of said county that such plat has been filed as above prescribed.

SEC. 6. The expenses of surveying, locating and establishing said road shall be paid by the county of Ramsey aforesaid.

SEC. 7. This act shall take effect and be in force from and after its passage.
