

an German Mutual Fire Insurance Company, its officers and agents, not inconsistent with its articles of incorporation and the General Laws of this State relating to the organization of town insurance companies, are hereby legalized and made valid as the corporate acts of said company.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 332.

AN ACT to legalize and confirm the organization of all organized towns in Redwood county.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the organization of the following named towns in the county of Redwood and State of Minnesota, to wit: Brookville, Morgan, Sherman, Homer, Paxton, Three Lakes, Sundown, Charleston, Willow Lake, New Avon, Redwood Falls, Delhi Swede Forrest, Kentric, Sheridan, Vail, Waterbury, Lamberton, North Hero, Johnsonville, Vesta, Underwood, West Lin, Gates and Springdale be, and the same is, hereby legalized and made valid to all intents and purposes.

SEC. 2. That all the acts and proceedings of the board of county commissioners of said county of Redwood in organizing said towns as now organized, be, and hereby are legalized, made valid and effectual to all intents and purposes, and shall have the same force and effect as if said acts and proceedings had been in all respects in conformity to the provisions of the statutes of the State of Minnesota in such case made and provided.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 333.

AN ACT to change the names of certain persons therein named.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of Lewis Nelson, of the county of Kandiyohi, is hereby changed to Lars A. Rane.

SEC. 2. The name of John A. Carlson of the county of Chisago, is hereby changed to John A. Fornell.

SEC. 3. The name of James Peter Peterson, of the county of Freeborn, is hereby changed to James Philip Valby.

SEC. 4. The name of Ole Peter Peterson, of the county of Freeborn, is hereby changed to Otto Peter Valby.

SEC. 5. The name of Ole M. Hawkinson, of the county of Meeker, is hereby changed to Ole M. Hawkins.

SEC. 6. The name of Amina Sybil Powers, of the county of Mower, is hereby changed to Amina Sybil Dufty, and she is hereby constituted the heir-at-law of Frederick M. Dufty and Levantia Jannette Dufty, his wife, of said county of Mower, and entitled to all the privileges and rights, and subject to all the duties she would be entitled and subject to if she were the child of Frederick M. Dufty and Levantia Jannette Dufty aforesaid.

SEC. 7. The name of Lars Larson Brakken is hereby changed to that of Lars L. Tobiason.

SEC. 8. This act shall take effect on its passage.

CHAPTER 334.

AN ACT changing the name of the town of Chippewa, in Douglas county, to that of Brandon.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of the town of Chippewa, in Douglas county be and the same is hereby changed to that of Brandon.

SEC. 2. This act to take effect and be in force from and after February twenty-eight (28), A. D. one thousand eight hundred and eighty-one (1881).

CHAPTER 335.

AN ACT to change the name of Trenton, in Big Stone county, to Otry.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of the town of Trenton, in Big Stone county, be and the same is hereby changed to that of Otry.

SEC. 2. This act shall take effect and be in force from and after its passage.
