

## CHAPTER 39.

## AN ACT TO INCORPORATE THE VILLAGE OF PIPE STONE, IN PIPE STONE COUNTY.

*Be it enacted by the Legislature of the State of Minnesota :*

SECTION 1. That sections one (1), two (2), eleven (11), twelve (12), thirteen (13) and fourteen (14) of township one hundred and six (106) of range forty-six (46) and sections six (6), seven (7) and eighteen (18) town one hundred and six (106) range forty-five (45) in Pipestone county, Minnesota, is hereby set apart and incorporated as the village of Pipe Stone, under the provisions of chapter one hundred and thirty-nine (139) of the general laws of the State of Minnesota for the year of eighteen hundred and seventy-five (1875) and the amendments thereto.

SEC. 2. That C. H. Bennett, J. H. Nicols and S. L. Bailey, Sr., are hereby designated commissioners to carry out the provisions of section nine (9) of said chapter and the secretary of state is hereby directed to notify said commissioners of the passage of this act.

SEC. 3. That in addition to the general powers conferred by the said chapter, the village council shall have power

*First.* To prescribe such additional duties for the officers of said village as they may by ordinance direct.

*Second.* To prevent the obstruction of public streets and public grounds.

*Third.* To provide for the compensation of the officers of said village.

SEC. 4. That the electors of said village are hereby authorized to elect two (2) justices of the peace for said village whose powers, duties and qualifications shall be the same as provided by chapter one hundred and thirty-nine (139) of the general laws of one thousand eight hundred and seventy-five (1875) and their powers shall be co-extensive with county justices of the peace.

SEC. 5. That said electors shall elect two (2) constables and one (1) assessor. Said assessor to hold his office for one (1) year and the constables to hold their offices for two (2) years.

SEC. 6. That the constables shall carry out the orders of the council and perform all the duties of a village marshal.

SEC. 7. The village council shall have power by ordinance to restrain, regulate, license or prohibit the sale, giving away, disposing of or dealing in spirituous, malt, fermented or vinous liquors within the corporate limits of said village.

*Provided,* That nothing herein contained shall be so construed as to prevent the people of said village from deciding for them-

selves whether license shall or shall not be granted in said village and the village recorder, upon the written request of ten (10) legal voters of said village at least twenty (20) days before any annual village election shall post notices in at least three (3) public places in said village at least ten (10) days before such election that the question of granting license for the sale of spirituous, vinous, fermented or malt liquors shall be submitted to the electors of said village at such election for their approval or rejection.

And all those voting at such election in favor of license shall have printed or written on their tickets: *License, yes*, and those voting against license shall have printed or written on their tickets *License, no*, and if it shall appear that the majority have voted in favor of license then the village council may grant license, but if the majority shall vote against license then the village council shall not grant license.

If at any annual election the question of license is not voted on, then it shall be unlawful for the village council to give a license until it is so voted on.

SEC. 8. All the provisions of chapter one hundred and thirty-nine (139) of the general laws of one thousand eight hundred and seventy-five (1875) and the several acts amendatory thereto shall be in full force and effect in said village except so far as is inconsistent with the provisions of this act.

SEC. 10. This act shall take effect and be in force from and after its passage.

## CHAPTER 40.

AN ACT TO INCORPORATE THE VILLAGE OF RED LAKE FALLS, IN  
POLK COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

### CHAPTER 1.

SECTION 1. That all the territory embraced to-wit: The whole of section sixteen (16), fifteen (15), twenty-one (21), twenty-two (22), west one-half ( $\frac{1}{2}$ ) of section fourteen (14) and west one-half ( $\frac{1}{2}$ ) of section twenty-three (23) and north one-half ( $\frac{1}{2}$ ) of section twenty-seven (27) and northwest one-quarter ( $\frac{1}{4}$ ) of section twenty-six (26), in township one hundred and fifty-[one] (151), of range forty-four (44) shall be known as the village of Red Lake Falls, and shall have the powers generally possessed by corporation at common law, and in
