

the rights and privileges peculiar to said village and be subject to the ordinances thereof.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 60.

AN ACT RELATING TO THE VILLAGE OF DUNDAS IN THE COUNTY OF RICE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section two (2) of chapter thirteen (13) of the special laws of Minnesota for the year eighteen hundred and seventy-nine (1879) be and the same is hereby amended so as to read as follows:

"SEC. 2. The territory included in the following limits and boundaries shall constitute the village of Dundas: The southwest quarter (S. W. $\frac{1}{4}$) of section ten (10) in township one hundred and eleven (111), range twenty (20), the southeast quarter (S. E. $\frac{1}{4}$) of section ten (10), township one hundred and eleven (111), range twenty (20); the southwest quarter (S. W. $\frac{1}{4}$) of section eleven (11), in township one hundred and eleven (111), range twenty (20); the northwest quarter (N. W. $\frac{1}{4}$) of section fourteen (14), and the north half (N. $\frac{1}{2}$) of section fifteen (15) in said township one hundred and eleven (111), and range twenty (20)."

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 61.

AN ACT TO AMEND AN ACT ENTITLED AN ACT, TO INCORPORATE THE VILLAGE OF EXCELSIOR, IN THE COUNTY OF HENNEPIN, AND STATE OF MINNESOTA, BEING CHAPTER FOUR (4) OF THE SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND SEVENTY-SEVEN (1877).

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That chapter four (4) of the special laws of the year one thousand eight hundred and seventy-seven (1877), being an act

to incorporate the village of Excelsior, in the county of Hennepin, and State of Minnesota, be amended by adding thereto the three (3) following sections, viz :

SEC. 8. That the village council shall have power to levy a special tax for road and bridge purposes upon all property within the corporate limits of said village.

Provided, that all property within the corporate limits of said village shall be exempt from any tax for road and bridge purposes levied by the supervisors of the town of Excelsior ; and, *provided further*, that the assessor of the town of Excelsior is hereby made the assessor of the village of Excelsior, and shall perform all duties pertaining to the office of assessor of said village.

SEC. 9. The county auditor shall furnish a separate assessment roll for and keep a separate account with the said village of Excelsior and shall extend upon the tax list for said village all taxes levied by the supervisors of said town of Excelsior (except those levied by them for road and bridge purposes) together with all taxes levied by the council of said village of Excelsior, and shall deliver to the treasurer of said town of Excelsior an order on the county treasurer for all moneys arising from levies made by the supervisors of said town, and shall also deliver to the treasurer of said village an order on the county treasurer for all moneys arising from levies made by the council of said village in accordance with the provisions of paragraph sixty-seven (67) of the general tax law of one thousand eight hundred and seventy-eight (1878).

SEC. 10. The county treasurer of the county of Hennepin is hereby authorized and directed to pay over to the village treasurer of the said village of Excelsior all sums of money now in the possession of the said county treasurer, and all sums that may hereafter be received by said county treasurer, which have been assessed and collected upon the taxable property within the corporate limits of said village of Excelsior, as taxes for road and bridge purposes, and the county auditor of the said county of Hennepin is hereby authorized to give the village treasurer of said village of Excelsior an order upon the county treasurer aforesaid, for the money so assessed and collected upon the taxable property within the corporate limits of said village of Excelsior as taxes for road and bridge purposes.

SEC. 2. This act shall take effect from and after its passage.
