

CHAPTER 45.

AN ACT TO AMEND SECTION SIX (6) OF CHAPTER THIRTY-TWO (32) OF GENERAL STATUTES A. D. ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO OFFICE OF SURVEYOR GENERAL.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section six (6) of chapter thirty-two (32) of General Statutes of A. D. one thousand eight hundred and seventy eight (1878), be and the same is hereby amended by striking out of said section in the seventh line thereof the word "confirmed."

SEC. 2. This act shall take effect from its passage.

CHAPTER 46.

AN ACT TO AMEND CHAPTER THIRTY-SEVEN (37) OF THE GENERAL STATUTES OF A. D. ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT (1878), RELATING TO UNIVERSITY OF MINNESOTA.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section five (5) of chapter thirty-seven (37) of the General Statutes of A. D. one thousand eight hundred and seventy-eight (1878) be amended so as to read as follows:

§ 5. Officers of board—bonds of president and treasurer—The Board of Regents shall elect from the members of the board, a president of the board, and a recording secretary. They shall also elect a treasurer who may or may not be a member of the board. All of said officers shall hold their offices during the pleasure of the board. And the president and treasurer, each before entering upon the duties of his office, shall execute a bond in the penal sum of fifty thousand dollars (\$50,000), with at least two sufficient sureties, to the

State of Minnesota, to be approved by the Governor, conditioned for the faithful and honest performance of the duties of his office according to law, which bonds, when so approved shall be filed in the office of the Secretary of State.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 47.

AN ACT TO FIX THE SALARY OF THE DEPUTY STATE TREASURER.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the salary of the Deputy State Treasurer for the year A. D. one thousand eight hundred and eighty-two (1882), and annually thereafter, shall be eighteen hundred dollars (\$1800).

SEC. 2. That subdivision twenty (20) of section ten (10) of chapter seven (7) of the General Statutes of A. D. one thousand eight hundred and seventy-eight (1878), be and the same is hereby amended by striking out the words "fifteen hundred" and inserting the words "eighteen hundred" in lieu thereof.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 48.

AN ACT TO AUTHORIZE THE DIRECTORS OF THE MINNESOTA INSTITUTE FOR THE DEAF AND DUMB AND BLIND OF PURCHASE CERTAIN LANDS AND APPROPRIATING MONEY THEREFOR.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the Directors of the Minnesota Institute for the Deaf and Dumb and Blind are hereby empowered to purchase certain lands adjoining the grounds of the Deaf and
