

## CHAPTER 11.

AN ACT TO INCORPORATE THE VILLAGE OF SOUTH STILLWATER,  
IN WASHINGTON COUNTY,

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The following described territory in the county of Washington, in this State, to-wit: Commencing on the shore of Lake St. Croix where the centre line of section two (2), town twenty-nine (29), range twenty (20) strikes the west bank of the same; thence running west on the centre line of said section two (2) and section three (3) of said town and range to the centre of said section three (3); thence south on the north and south centre line of said section three (3) to the south line of said section; thence west on the said south line of said section three (3) and on the south line of section four (4) of the said town and range to the north-west corner of the north-east quarter of the north-east quarter of section nine (9), said town and range; thence south to the south-west corner of said north-east quarter of the north-east quarter of section nine (9) aforesaid; thence east on the eighth (8th) section line of sections number nine (9) and ten (10), said town and range, three hundred and twenty (320) rods, to the north-west corner of the south-east quarter of the north-east quarter of said section ten (10); thence south on the north and south eighth (8th) section line of said section ten (10) and section fifteen (15) of the same town and range, to the south-west corner of the north-east quarter of the north-east quarter of said section number fifteen (15); thence east on the south line of said north-east quarter of the north-east quarter of said section fifteen (15) and on the south line of lot number three (3), section fourteen (14) said town and range, to the west shore of said Lake St. Croix, and thence north along the shore of said Lake to the place of beginning, and also jurisdiction over said Lake St. Croix between the north and south lines of said description continued to the east shore of the said lake, be and the same is hereby set apart for incorporation as a village in pursuance of the General Laws of the State of Minnesota, under the name and style of South Stillwater.

In addition to the general powers and authority granted by the General Laws of this State, the members of the village Council, Justices and Constables of said village shall have and possess the powers and authority of Constables at common law within the jurisdiction of said county.

And the village Council is also hereby granted special authority to appoint special Constables whenever occasion may require, and the President thereof shall also have, and authority is hereby expressly granted him, authority to appoint special Constables on emergency when the Council is not in session. All officers so ap-

pointed shall have and possess all the powers above confirmed on members of the Council and Constables.

Said Council may also by ordinance provide for officers other than those provided for by General Laws, and prescribe their duties. All such officers shall be appointed by the President by and with the consent of the Council.

SEC. 2. That B. E. Wings, Ambrose Secrest and Ed. C. Gamm, be and hereby are designated to take the necessary steps and do all things requisite to organize the said village under and in pursuance of the Statute in such cases made and provided.

SEC. 3. This act shall take effect from its passage.

## CHAPTER 12.

### AN ACT TO INCORPORATE THE VILLAGE OF ADRIAN.

*Be it enacted by the Legislature of the State of Minnesota.*

SECTION 1. That the following described territory in the county of Nobles and state of Minnesota, to-wit:

The west half of section eighteen (18), and the northwest quarter of section nineteen (19), all in township one hundred and two (102), range forty-two (42), and the east one half of section thirteen (13), and the north-east quarter of section twenty-four (24), township one hundred and two (102), range forty-three (43), be and the same is hereby set apart constituted and incorporated as the village of Adrian, under and subject to the provisions of chapter one hundred and thirty-nine (139) of the General Laws of one thousand eight hundred and seventy-five (1875); and the inhabitants of said territory shall form and constitute a municipal corporation at common law together with the power granted and conferred by said chapter one hundred and thirty-nine, (139) of the General Laws of one thousand eight hundred and seventy-five (1875) and all acts amendatory thereof and the further power herein granted.

SEC. 2. The village council shall have power:

*First.* To prescribe such additional duties for the officers of said village as they may by ordinance direct.

*Second.* To appoint such additional special officers for said village as may be necessary therefor.

*Third.* To provide for the publication in a newspaper of notices and ordinances.

*Fourth.* To prevent the obstruction of streets and public grounds.
