

under and according to the provisions of the act, entitled: "An act to establish and maintain a system of public schools in the state of Minnesota," approved February 28, A. D. 1877, in relation to condemnation of property.

SEC. 2. That conveyances of property made by said Board of Education, shall be subscribed by the president and secretary thereof and need not be countersigned by the city comptroller of said city or kept on file by him.

SEC. 3. That this act shall take effect and be in force from and after its passage.

### CHAPTER 109.

AN ACT TO AUTHORIZE THE BOARD OF COMMISSIONERS OF THE COUNTY OF HENNEPIN TO PAY THE CLAIM OF MRS. MILTON ROBERTS FOR BOARDING AND TAKING CARE OF WILLIAM J. WALLACE, A POOR SICK PERSON, RESIDENT OF SAID COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The county commissioners of the county of Hennepin are hereby authorized to pay to Mrs. Milton Roberts, out of any money in the treasury of the county not otherwise appropriated, such sum as may be a full compensation, not exceeding the sum of two hundred and forty (\$240) dollars, with interest upon the same at the rate of seven (7) per cent. from the first (1st) day of June, one thousand eight hundred and seventy-nine (1879), until paid; the said sum to be in full satisfaction of, and payment for boarding, medical attendance, and taking care of William J. Wallace, a sick pauper of said county, during the months of March, April and May, in the year A. D., one thousand eight hundred and seventy-nine (1879).

SEC. 2. This act shall take effect and be in force from and after its passage.

### CHAPTER 110.

AN ACT AUTHORIZING THE CITY COUNCIL OF THE CITY OF STILLWATER, TO COVER THE FUNDS TO THE CREDIT OF THE SINKING FUND ACCOUNT, INTO THE CURRENT FUND ACCOUNT.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The city council of the city of Stillwater, in the county of Washington, and State of Minnesota, is hereby authorized and

empowered to take from the sinking fund account, as the same is kept and known in the accounts of said city, all moneys that now are or hereafter may be in the city treasury of said city to the credit of said fund and transfer, and set over said moneys to the credit of the current fund account of said city, and when said moneys are so transferred and set over, the same shall be used, disbursed and paid out as other current funds of said city, to pay the current expenses of said city and the use of said moneys for the purpose aforesaid, as well as any use heretofore made of the moneys heretofore belonging to said sinking fund, is hereby legalized and made valid.

SEC. 2. This act shall take effect and be in force from and after its passage.

### CHAPTER 111.

AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF HENNEPIN COUNTY TO PAY THE CLAIMS OF A. C. AUSTIN, SAMUEL LYDIORD, CHARLES H. WARD AND J. SHAFER FOR SERVICES RENDERED AS MEMBERS OF THE BOARD OF EQUALIZATION FOR THE COUNTY OF HENNEPIN IN THE YEAR ONE THOUSAND EIGHT HUNDRED AND EIGHTY (1880).

*Be it enacted by the Legislature of the State of Minnesota.*

SECTION 1. That the county commissioners of the county of Hennepin be, and they are hereby authorized to pay, out of any money in the county treasury of said county not otherwise appropriated, to A. C. Austin thirty-six dollars and twenty cents (\$36.20), to Samuel Lydiord sixty-three dollars (\$63), to Charles H. Ward forty-nine dollars (\$49), and to J. Shafer thirty-six dollars and twenty cents, (\$36.20 as compensation for services rendered by them in the year one thousand eight hundred and eighty (1880), as members of the board of equalization for said county.

SEC. 2. This act shall take effect and be in force from and after its passage.
