That the west half ( $\frac{1}{2}$ ) of the southwest quarter of the southwest quarter section twenty (20), town one hundred and ten (110), range twenty-six (26) west, be and the same is hereby detached from school district number twenty-seven (27), and that the south half ( $\frac{1}{2}$ ) of the southeast quarter section nineteen (19), town one hundred and ten (110), range twenty-six (26) west, be and the same is hereby detached from school district number thirty-eight (38) and attach all of said detached territory to independent school district number one (1) in Nicollet county.

SEC. 2. This act shall take effect and be in force from and after its passage.

#### CHAPTER 134.

AN ACT TO REPEAL CHAPTER ONE HUNDRED AND FIFTY-TWO (152) OF SPECIAL LAWS OF ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE (1881), CHANGING THE BOUNDARIES OF INDEPENDENT SCHOOL DISTRICT NUMBER TWENTY-EIGHT (28), IN DODGE COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. Chapter one hundred and fifty-two (152), of the special laws of one thousand eight hundred and and eighty-one (1881), being an act to change the boundaries of Independent school district number twenty-eight (28), in Dodge county, is hereby repealed.

SEC. 2. This act shall take effect and be in force from and after its passage.

#### CHAPTER 135.

AN ACT TO DETACH CERTAIN TERRITORY FROM SCHOOL DISTRICT NUMBER SEVENTY-SEVEN (77), AND ATTACH THE SAME TO SCHOOL DISTRICT NUMBER SEVENTY-SIX (76), BOTH OF HENNEPIN COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the south half ( $\frac{1}{2}$ ) of section thirty-five (35), town one hundred and nineteen (119), range twenty-four (24), be detached from school district number seventy-seven (77), in the

county of Hennepin, and that the same be and is hereby attached to school district number seventy-six (76) of said county for school purposes.

SEC. 2. This act shall take effect and be in force from and after its passage.

### CHAPTER 136.

AN ACT TO AUTHORIZE THE BOARD OF COUNTY COMMISSIONERS OF BLUE EARTH COUNTY, TO DETACH CERTAIN TERRITORY FROM JOINT SCHOOL DISTRICT NUMBER SIX (6), IN THE COUNTIES OF BLUE EARTH AND LE SUEUR, AND ATTACH THE SAME TO SCHOOL DISTRICT NUMBER ONE HUNDRED AND THIRTY THREE (133), IN THE COUNTY OF BLUE EARTH.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The board of county commissioners of the county of Blue Earth, are hereby authorized in their discretion to detach the following described territory, viz: The southeast quarter of section number twenty-two (22) and the west half ( $\frac{1}{2}$ ) of the northwest quarter of section twenty-three (23), all in township one hundred and nine (109), of range twenty-five (25), in Blue Earth county, Minnesota, being a part of joint school district number six (6), in Blue Earth and Le Sueur counties, and attach the said territory to school district number one hundred and thirty-three (133), in the said Blue Earth county.

SEC. 2. This act shall take effect and be in force from and after its passage.

### CHAPTER 137.

AN ACT TO DETACH CERTAIN TERRITORY FROM SCHOOL DISTRICT NUMBER FIVE (5), IN WRIGHT COUNTY, AND ATTACH THE SAME TO INDEPENDENT SCHOOL DISTRICT NUMBER SEVEN (7), IN SAID WRIGHT COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. The south half ( $\frac{1}{2}$ ) of the northeast quarter ( $\frac{1}{4}$ ) of section sixteen (16), town number one hundred and twenty-one (121), range twenty-five (25) west, in Wright county, is hereby detached from school district number five (5), and attached to Independent school district number seven (7), in said Wright county.
