

and substantial bridge across the Blue Earth river, at a point where the public highway between the villages of Garden City and Good Thunder crosses said stream in Blue Earth county, the same to be and remain free from toll.

SEC. 2. Said bridge shall be built under the direction of the board of county commissioners of said Blue Earth county, and no part of said appropriation shall be paid out of the state treasury until the completion of the bridge above mentioned.

SEC. 3. T. N. Boynton, E. T. Champlain and Henry Dyer are hereby appointed a committee on the part of the state to view and examine the bridge as soon as completed, and to examine all contracts, vouchers and accounts respecting its construction and the cost thereof, and to ascertain cost of building said bridge and make a report of such cost to the state auditor.

SEC. 4. Any two of said committee may act in the premises, and in case two of said committee cannot be found or refuse to act, it is hereby made the duty of the county auditor of Blue Earth county, upon the request of any one of the county commissioners of said county, to investigate and examine all papers, vouchers and accounts relating to the building of said bridge, and to estimate its value, and report at his earliest convenience all the facts to the state auditor, who shall then have full authority to issue an order or draft in favor of the county treasurer for the amount found to be due for the construction of the required, not exceeding the sum of seven hundred dollars (\$700).

SEC. 5. This act shall take effect and be in force from and after its passage.

## CHAPTER 157.

### AN ACT TO APPROPRIATE MONEY TO BUILD A BRIDGE ACROSS ROCK RIVER IN ROCK COUNTY.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the sum of fifteen hundred dollars (\$1,500), or so much thereof as may be necessary to construct a bridge across Rock river at a point about five hundred and sixty-five (.65) feet north of the quarter line running east and west through section eleven (11), township one hundred and two (102), north of range forty-five (45) west.

SEC. 2. That said bridge shall be built under the direction of the board of county commissioners of said Rock county, and no part of said appropriation shall be paid until said bridge shall be completed and ready for travel. William Jacobson, W. H. Wilson and E. Hadley are hereby made a committee to view said bridge when completed and examine all contracts vouchers and accounts

respecting its construction and the cost thereof and make a report thereof to the state auditor.

SEC. 3. That upon the receipt of said report by the state auditor he shall draw his order in favor of said county of Rock on the state treasurer for any money belonging to the internal improvement fund for the cost of said bridge, not to exceed fifteen hundred (1,500) dollars, and the state treasurer shall pay over to the county treasurer of Rock county upon such order or vouchers, and said money shall be paid out by the county treasurer upon the order of the chairman of the board of county commissioners.

SEC. 4. Said bridge shall be forever free from toll.

SEC. 5. This act shall take effect, and shall be in force from and after its passage.

### CHAPTER 158.

AN ACT TO APPROPRIATE ONE THOUSAND (\$1,000) DOLLARS FOR BUILDING A BRIDGE IN LAC QUI PARLE COUNTY, MINNESOTA.

*Be it enacted by the Legislature of the State of Minnesota:*

SECTION 1. That the sum of five hundred (\$500) dollars or so much thereof as may necessary, is hereby appropriated out of any money in the State treasury belonging to the internal improvement fund, or out of the first money that may come into the treasury belonging to said fund not otherwise appropriated for building a bridge across the Lac qui Parle river, in Lac qui Parle county, Minnesota, near the village of Lac qui Parle.

SEC. 2. That said bridge shall be built under the direction of Charles Halverson, M. C. Chamberlain and C. M. Anderson, and no part of said appropriation shall be paid out of the State treasury until said bridge is complete and ready for travel.

SEC. 3. That the county commissioners of Lac qui Parle county, are hereby appointed a committee on the part of the State to examine all contracts, vouchers and accounts respecting the expenditure of said money, and make report of the same to the State auditor. Any two (2) of said committee shall have power to act in the premises upon receipt of said report by the State auditor, he shall upon demand of said committee draw his warrant upon the State treasurer for the expenditure by the said commission under this act, not to exceed the sum of [five] hundred (\$500) dollars.

SEC. 4. This act shall take effect and be in force from and after its passage.
