SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 192.

AN ACT TO CHANGE THE NAMES OF CERTAIN PERSONS THEREIN NAMED.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the names of Ella Gannon and May Gannon, minors of Mrs. L. Annett Safford, of the town of Lexington, in the county Le Sueur, State of Minnesota, be and the same are hereby changed to that of Ella Safford and May Safford, and are hereby declared the heirs at law of Reuben L. Safford, of said town and county.

SEC. 3. This act shall take effect from and after its passage.

CHAPTER 193.

AN ACT TO CHANGE THE NAME OF JOHN LARSON TO JOHN L. SHERVE.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the name of John Larson, of the town of Rockdell, in the county of Olmsted, is hereby changed to John L. Sherve.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 194.

AN ACT TO PROVIDE FOR AN EXTENSION OF TIME FOR THE PERFORMANCE OF CERTAIN CONDITIONS UPON WHICH CERTAIN BONDS HAVE BEEN VOTED BY THE COUNTY OF TODD, TO AID IN THE CONSTRUCTION OF THE SAUK CENTRE NORTHERN RAILROAD SO CALLED.

WHEREAS, The electors of the county of Todd, under and in pursuance of a statute for such case made and provided, have voted to issue certain bonds of that county to aid in the con-

struction of the "Sauk Centre Northren railroad" so called, upon certain terms and conditions to be performed by the company owning and building such railroad, on or before tue month of July A. D. one thousand eight hundred and eighty-two (1882); Now therefore

Be it enacted by the Legislature of the State of Minnesota :

SECTION. 1. The board of county commissioners of the said county of Todd, is hererby authorized and empowered by resolution adopted at any regular or special meeting of said board, to extend the time for the performance of the conditions upon which the said bonds have been voted to be issued to the railroad company building the said railroad, for the period of one (1) year from the time when said conditions were required to be performed by such vote, and in case such extension of time shall be granted, the performance of said conditions by the said railroad company within such extended period shall be as valid and effectual for the purpose of entitling such [railroad] company to have and receive such bonds as if the same had been performed within the period of time limited by such vote.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 195.

AN ACT FIXING THE CHARGE FOR A LICENSE FOR THE SALE OF SPIRITUOUS, VENOUS AND MALT LIQUORS IN THE VILLAGE OF DASSEL, IN MEEKER COUNTY.

Be it enacted by the Legislature of the State of Minnesota :

SECTION 1. No license for the sale of spirituous, malt or fermented liquors in the village of Dassel, in the county of Meeker, shall be granted for less than fifty dollars nor more than five hundred dollars, in the discretion of the village council.

SEC. 2. This act shall take effect and be in force from and after its passage.
