Sec. 2. All acts and parts of acts inconsistent with this act are hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 216.

AN ACT TO REGULATE THE SALARY, COMPENSATION AND FEES OF THE COUNTY TREASURER, OF THE COUNTY OF LE SUEUR, AND STATE OF MINNESOTA, AND CLERK HIRE OF THE SAME.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The salary of the county treasurer, in the county of Le Sueur, in this state, shall be twelve hundred (\$1200) dollars per annum. All moneys received as fees or percentage in excess of the amount provided for in this act, shall be paid by said officer at the end of each year, into the revenue fund of said county. The salary hereby fixed shall be in full for the same including clerk hire.

Provided, That the board of county commissioners of said county, by a majority vote of all the members thereof, may allow additional compensation as clerk hire not exceeding three hundred.

(\$300) dollars per annum.

SEC. 2. The terms and provisions of this act shall apply to the present term of office of the county treasurer of said county, and the board of county commissioners of said county are hereby authorized and empowered to allow to the present treasurer of said county, such sum as he has paid out for clerk hire, not exceeding the sum of three hundred (\$300) dollars per annum.

SEC. 3. This act shall take effect and be in force from and after

its passage.

CHAPTER 217.

AN ACT EXTENDING THE TIME FOR THE PAYMENT OF TAXES ON REAL AND PERSONAL PROPERTY IN LYON COUNTY.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. That all unpaid seed grain tax, and all unpaid personal property taxes of any and all years, prior to and including the year A.D. one thousand eight hundred and eighty (1880), now due and

unpaid in said Lyon county, be and the time for the payment of the same is hereby extended, subject to the provisions of section

two (2) of this act.

SEC. 2. Before any person shall be entitled to the extension mentioned in section one (1) of this act, he shall make and file with the county treasurer of Lyon county, an affidavit subscribed and sworn to before some officer authorized to administer oaths, specifying the kind of tax or taxes and the amount of the same, and stating his inability to pay said tax or taxes without distress, and shall then elect to have the whole of said amout of tax or taxes extended against his personal property for the year A. D. one thousand eight hundred and eighty-two (1882), or one-half (\frac{1}{2}) of said amount against his real property. (describing such real property) for the year A. D. one thousand eight hundred and eighty-two (1882), and one-half (\frac{1}{2}) against his real property for the year A. D. one thousand eight hundred and eighty-three (1883).

Sec. 3. No costs or penalty shall be added to the original

amount of tax or taxes extended as provided in this act.

Sec. 4. The affidavit mentioned in section two (2) of this act, shall be made and filed with the county treasurer of Lyon county, on or before the first (1st) day of May, one thousand eight hundred and eighty-two (1882); and it is hereby made the duty of the treasurer to file said affidavits with the auditor of Lyon county, on or before the first (1st) day of June, A. D. one thousand eight hundred and eighty-two (1882), and upon the filing of said affidavit the auditor shall extend the said tax or taxes as elected in section two (2) of this act.

SEC. 5. The sale of the forfeited real estate of Lyon county, against which judgment has been entered, is hereby adjourned until the first (1st) day of December A. D. one thousand eight hundred and eighty-two (1882), and any person may redeem from said list prior to that date, any and all real estate contained therein, by paying the amount of the judgment now entered against it without

any additional cost or penalty.

SEC. 6. The auditor shall on the first (1st) day of December, A. D. one thousand eight hundred and eighty-two (1882), proceed to sell all lands in said county which are charged with taxes and against which judgment has been entered, to satisfy said judgment with interest and costs, unless such judgments shall have been paid before that time. *Provided*, That the notice of such sale shall be first duly given as provided for in section eighty-two (82), of chapter eleven (11), of general statutes of one thousand eight hundred and seventy-eight (1878).

SEC. 7. All acts and parts of acts inconsistent with the provis-

ions of this act, are hereby repealed.

Sec. 8. This act shall take effect and be in force from and after its passage.
