

ture. This section shall not be construed to mean that the owner or operator of any such truck cannot carry on his usual accommodation services for his patrons on regular return trips, such as butter, cream, cheese, and other dairy supplies.

Sec. 2. *This act shall become effective on November 15, 1959, for the taxable year of 1960 and all subsequent years.*

CHAPTER 259—H. F. No. 71

An act relating to the payment of special aids for the education of trainable children; amending Minnesota Statutes 1957, Section 131.099.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 131.099, is amended to read:

131.099 District entitled to aid; limitation upon amount. The aids provided for in sections 131.095, 131.096, and 131.097 shall be paid to the district providing the special instruction and service. Foundation program aid shall be paid to the district or unorganized territory of the pupil's residence. The amount of aid for special instruction and services for trainable children authorized in sections 131.095 and 131.096 may not exceed the amount expended for such special instruction and services for trainable children for the year for which the aid is paid.

CHAPTER 260—H. F. No. 120

[Coded]

An act relating to wild animals; regulating the use and possession of crossbows for hunting purposes; amending Minnesota Statutes 1957, Section 100.29 by adding a Subdivision.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 100.29, is amended by adding a subdivision to read:

[Subd. 26] *Except as expressly permitted by the com-*

missioner, it is unlawful to take any species of protected quadrupeds or birds with a crossbow, or to have a crossbow in possession out of doors or in a motor vehicle in any territory which is open at the time for taking any such quadrupeds or birds, or in any territory where there is an open season for taking deer with firearms for ten days preceding and five days succeeding such season, unless the crossbow is unstrung and contained in a case or in the trunk of a motor vehicle with the door closed.

CHAPTER 261—H. F. No. 312

An act relating to purchase of supplies and equipment by counties, towns, boroughs, villages, school districts, and cities; amending Minnesota Statutes 1957, Sections 471.35, 471.36 and 471.37; repealing Minnesota Statutes 1957, Section 471.34.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 471.35, is amended to read:

471.35 Specifications of supplies or equipment. *When any county, city, village, borough, or town, calls for bids for the purchase of supplies or equipment, specifications shall not be so prepared as to exclude all but one type or kind but shall include competitive supplies and equipment.*

Sec. 2. Minnesota Statutes 1957, Section 471.36 is amended to read:

471.36 Non-competitive supplies and equipment. *The provisions of Sections 471.35 to 471.37 shall not apply to non-competitive types and kinds of supplies and equipment.*

Sec. 3. Minnesota Statutes 1957, Section 471.37 is amended to read:

471.37 Violations. *The violation of any of the provisions of Sections 471.35 to 471.36 shall be a gross misdemeanor.*

Sec. 4. Minnesota Statutes 1957, Section 471.34 is repealed.
