CHAPTER 324—S. F. No. 1085

An act relating to any fire department relief association situated in the City of White Bear Lake; authorizing the payment of certain benefits.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Fire department, relief association.** Any fire department relief association situated in the city of White Bear Lake may pay \$500 in a single sum as an additional retirement benefit to any member of the association who retired prior to January 1, 1959, and who was entitled to and received total retirement benefits of \$100 or less.

Sec. 2. The payment of \$500 to any living retired member as provided in section 1 shall be in lieu of all death benefits that would otherwise be due upon the death of such member.

Sec. 3. Sections 1 to 3 shall be effective upon approval by a majority of the members of the White Bear Lake city council.

CHAPTER 325—S. F. No. 1180

An act relating to the salaries of the county commissioners of Anoka County.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **County commissioners' salaries.** In the

county of Anoka the yearly salaries of the members of the board of county commissioners shall be set by said board at a sum not to exceed \$3,600, which sum shall be payable in equal monthly installments.

Sec. 2. This act shall become effective only after its approval by a majority vote of the board of county commissioners of Anoka county.

CHAPTER 326—S. F. No. 1212

An act relating to the salaries of the county commissioners of Olmsted County.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. **County commissioners; salaries.** In the county of Olmsted the yearly salaries of the members of the board of county commissioners shall be set by said board at a sum not to exceed \$3,000, which sum shall be payable in equal monthly installments.

Sec. 2. This act shall become effective only after its approval by a majority vote of the board of county commissioners of Olmsted county.

CHAPTER 327—S. F. No. 1342

An act relating to the Village of Medford in Steele County; legalizing and validating expenditures made for street improvements in 1958.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. **Street improvement expenditures, validating.** All proceedings had and expenditures made by the governing body of the village of Medford in Steele County in 1958 for improving streets in said village without advertising for bids for material and labor are hereby legalized and validated.
