

Be it enacted by the Legislature of the State of Minnesota :

Section 1. **Mankato, easement from state.** The governor and the state auditor of the state of Minnesota are hereby authorized and directed to convey by proper instrument in a form approved by the attorney general a perpetual easement, including the right of access, to the city of Mankato in certain real estate situated in Blue Earth county, Minnesota, described as follows :

A strip of land 60 feet in width, the center line of which is described as follows :

Commencing at the north quarter corner of section 19, T. 108 N., R. 26 W.; thence S. 89° 33' W. 1171.4 ft. along the north line of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said section 19, to the point of beginning;

Thence S. 8° 21' E. 200.8 ft.; thence S. 50° 50' E. 365.2 ft. to a point; thence S. 75° 29' E. 500.48 ft. to a point; thence S. 55° 50' E. 204.8 ft. to a point; thence N. 80° 52' E. 212.2 ft. to the end point in the East line of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said section 19, which is 642.9 ft. south of the north quarter corner of said section 19.

Sec. 2. The conveyance of said easement shall be made to the city of Mankato without any consideration whatever, for the purpose of constructing, maintaining and operating upon said premises sanitary sewer and water mains and appurtenances thereto together with any other incidental or necessary uses arising out of or connected with the purposes aforesaid.

An act authorizing the governor and the state auditor to execute a perpetual easement to the City of Mankato for certain purposes in certain lands in Blue Earth County, Minnesota.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. **Mankato, easement by state.** The governor and the state auditor of the State of Minnesota are hereby authorized and directed to convey by proper instrument in a

form approved by the attorney general a perpetual easement, including the right of access, to the city of Mankato in certain real estate situated in Blue Earth County, Minnesota, described as follows:

That part of the northeast quarter of the northwest quarter ($NE\frac{1}{4}$ $NW\frac{1}{4}$) of section 19, township 108 north, range 26 west, described as follows: From the northeast corner of said northeast quarter of the northwest quarter run westerly along the north line of said section 19 for 859.4 feet; thence deflect to the left at an angle of $90^{\circ} 00'$ for 429.3 feet to the point of beginning of tract to be described; thence continue southerly along the last above described course for 175 feet; thence deflect to the right at an angle of $90^{\circ} 00'$ for 175 feet; thence deflect to the right at an angle of $90^{\circ} 00'$ for 175 feet; thence deflect to the right at an angle of $90^{\circ} 00'$ for 175 feet to the point of beginning.

Sec. 2. The conveyance of said easement shall be made to the City of Mankato without any consideration whatever for the purpose of constructing, maintaining and operating upon said premises a water reservoir, pump house, water tower and appurtenances thereto together with any other incidental or necessary uses arising out of or connected with the purposes aforesaid.

An act relating to a county school tax levy in St. Louis County; amending Laws 1945, Chapter 579, Section 1, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1945, Chapter 579, Section 1, as amended by Laws 1949, Chapter 375, Section 1, as amended by Laws 1951, Chapter 236, Section 1, as amended by Laws 1953, Chapter 249, Section 1, as amended by Laws 1955, Chapter 698, Section 1, as amended by Laws 1957, Chapter 469, Section 1, is amended to read:

Section 1. St. Louis County, school tax levy. The
