An act relating to Rice County; providing for salary and clerk hire for the clerk of district court.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Rice County—clerk of district court, salary. The annual salary of the clerk of district court of Rice county shall be \$3,600, plus the fees accruing to and collected through the office of the clerk. The amount of clerk hire in such office shall be an amount not to exceed \$6,000 annually, and such additional sums as may be allowed by order of the district court.
- Sec. 2. Section 1 shall become effective only after its approval by a majority of the board of county commissioners of Rice county.

CHAPTER 138-H. F. No. 809

An act authorizing the enactment and publication in book form of a legislative code for the City of Duluth.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Duluth legislative code publication. Authority is hereby conferred upon the City of Duluth to provide for the enactment, adoption and publication in book form of a legislative code of and for the City of Duluth, which shall contain a revision and codification of such ordinances of the city as the governing body thereof shall determine by ordinance adopted by a majority of such governing body. The legislative code authorized by this act shall include the charter of the city, and may by reference incorporate such laws as are applicable to the City of Duluth. The governing body of such city may provide for the exclusion from such code of such ordinances which have granted franchises, ordinances relating to the conveyance of lands, and ordinances which are deemed to be temporary in character or purpose. Ordinances excluded from the code shall be appropriately listed and identified by number or by brief abstract of the title thereof; and such list shall be included in the publication of such code.

Exclusion of any ordinance or ordinances shall not be deemed to be an amendment or repeal thereof, unless the intent to amend or repeal is clearly expressed.

- Sec. 2. Upon the enactment, adoption and publication of the legislative code as authorized by this act, the city clerk shall cause to be published in the official newspaper of the City of Duluth notice, once a week for two consecutive weeks, that such code will during regular business hours be available for examination by the public, and the governing body of such city may, by resolution adopted by a majority thereof, determine the price to be paid for each volume purchased for private use.
- Sec. 3. Upon the adoption, enactment and publication of the legislative code as authorized by this act, all courts shall take judicial notice of such code.
- Sec. 4. This act shall become effective only after its approval by a majority of the governing body of the City of Duluth.

An act relating to preference on public contracts; amending Laws of Minnesota 1959, Chapter 47, Section 1, by adding a new subdivision.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Laws of Minnesota 1959, Chapter 47, Section 1 is amended by adding a new subdivision as follows:
- Subd. 3. [16.365] Public contracts. The provisions of Subdivisions 1 and 2 shall not apply to any contract for any project upon which federal funds are available for expenditure.
