

## CHAPTER 161—H. F. No. 1147

[Not Coded]

*An act conveying to the Village of Bayport an easement and all right, title and interest in and to an interceptor sewer constructed therein in Bayport.*

Be it enacted by the Legislature of the State of Minnesota :

**Section 1. State interceptor sewer, transfer to Bayport.**  
Subdivision 1. The State transfers and conveys all its right, title and interest to the Village of Bayport of all easements, facilities, fixtures, material and equipment, being the entire interceptor sewer located on, adjacent to and on each side of a line described as follows :

From the sanitary sewer manhole at the center of North Main Street and Fifth Avenue North proceeding West five (5) feet North of and parallel to the center line of Fifth Avenue North to a point five (5) feet East of the centerline of Second Street; thence continuing North parallel to the center-line of Second Street North to a point in the intersection of Sixth Avenue North and Second Street North; thence Northeasterly to a point on the East right of way line of Second Street North, approximately fifteen (15) feet North of the North right of way line of Sixth Avenue North; thence Northerly along the East right of way line of Second Street North to the point of intersection of the East right of way line of Second Street North extended with the North lot line of Lots 11 and 12, Block 17, Original Town, extended; thence Westerly along said North property line of Lots 11 and 12, Block 17, Original Town, to a point approximately twenty-five (25) feet East of the West right of way line of Trunk Highway No. 95; thence Northerly, parallel to the West right of way line of Trunk Highway No. 95 to a point in the right of way of Eighth Avenue North extended; thence West in the right of way of Eighth Avenue North to a point approximately twenty (20) feet East of the East right of way line of Temporary Trunk Highway No. 95; thence Northwesterly to the Minnesota State Prison metering station, all in Sections Two (2) and Three (3), Township Twenty-nine (29) North, of Range Twenty (20) West, Washington County, Minnesota.

in which the State constructed a sanitary interceptor sewer to

serve the State Penitentiary in order that the Village might maintain its sewer.

Subd. 2. The State conveys to the Village of Bayport all materials, equipment, fixtures and constructed additional treatment facilities at the Village of Bayport sewage treatment plant.

Subd. 3. The conveyance is without consideration.

Subd. 4. An instrument of conveyance thereof may be executed by the Governor and attested by the Secretary of State.

#### CHAPTER 162—S. F. No. 95

*An act relating to state employees retirement fund, amending Minnesota Statutes 1957, Section 352.12, Subdivision 1, and adding new subdivisions thereto, and repealing Section 352.117, Subdivision 3, and Section 352.66, Subdivisions 1 and 2.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 352.12, Subdivision 1, is amended to read:

**352.12 Subdivision 1. Death before termination of service.** *If a member dies before his state service has terminated and neither a survivor benefit nor a reversionary annuity is payable as provided herein, a refundment shall be paid to his beneficiary or, if there be none, to the representative of his estate in an amount equal to his accumulated deductions plus interest thereon to the date of death at the rate of two percent per annum compounded annually. The designated beneficiary or representative of the estate of a member who may have received a disability annuity shall not be entitled to the payment of interest upon any balance remaining to his credit in the fund at the time of death.*

Sec. 2. Minnesota Statutes 1957, Section 352.12, is amended by adding the following new subdivisions:

**352.12 Subd. 5. Death of former member.** *If a former member of the association dies and he has not received an annuity or a retirement allowance, a refundment shall be paid to his designated beneficiary or, if there be none, to the*
