Lot 3 thereof, and the northeast quarter of the northwest quarter and the east half of Section 14, all in township 162 north, range 33 west.

Sec. 2. The lands so dedicated within the limits specified in this act shall be known as the "Lake of the Woods-Zippel Bay Recreation Reserve" to be administered in the same manner as provided for state parks.

## CHAPTER 64-S. F. No. 129

#### [Coded]

An act relating to jails and lockups; prohibiting the introduction of narcotics, intoxicating liquor, beer, and weapons, and providing a penalty therefor.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [641.165] Narcotics, intoxicants, weapons, explosives, forbidden; penalty. Any person who, in any manner, causes the introduction into a jail, lockup or other place of confinement, or upon the grounds thereof, of any natural or synthetic narcotic, or any intoxicating or alcoholic liquor, or malt beverage, regardless of alcoholic content, or any weapon or explosive without the consent of the person in charge of the jail, lockup or place of confinement shall be guilty of a gross misdemeanor.

## CHAPTER 65—S. F. No. 440

#### [Not Coded]

An act authorizing the Governor, upon recommendation of the Commissioner of Conservation, to execute and deliver to Roy Warning a quit claim deed conveying all of the right, title, and interest of the state in and to certain land in Le Sueur county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. State land, deed to Roy Warning. Not-withstanding any other law to the contrary the governor, upon

recommendation of the commissioner of conservation, in the name of and on behalf of the state of Minnesota is hereby authorized to execute and deliver to Roy Warning a quit claim deed for a consideration of \$1 in such form as the attorney general may approve, conveying to him all the right, title, and interest of the state in and to the following described real estate situate in the county of Le Sueur described as follows:

Beginning at a point on the North-South center line of Section Numbered Fourteen (14), of Township Numbered One Hundred Ten (110) North, of Range Numbered Twenty-six (26) West, three hundred ninety-one (391) feet north of the center of said section; thence East six hundred twenty (620) feet; thence North 79° 32′ East six hundred sixty-five (665) feet; thence North 21° 34′ East one hundred seventy (170) feet; thence southwesterly in a straight line one thousand four hundred (1400) feet, more or less, to a point on said north-south center line three hundred ninety-eight (398) feet north of the center of said section; thence south seven (7) feet, to the place of beginning.

# CHAPTER 66—H. F. No. 210

An act relating to highway traffic regulations, amending Minnesota Statutes 1957, Section 169.03.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 169.03, is amended to read as follows:

169.03 Application. The provisions of this chapter applicable to the drivers of vehicles upon the highways shall apply to the drivers of all vehicles owned or operated by the United States, this state, or any county, city, town, district, or any other political subdivision of the state, subject to such specific exemptions as are set forth in this chapter with reference to authorized emergency vehicles.

The driver of any authorized emergency vehicle, when responding to an emergency call, upon approaching a red or stop signal or any stop sign shall slow down as necessary for safety, but may proceed cautiously past such red or stop sign or signal after sounding siren and displaying red lights.
