

Be it enacted by the Legislature of the State of Minnesota :

Section 1. **General obligation bonds.** The village council of the village of Kimball Prairie is hereby authorized to issue and sell general obligation bonds of the village in the amount of not to exceed \$35,000 for the purpose of providing money to pay for improvements in village streets. Such bonds shall mature in such years, bear such rate or rates of interest, and be sold in such manner as the village council shall by resolution determine.

Sec. 2. The proceeds of such bonds shall be used solely to pay for curb, gutter, surfacing, and other improvements in the village streets pursuant to contracts heretofore entered into by the village council and all such contracts are hereby legalized and validated.

Sec. 3. This act shall not apply to or affect any action or appeal now pending in which such bonds shall be called in question.

Sec. 4. This law takes effect when approved by the village council of the village of Kimball Prairie and upon compliance with Laws 1959, Chapter 368.

EXTRA SESSION

CHAPTER 63—S. F. No. 166

An act relating to planning and zoning in Mower County; amending Laws 1959, Chapter 101, Section 2, Subdivision 1.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Laws 1959, Chapter 101, Section 2, Subdivision 1, is amended to read :

Sec. 2. Subdivision 1. **Mower County, planning and zoning.** The county board shall establish a planning commission of from 5 to 15 members appointed by the county board for such terms as the county board shall designate.

The members of the planning commission shall *receive such compensation together with such necessary mileage and expenses in attending meetings while on the business of the commission, as shall be determined by the county board.* The

county shall pay *such compensation and necessary expenses* of the operation of the commission.

Sec. 2. This act is effective only after its approval by majority vote of the county board of Mower county, *and upon compliance with Laws 1959, Chapter 368.*

CHAPTER 64—S. F. No. 82

An act relating to the reimbursement of public officers and employees of the City of Minneapolis for use of privately owned automobiles in the performance of their duties.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. **Minneapolis, use of privately owned automobiles.** The governing body of the city of Minneapolis may determine to pay to any officer or employee as compensation or reimbursement for the use by such officer or employee of his own automobile in the performance of his duties not to exceed ten cents per mile for the first 500 miles in any one month and 7½¢ per mile thereafter.

Sec. 2. This act shall become effective only upon its approval by a majority vote of the governing body of the city of Minneapolis.

CHAPTER 65—S. F. No. 143.

An act authorizing the town of White Bear in Ramsey County to make local improvements as provided by Minnesota Statutes 1957, Chapter 429.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. **White Bear, local improvements.** The town of White Bear, in Ramsey county, may exercise every power
