

**Sec. 14. Application.** Sections 1 to 15 shall not apply and shall have no force or effect upon the county until the requirements and procedure for creation of a sheriff's civil service commission as herein outlined have been complied with.

**Sec. 15. Veterans preference law not affected.** Section 1 to 15 do not exclude or modify the application of Minnesota Statutes, Sections 197.45 and 197.46, known as the Veterans Preference Law.

**Sec. 16.** Sections 1 to 15 shall be effective upon approval by a majority vote of the members of the Board of County Commissioners and upon compliance with Laws 1959, Chapter 368.

Section 1. Laws 1939, Chapter 247, is hereby repealed.

CHAPTER 156—S. F. No. 744

*An act relating to terms of district court in certain counties; amending Minnesota Statutes 1957, Sections 484.22 and 484.23, as amended.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 484.22, as amended by Laws 1959, Chapter 104, Section 1, and Chapter 249, Section 14, are amended to read:

484.22 **Kittson and other counties.** General terms of district court in the counties named in this section shall be held each year at the times herein specified:

**Kittson County:** ~~On the fourth Tuesday in March and the fourth Tuesday in September. On the fourth Tuesday in February and the fourth Tuesday in September.~~

**Mahnomen County:** ~~On the third Tuesday in March and the first Tuesday in October. On the first Tuesday in March and the first Tuesday in October.~~

**Marshall County:** ~~On the fourth Tuesday in February and the first Tuesday in September. On the first Tuesday in February and the first Tuesday in September.~~

**Norman County:** ~~On the third Tuesday in February and the second Tuesday in September. On the second Tuesday in February and the second Tuesday in September.~~

**Pennington County:** ~~On the second Tuesday in May and the third Tuesday in November. On the first Tuesday in April and the first Tuesday in November.~~
