

set forth in its annual budget, in lieu of the levies authorized by any other general or special law for such purposes, the board of county commissioners of Hennepin county upon approval of each annual budget may levy taxes on all the taxable property in the county and park district at a rate not exceeding ~~40~~ .80 mill on the assessed valuation thereof. *To provide funds for the acquisition and betterment of park properities and facilities of the district in accordance with plans filed by it under Minnesota Statutes, Section 398.19, upon request of the board of park district commissioners by a resolution or resolutions regularly adopted by a majority of all members thereof, the board of county commissioners of Hennepin county may by resolution issue and sell general obligation bonds of the county in the manner provided in Minnesota Statutes, Sections 475.60 to 475.753, in an aggregate amount not exceeding \$5,000,000. Taxes for the payment of the principal of and interest on such bonds, shall be assessed and extended upon all taxable property in the county. Such bonds shall not be subject to the limitations of Minnesota Statutes, Sections 475.51 to 475.59, but the maturity years and amounts and interest rates of each series of bonds shall be fixed so that the maximum amount of principal and interest to become due in any year, on the bonds of that series shall not exceed an amount equal to one mill times the assessed value of all taxable property in the county as last finally equalized before the issuance of the new series.*

Sec. 2. *Laws 1963, Chapter 217, Section 2 and Laws 1963, Chapter 883, Sections 3, 4, 5, and 8, are repealed.*

Sec. 3. *This act takes effect when approved by the board of commissioners of the Hennepin county park reserve district and the board of county commissioners of Hennepin county, and upon compliance with Minnesota Statutes, Section 645.021.*

Sec. 6. [3.731] Claims which may be considered; payment. Subdivision 1. In accordance with Minnesota Statutes, Sections 3.66 to 3.84, the commission shall consider claims which, but for some statutory restrictions, inhibitions, or limitations, could be maintained in the courts of the state. No liability is imposed upon the state or any of its agencies by a determination of the commission approving a claim and recommending an award. If the commission recommends an award of \$250 or less to be paid from any account or fund in the state treasury, the department or agency against whom the award is made may pay the claim from any appropriation made to it if funds are available therein for such purpose.

The moneys in such appropriation are hereby reappropriated therefor. A department or agency making such payment shall biennially report to the legislature concerning the same on or before January 15 of each odd numbered year.

Except as provided in Minnesota Statutes, Section 3.78, a claim shall be instituted by the filing of a written notice with the clerk. Each claim shall be considered by not less than four members of the commission. After consideration, if the commission finds that the claim is just and proper, it shall so determine and shall file with the clerk a brief statement of its reasons. A brief statement shall be similarly filed with the clerk as to any claim rejected by the commission. If the determination of the commission is not unanimous, the reasons of each dissenting member of the commission shall be stated. As to an approved claim, the commission shall determine the amount that should be paid to the claimant, and shall itemize this amount as an award, with the reasons therefor, in its statement filed with the clerk. In determining the amount of a claim, interest shall not be allowed unless the claim is based upon a contract which specifically provides for the payment of interest.

CHAPTER 887—S. F. No. 564

[Coded in Part]

An act relating to wild animals; prohibiting the chasing or killing of wild animals with any motor propelled vehicle; amending Minnesota Statutes 1967, Sections 100.26, Subdivision 1; and 100.29, by adding a subdivision.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 100.26, Subdivision 1, is amended to read:

100.26 Wild animals; chasing; motor propelled vehicle.
Subdivision 1. Weasel, wild cat, lynx, wolves, foxes, bears, gophers, porcupines, badgers, and all other quadrupeds for which no closed season or other protection is accorded by chapters 97 to 102, are unprotected animals and may be taken either in the daytime or at night, and in any manner, except with the aid of artificial lights, and possessed, bought, sold or transported in any quantity, provided that for the safety of humans and domestic stock, poison may not be used in the taking thereof, except in the manner authorized by Minnesota Statutes 1961, Sections 18.021 to 18.035, and acts amendatory thereof, and steel traps may not be used in the taking of bear, except when and in the manner prescribed by the commissioner. The taking of bear may be prohibited by order of the commissioner in such areas of the state and during such periods as he may deem necessary. Raccoon are unprotected animals on May 21, 1965, and all of the provisions of this subdivision are applicable to such animals except that they may be taken with the aid of artificial lights in the manner provided by law under section 100.29, subdivision 10. *It shall be unlawful to intentionally drive, chase, run over or kill with any motor propelled vehicle any unprotected animals.*
