

CHAPTER 431—H.F.No. 2120

An act relating to public meetings; authorizing the governing board of a joint vocational technical district to establish meeting sites; amending Minnesota Statutes 1986, section 136C.61, by adding a subdivision.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1986, section 136C.61, is amended by adding a subdivision to read:

Subd. 7. MEETINGS. Notwithstanding any law to the contrary, the joint board may hold meetings at any location convenient to the member districts and the public, whether or not that meeting site is located within the boundaries of a member district. The joint board shall establish and maintain a schedule of the time and place of its meetings and shall give notice of regular and special meetings in the same manner as required for other public bodies.

Sec. 2. EFFECTIVE DATE.

Section 1 is effective July 1, 1988.

CHAPTER 432—H.F.No. 2270

An act relating to natural resources; authorizing a private sale of surplus state property to the Memorial Hospital Association of Cambridge.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. SALE OF STATE PROPERTY TO MEMORIAL HOSPITAL ASSOCIATION.

Notwithstanding Minnesota Statutes 1986, sections 94.09 to 94.16, the commissioner of administration may convey land described in this section to the Memorial Hospital Association, Inc., of Cambridge, Minnesota.

The land described in this section may be sold by private sale for a consideration not less than its appraised value. The conveyance must be in a form approved by the attorney general.

The land that may be sold is vacant property without buildings in Cambridge containing 8.4 acres more or less in Isanti county described as:

"The East 1,098 feet of Lot 31 of Auditor's Subdivision No. 9, Isanti county, Minnesota, as measured at right angles to the east line of said Lot 31. Excepting therefrom that part of said Lot 31 lying easterly of a line drawn parallel with and distant 33 feet west of the southerly projection of the center

line of South Dellwood Street (formerly known as Superior Street), as described in Book 33 of Deeds, pages 389 and 390, on file in the office of the county recorder, Isanti county, Minnesota (as measured at right angles to said southerly projection of the center line of South Dellwood Street). Subject to easements, restrictions, and reservations of record, if any."

The property to be conveyed in this section is surplus property of the Cambridge Regional Human Services Center that is needed by the Memorial Hospital Association, Inc., to construct a limited care facility. The property is adjacent to Memorial Hospital and is required so that the limited care facility can utilize existing services of Memorial Hospital.

Sec. 2. EFFECTIVE DATE.

This act is effective the day following final enactment.

CHAPTER 433—S.F.No. 1607

An act relating to the city of Minneapolis; providing for the appointment, compensation, and liability of certain city employees and contractors; amending Laws 1969, chapter 937, section 1, subdivision 9, as amended, and 9a; Laws 1980, chapter 607, article 15, section 21; and Laws 1987, chapter 55, section 2.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Laws 1969, chapter 937, section 1, subdivision 9, as added by Laws 1982, chapter 491, section 2, and amended by Laws 1983, chapter 220, section 1, and Laws 1986, chapter 473, section 16, is amended to read:

Subd. 9. The city coordinator of the city of Minneapolis may appoint a person to the following positions to perform the duties and services he may direct:

- (a) Purchasing agent;
- (b) Management information services director;
- (c) General manager of auditorium the convention center;
- (d) Manager of operations, the convention center;
- (e) Director of federal programs;
- (~~e~~) (f) Legislative liaison;
- (~~f~~) (g) Director of energy programs;
