

**CHAPTER 379—H.F.No. 2594**

*An act relating to commerce; regulating trade practices; prohibiting contracts from providing an exclusive right to display free newspapers for distribution in any place of public accommodation; proposing coding for new law in Minnesota Statutes, chapter 325E.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

**Section 1. [325E.34] FREE NEWSPAPERS; EXCLUSIVE RIGHT TO DISTRIBUTE PROHIBITED.**

Subdivision 1. DEFINITIONS. For the purposes of this section, the terms in paragraphs (a) and (b) have the meanings given them.

(a) "Newspaper" has the meaning given in section 331A.01, subdivision 5.

(b) "Place of public accommodation" has the meaning given in section 363.01, subdivision 18.

Subd. 2. PROHIBITION. No contract may provide for an exclusive right to display free newspapers for distribution in any place of public accommodation.

**Sec. 2. EFFECTIVE DATE; APPLICABILITY.**

Section 1 is effective the day following final enactment and applies to contracts entered into or renewed on or after that date.

**CHAPTER 380—H.F.No. 2650**

*An act relating to cemeteries; allowing transfer of certain cemetery property to a religious corporation; amending Minnesota Statutes 1988, section 306.02, by adding a subdivision.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1988, section 306.02, is amended by adding a subdivision to read:

Subd. 4. TRANSFER TO RELIGIOUS CORPORATION. A cemetery corporation or association governed by this chapter may transfer cemetery land or property to a religious corporation existing under state laws without any express consideration. Money held by the cemetery corporation or association for maintenance of transferred land containing cemetery burial plots must also

be transferred to the religious corporation to which the land is transferred, and the religious corporation shall use the money for maintenance of the land and plots.

#### CHAPTER 381—H.F.No. 2407

*An act relating to health; changing asbestos containment standards; proposing coding for new law in Minnesota Statutes, chapter 326.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. [326.785] ASBESTOS CONTAINMENT BARRIERS.

Notwithstanding Minnesota Rules, part 7005.1616, subpart 4, item B, subitem (5), containment barriers, in the case of tunnel abatement enclosures, are limited to double critical barriers.

#### CHAPTER 382—S.F.No. 2048

*An act relating to education; clarifying legislative intent concerning corporal punishment; amending Minnesota Statutes 1989 Supplement, section 127.45.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1989 Supplement, section 127.45, is amended to read:

127.45 CORPORAL PUNISHMENT ~~PROHIBITED~~.

Subdivision 1. **DEFINITION.** For the purpose of this section, "corporal punishment" means conduct involving:

- (1) hitting or spanking a person with or without an object; or
- (2) unreasonable physical force that causes bodily harm or substantial emotional harm.
