1.2 relating to cannabis; transferring enforcement of edible cannabinoid products to

1.3 the Office of Cannabis Management; clarifying workplace testing for cannabis;

1.4 making technical changes related to the taxation of cannabis and related products;

1.5 replacing medical cannabis licenses with endorsements; establishing a petition

1.6 process to designate cannabinoids as nonintoxicating or approved for use in

1.7 lower-potency hemp edibles; authorizing lower-potency hemp edibles to contain

1.8 certain artificially derived cannabinoids created in making delta-9

1.9 tetrahydrocannabinol; allowing testing of certain hemp products to be performed

1.10 by labs meeting accreditation standards regardless of licensing status; authorizing

1.11 patients enrolled in the registry program to obtain cannabis flower from registered

1.12 designated caregivers; authorizing registered designated caregivers to cultivate

1.13 cannabis plants on behalf of patients enrolled in the registry program; authorizing

1.14 the Office of Cannabis Management to recall certain cannabis and related products;

1.15 transferring the duties of the medical cannabis program to the Office of Cannabis

1.16 Management on July 1, 2025; authorizing the appointment of deputy directors;

2.18 Section 1. Minnesota Statutes 2023 Supplement, section 3.9224, subdivision 1, is amended

2.20 Subdivision 1. **Definitions.** (a) As used in this section, the following terms have the  
2.21 meanings given.

2.22 (b) "Medical cannabis law" or "medical cannabis program" means the regulatory  
2.23 framework for cultivation, production, distribution, and sale of cannabis to qualifying  
2.24 patients for therapeutic use in the treatment of a qualifying condition.

2.25 (c) "Medical cannabis flower" means cannabis flower approved for sale under the medical  
2.26 cannabis law of a Minnesota Tribal government or under a compact entered into under this  
2.27 section.

2.28 (d) "Medical cannabis product" means a cannabis product approved for sale under the  
2.29 medical cannabis law of a Minnesota Tribal government or under a compact entered into  
2.30 under this section.

2.31 (e) "Medical cannabis business" means a ~~medical cannabis cultivator, processor, or~~  
2.32 ~~retailer~~ business with a medical cannabis endorsement.

2.33 (f) "Medical cannabis industry" means every item, product, person, process, action,  
2.34 business, or other thing or activity related to medical cannabis flower or medical cannabis  
2.35 products and subject to regulation under the law of a Minnesota Tribal government or under  
2.36 a compact entered into under this section.

2.37 (g) "Cannabis product" means any of the following:

2.38 (1) cannabis concentrate;

3.1 (2) a product infused with cannabinoids, whether artificially derived, or extracted or  
3.2 derived from cannabis plants or cannabis flower, including but not limited to  
3.3 tetrahydrocannabinol; or

3.4 (3) any other product that contains cannabis concentrate.

3.22 (j) "Tribally regulated land" means:

3.23 (1) all land held in trust by the United States for the benefit of a Minnesota Tribal  
3.24 government ("trust land");

3.25 (2) all land held by a Minnesota Tribal government in restricted fee status; and

3.26 (3) all land within the exterior boundaries of the reservation of a Minnesota Tribal  
3.27 government that is subject to the civil regulatory jurisdiction of the Tribal government. For

4.11 and provide the majority of the day-to-day physical labor and management of the farm;

4.12 (2) grosses no more than \$250,000 per year from the sale of farm products; and

4.13 (3) has not, and whose spouse has not, at any time had a direct or indirect ownership  
4.14 interest in farmland.

4.15 (c) "Emerging farmer" means a farmer experiencing limited land access or limited market  
4.16 access.

4.17 ~~(e)~~ (d) "Farm down payment" means an initial, partial payment required by a lender or

4.19 (e) "Limited land access" means farming (1) under a lease or other rental arrangement

4.21 farmer is not related to the farmer by blood or marriage, or (2) by renting land from an

4.23 (f) "Limited market access" means the majority of a farmer's annual farm product sales  
4.24 are direct sales to the consumer.

4.27 Subdivision 1. **Definitions.** For the purposes of this section, the following terms have

4.29 (a) "Artificially derived cannabinoid" means a cannabinoid extracted from a hemp plant  
4.30 or hemp plant parts with a chemical makeup that is changed after extraction to create a

5.1 different cannabinoid or other chemical compound by applying a catalyst other than heat  
5.2 or light. Artificially derived cannabinoid includes but is not limited to any  
5.3 tetrahydrocannabinol created from cannabidiol.

5.4 (b) "Batch" means a specific quantity of a specific product containing cannabinoids  
5.5 derived from hemp, including an edible cannabinoid product, that is manufactured at the  
5.6 same time and using the same methods, equipment, and ingredients that is uniform and  
5.7 intended to meet specifications for identity, strength, purity, and composition, and that is  
5.8 manufactured, packaged, and labeled according to a single batch production record executed  
5.9 and documented.

5.10 (c) "Certified hemp" means hemp plants that have been tested and found to meet the  
5.11 requirements of chapter 18K and the rules adopted thereunder.

5.12 ~~(d) "Commissioner" means the commissioner of health.~~

5.13 ~~(e)~~ (d) "Distributor" means a person who sells, arranges a sale, or delivers a product  
5.14 containing cannabinoids derived from hemp, including an edible cannabinoid product, that  
5.15 the person did not manufacture to a retail establishment for sale to consumers. Distributor  
5.16 does not include a common carrier used only to complete delivery to a retailer.

5.17 ~~(f)~~ (e) "Edible cannabinoid product" means any product that is intended to be eaten or  
5.18 consumed as a beverage by humans, contains a cannabinoid in combination with food  
5.19 ingredients, and is not a drug.

5.20 ~~(g)~~ (f) "Hemp" has the meaning given to "industrial hemp" in section 18K.02, subdivision  
5.21 3.

5.22 ~~(h)~~ (g) "Label" has the meaning given in section 151.01, subdivision 18.

5.23 ~~(i)~~ (h) "Labeling" means all labels and other written, printed, or graphic matter that are:

5.24 (1) affixed to the immediate container in which a product regulated under this section  
5.25 is sold;

5.26 (2) provided, in any manner, with the immediate container, including but not limited to  
5.27 outer containers, wrappers, package inserts, brochures, or pamphlets; or

5.28 (3) provided on that portion of a manufacturer's website that is linked by a scannable  
5.29 barcode or matrix barcode.

5.30 ~~(j)~~ (i) "Matrix barcode" means a code that stores data in a two-dimensional array of  
5.31 geometrically shaped dark and light cells capable of being read by the camera on a  
5.32 smartphone or other mobile device.

6.1 ~~(k)~~ (j) "Nonintoxicating cannabinoid" means substances extracted from certified hemp  
6.2 plants that do not produce intoxicating effects when consumed by any route of administration.

6.3 (k) "Office" means the Office of Cannabis Management.

6.4 (l) "Synthetic cannabinoid" means a substance with a similar chemical structure and  
6.5 pharmacological activity to a cannabinoid, but which is not extracted or derived from hemp  
6.6 plants, or hemp plant parts and is instead created or produced by chemical or biochemical  
6.7 synthesis.

6.8 **EFFECTIVE DATE.** This section is effective July 1, 2024.

6.9 Sec. 4. Minnesota Statutes 2023 Supplement, section 151.72, subdivision 2, is amended  
6.10 to read:

6.11 Subd. 2. **Scope.** (a) This section applies to the sale of any product that contains  
6.12 cannabinoids extracted from hemp and that is an edible cannabinoid product or is intended  
6.13 for human or animal consumption by any route of administration.

6.14 (b) This section does not apply to any product dispensed by a registered medical cannabis  
6.15 manufacturer pursuant to sections 152.22 to 152.37.

6.16 (c) The ~~commissioner~~ office must have no authority over food products, as defined in  
6.17 section 34A.01, subdivision 4, that do not contain cannabinoids extracted or derived from  
6.18 hemp.

6.19 **EFFECTIVE DATE.** This section is effective July 1, 2024.

6.20 Sec. 5. Minnesota Statutes 2023 Supplement, section 151.72, subdivision 3, is amended  
6.21 to read:

6.22 Subd. 3. **Sale of cannabinoids derived from hemp.** (a) Notwithstanding any other  
6.23 section of this chapter, a product containing nonintoxicating cannabinoids, including an  
6.24 edible cannabinoid product, may be sold for human or animal consumption only if all of  
6.25 the requirements of this section are met, ~~provided that~~. A product sold for human or animal  
6.26 consumption ~~does~~ must not contain more than 0.3 percent of any tetrahydrocannabinol and  
6.27 an edible cannabinoid product ~~does~~ must not contain an amount of any tetrahydrocannabinol  
6.28 that exceeds the limits established in subdivision 5a, paragraph (f).

6.29 (b) A product containing nonintoxicating cannabinoids, other than an edible cannabinoid  
6.30 product, may be sold for human or animal consumption only if it is intended for application

7.1 externally to a part of the body of a human or animal. Such a product must not be  
7.2 manufactured, marketed, distributed, or intended to be consumed:

7.3 (1) by combustion or vaporization of the product and inhalation of smoke, aerosol, or  
7.4 vapor from the product;

7.5 (2) through chewing, drinking, or swallowing; or

7.6 (3) through injection or application to a mucous membrane or nonintact skin.

7.7 (c) No other substance extracted or otherwise derived from hemp may be sold for human  
7.8 consumption if the substance is intended:

7.9 (1) for external or internal use in the diagnosis, cure, mitigation, treatment, or prevention  
7.10 of disease in humans or other animals; or

7.11 (2) to affect the structure or any function of the bodies of humans or other animals.

7.12 (d) No product containing any cannabinoid or tetrahydrocannabinol extracted or otherwise  
7.13 derived from hemp may be sold to any individual who is under the age of 21.

7.14 (e) Products that meet the requirements of this section are not controlled substances  
7.15 under section 152.02.

7.16 (f) Products may be sold for on-site consumption ~~provided that~~ if all of the following  
7.17 conditions are met:

7.18 (1) the retailer must also hold an on-sale license issued under chapter 340A;

7.19 (2) products, other than products that are intended to be consumed as a beverage, must  
7.20 be served in original packaging, but may be removed from the products' packaging by  
7.21 customers and consumed on site;

7.22 (3) products must not be sold to a customer who the retailer knows or reasonably should  
7.23 know is intoxicated;

7.24 (4) products must not be permitted to be mixed with an alcoholic beverage; and

7.25 (5) products that have been removed from packaging must not be removed from the  
7.26 premises.

7.27 (g) Edible cannabinoid products that are intended to be consumed as a beverage may be  
7.28 served outside of the products' packaging if the information that is required to be contained  
7.29 on the label of an edible cannabinoid product is posted or otherwise displayed by the retailer.

7.30 **EFFECTIVE DATE.** This section is effective July 1, 2024.

8.1 Sec. 6. Minnesota Statutes 2023 Supplement, section 151.72, subdivision 4, is amended  
8.2 to read:

8.3 Subd. 4. **Testing requirements.** (a) A manufacturer of a product regulated under this  
8.4 section must submit representative samples of each batch of the product to an independent,  
8.5 accredited laboratory in order to certify that the product complies with the standards ~~adopted~~  
8.6 ~~by the board on or before July 1, 2023, or the standards adopted by the commissioner~~ office.  
8.7 Testing must be consistent with generally accepted industry standards for herbal and botanical  
8.8 substances, and, at a minimum, the testing must confirm that the product:

8.9 (1) contains the amount or percentage of cannabinoids that is stated on the label of the  
8.10 product;

8.11 (2) does not contain more than trace amounts of any mold, residual solvents or other  
8.12 catalysts, pesticides, fertilizers, or heavy metals; and

8.13 (3) does not contain more than 0.3 percent of any tetrahydrocannabinol.

8.14 (b) A manufacturer of a product regulated under this section must disclose all known  
8.15 information regarding pesticides, fertilizers, solvents, or other foreign materials applied to  
8.16 industrial hemp or added to industrial hemp during any production or processing stages of  
8.17 any batch from which a representative sample has been sent for testing, including any  
8.18 catalysts used to create artificially derived cannabinoids. The disclosure must be made to  
8.19 the laboratory performing testing or sampling and, upon request, to the ~~commissioner~~ office.  
8.20 The disclosure must include all information known to the ~~licensee~~ manufacturer regardless  
8.21 of whether the application or addition was made intentionally or accidentally, or by the  
8.22 manufacturer or any other person.

8.23 (c) Upon the request of the ~~commissioner~~ office, the manufacturer of the product must  
8.24 provide the ~~commissioner~~ office with the results of the testing required in this section.

8.25 (d) The ~~commissioner~~ office may determine that any testing laboratory that does not  
8.26 operate formal management systems under the International Organization for Standardization  
8.27 is not an accredited laboratory and require that a representative sample of a batch of the  
8.28 product be retested by a testing laboratory that meets this requirement.

8.29 (e) Testing of the hemp from which the nonintoxicating cannabinoid was derived, or  
8.30 possession of a certificate of analysis for such hemp, does not meet the testing requirements  
8.31 of this section.

8.32 **EFFECTIVE DATE.** This section is effective July 1, 2024.



9.1 Sec. 7. Minnesota Statutes 2023 Supplement, section 151.72, subdivision 5a, is amended  
9.2 to read:

9.3 Subd. 5a. **Additional requirements for edible cannabinoid products.** (a) In addition  
9.4 to the testing and labeling requirements under subdivisions 4 and 5, an edible cannabinoid  
9.5 must meet the requirements of this subdivision.

9.6 (b) An edible cannabinoid product must not:

9.7 (1) bear the likeness or contain cartoon-like characteristics of a real or fictional person,  
9.8 animal, or fruit that appeals to children;

9.9 (2) be modeled after a brand of products primarily consumed by or marketed to children;

9.10 (3) be made by applying an extracted or concentrated hemp-derived cannabinoid to a  
9.11 commercially available candy or snack food item;

9.12 (4) be substantively similar to a meat food product; poultry food product as defined in  
9.13 section 31A.02, subdivision 10; or a dairy product as defined in section 32D.01, subdivision  
9.14 7;

9.15 (5) contain an ingredient, other than a hemp-derived cannabinoid, that is not approved  
9.16 by the United States Food and Drug Administration for use in food;

9.17 (6) be packaged in a way that resembles the trademarked, characteristic, or  
9.18 product-specialized packaging of any commercially available food product; or

9.19 (7) be packaged in a container that includes a statement, artwork, or design that could  
9.20 reasonably mislead any person to believe that the package contains anything other than an  
9.21 edible cannabinoid product.

9.22 (c) An edible cannabinoid product must be prepackaged in packaging or a container that  
9.23 is child-resistant, tamper-evident, and opaque or placed in packaging or a container that is  
9.24 child-resistant, tamper-evident, and opaque at the final point of sale to a customer. The  
9.25 requirement that packaging be child-resistant does not apply to an edible cannabinoid product  
9.26 that is intended to be consumed as a beverage.

9.27 (d) If an edible cannabinoid product, other than a product that is intended to be consumed  
9.28 as a beverage, is intended for more than a single use or contains multiple servings, each  
9.29 serving must be indicated by scoring, wrapping, or other indicators designating the individual  
9.30 serving size that appear on the edible cannabinoid product.

9.31 (e) A label containing at least the following information must be affixed to the packaging  
9.32 or container of all edible cannabinoid products sold to consumers:

- 10.1 (1) the serving size;
- 10.2 (2) the cannabinoid profile per serving and in total;
- 10.3 (3) a list of ingredients, including identification of any major food allergens declared
- 10.4 by name; and
- 10.5 (4) the following statement: "Keep this product out of reach of children."
- 10.6 (f) An edible cannabinoid product must not contain more than five milligrams of any
- 10.7 tetrahydrocannabinol in a single serving. An edible cannabinoid product, other than a product
- 10.8 that is intended to be consumed as a beverage, may not contain more than a total of 50
- 10.9 milligrams of any tetrahydrocannabinol per package. An edible cannabinoid product that
- 10.10 is intended to be consumed as a beverage may not contain more than two servings per
- 10.11 container.
- 10.12 (g) An edible cannabinoid product may contain delta-8 tetrahydrocannabinol or delta-9
- 10.13 tetrahydrocannabinol that is extracted from hemp plants or hemp plant parts or is an
- 10.14 artificially derived cannabinoid. Edible cannabinoid products are prohibited from containing
- 10.15 any other artificially derived cannabinoid, including but not limited to THC-P, THC-O, and
- 10.16 HHC, unless the ~~commissioner~~ office authorizes use of the artificially derived cannabinoid
- 10.17 in edible cannabinoid products. Edible cannabinoid products are prohibited from containing

(b) Except as provided in paragraph (a), no person, cooperative, or business holding a medical cannabis license may own or operate any other cannabis business or hemp business.

(c) The office by rule may limit the number of medical cannabis business licenses that a person or business may hold.

(d) For purposes of this subdivision, a restriction on the number of licenses or type of license that a business may hold applies to every cooperative member or every director, manager, and general partner of a medical cannabis business.

Subd. 3. **Medical cannabis combination business license.** (a) A person, cooperative, or business holding a medical cannabis combination license is prohibited from owning or operating any other cannabis business or hemp business.

(b) A person or business may only hold one medical cannabis combination license.

(i) an operating plan demonstrating the proposed layout of the facility, including a diagram of ventilation and filtration systems; plans for wastewater and waste disposal for the manufacturing facility; plans for providing electricity, water, and other utilities necessary for the normal operation of the manufacturing facility; and plans for compliance with applicable building code and federal and state environmental and workplace safety requirements;

(ii) all methods of extraction and concentration that the applicant intends to use and the volatile chemicals, if any, that are involved in extraction or concentration;

(iii) if the applicant is seeking an endorsement to manufacture products infused with cannabinoids for consumption by patients enrolled in the registry program, proof of an edible cannabinoid product handler endorsement from the office; and

(iv) evidence that the applicant will comply with the applicable operation requirements for the license being sought;

(3) for medical cannabis retailer license applicants:

(i) a list of every retail license held by the applicant and, if the applicant is a business, every retail license held, either as an individual or as part of another business, by each officer, director, manager, and general partner of the cannabis business;

(ii) an operating plan demonstrating the proposed layout of the facility, including a diagram of ventilation and filtration systems, policies to avoid sales to individuals who are not authorized to receive the distribution of medical cannabis flower or medical cannabinoid products, identification of a restricted area for storage, and plans to prevent the visibility of cannabis flower and cannabinoid products; and

(iii) evidence that the applicant will comply with the applicable operation requirements for the license being sought; or

(4) for medical cannabis combination license applicants:

(i) the information required under clauses (1) to (3); and

(ii) any additional information required under sections 342.30, subdivision 3; 342.31, subdivision 3; and 342.32, subdivision 3.

(c) A medical cannabis cultivator license holder must verify that every batch of medical cannabis flower has passed safety, potency, and consistency testing at a cannabis testing facility approved by the office for the testing of medical cannabis flower before the medical cannabis cultivator may package, label, or sell the medical cannabis flower to any other entity.

(d) A medical cannabis cultivator may exceed the limit of 60,000 square feet of plant canopy if it was legally cultivating medical cannabis with a greater plant canopy as of April 1, 2023.

**342.50 MEDICAL CANNABIS PROCESSORS.**

(a) A medical cannabis processor license, consistent with the specific license endorsement or endorsements, entitles the license holder to:

(1) purchase medical cannabis flower, medical cannabinoid products, hemp plant parts, and hemp concentrate from medical cannabis cultivators and other medical cannabis processors;

(2) purchase hemp plant parts from industrial hemp growers;

(3) make cannabis concentrate from medical cannabis flower;

(4) make hemp concentrate, including hemp concentrate with a delta-9 tetrahydrocannabinol concentration of more than 0.3 percent as measured by weight;

(5) manufacture medical cannabinoid products;

(6) package and label medical cannabinoid products for sale to other medical cannabis processors and to medical cannabis retailers; and

(7) perform other actions approved by the office.

(b) A medical cannabis processor license holder must comply with all requirements of section 342.26, including requirements to obtain specific license endorsements.

(c) A medical cannabis processor license holder must verify that every batch of medical cannabinoid product has passed safety, potency, and consistency testing at a cannabis testing facility approved by the office for the testing of medical cannabinoid products before the medical cannabis processor may package, label, or sell the medical cannabinoid product to any other entity.

Sec. 4. **EDIBLE CANNABINOID PRODUCTS; ENFORCEMENT.**

(a) The Department of Health shall enforce the provisions of Minnesota Statutes, section 151.72, and all rules, orders, stipulation agreements, settlements, compliance agreements, and registrations related to that section adopted or issued by the Office of Medical Cannabis or the Department of Health pursuant to the Health Enforcement Consolidation Act of 1993 contained in Minnesota Statutes, sections 144.989 to 144.993, and the authority to embargo products described in paragraph (b). The commissioner of health may assign enforcement responsibilities to the Office of Medical Cannabis.

(b) Whenever a duly authorized agent of the Department of Health finds or has probable cause to believe that any product is being sold in violation of the provisions of Minnesota Statutes, section 151.72, the agent shall affix thereto an appropriate marking, giving notice that the article is, or is suspected of being in violation of Minnesota Statutes, section 151.72, has been embargoed, and warning that it is unlawful for any person to remove or dispose of the embargoed article by sale or otherwise without permission from the agent or the court. When an agent of the Department of Health has embargoed an article, the Department of Health shall, within 30 days, petition the district court in whose jurisdiction the article is embargoed for an order of condemnation. When an embargoed article is not so found by the agent, the agent shall remove the marking. If the court finds that an embargoed article is being sold in violation of the provisions of Minnesota Statutes, section 151.72, the article shall be destroyed at the expense of the claimant thereof, who shall also pay all court costs and fees, storage, and other proper expenses. If the violation can be corrected by proper labeling or processing of the article, or by filing the proper documents with the court, the court, after the costs, fees, and expenses have been paid and a sufficient bond has been executed, may order that the article be delivered to the claimant for labeling, processing, or filing under supervision of an agent of the board. The expense of the supervision shall be paid by the claimant. The bond shall be returned to the claimant on the representation to the court by the board that the article is no longer in violation of this chapter and that the expenses of supervision have been paid.

(c) The enforcement authority under paragraphs (a) and (b) shall transfer to the Office of Cannabis Management at any such time that the powers and duties of the Department of Health with respect to the medical cannabis program under Minnesota Statutes, sections 152.22 to 152.37, are transferred to the Office of Cannabis Management. The director of the Office of Cannabis Management may assign enforcement responsibilities to the Division of Medical Cannabis.

(d) This section shall expire on March 1, 2025.
