1.25 We, the undersigned conferees for S.F. No. 745 report that we have agreed upon the
1.26 items in dispute and recommend as follows:

1.27 That the House recede from its amendments and that S.F. No. 745 be further
1.28 amended as follows:

1.29 Delete everything after the enacting clause and insert:

1.30 "Section 1. [13.356] PERSONAL CONTACT AND ONLINE ACCOUNT
1.31 INFORMATION.

1.32 (a) The following data on an individual collected, maintained, or received by
1.33 a government entity for notification purposes or as part of a subscription list for an

2.1 entity's electronic periodic publications as requested by the individual are private data
2.2 on individuals:

2.3 (1) telephone number;

2.4 (2) e-mail address; and

2.5 (3) Internet user name, password, Internet protocol address, and any other similar
2.6 data related to the individual's online account or access procedures.

2.7 (b) Section 13.04, subdivision 2, does not apply to data classified under paragraph (a).
2.8 Paragraph (a) does not apply to data submitted by an individual to the Campaign Finance
2.9 Board to meet the legal requirements imposed by chapter 10A, to data submitted for
2.10 purposes of making a public comment, or to data in a state agency's rulemaking e-mail list.

2.11 (c) Data provided under paragraph (a) may only be used for the specific purpose
2.12 for which the individual provided the data.

2.13 **EFFECTIVE DATE.** This section is effective the day following final enactment
2.14 and applies to data collected, maintained, or received before, on, or after that date.

2.15 Sec. 2. Minnesota Statutes 2012, section 13.37, subdivision 1, is amended to read:

2.16 Subdivision 1. **Definitions.** As used in this section, the following terms have the
2.17 meanings given them.

2.18 (a) "Security information" means government data the disclosure of which the
2.19 responsible authority determines would be likely to substantially jeopardize the security of
2.20 information, possessions, individuals or property against theft, tampering, improper use,
2.21 attempted escape, illegal disclosure, trespass, or physical injury. "Security information"
2.22 includes crime prevention block maps and lists of volunteers who participate in community
2.23 crime prevention programs and their home and mailing addresses and₂ telephone numbers,
2.24 e-mail or other digital addresses, Internet communication services accounts information or
2.25 similar accounts information, and global positioning system locations.

2.26 (b) "Trade secret information" means government data, including a formula, pattern,
2.27 compilation, program, device, method, technique or process (1) that was supplied by the
2.28 affected individual or organization, (2) that is the subject of efforts by the individual or
2.29 organization that are reasonable under the circumstances to maintain its secrecy, and (3)
2.30 that derives independent economic value, actual or potential, from not being generally
2.31 known to, and not being readily ascertainable by proper means by, other persons who can
2.32 obtain economic value from its disclosure or use.

2.33 (c) "Labor relations information" means management positions on economic and
2.34 noneconomic items that have not been presented during the collective bargaining process

3.1 or interest arbitration, including information specifically collected or created to prepare
3.2 the management position.

3.3 (d) "Parking space leasing data" means the following government data on an
3.4 applicant for, or lessee of, a parking space: residence address, home telephone number,
3.5 beginning and ending work hours, place of employment, work telephone number, and
3.6 location of the parking space.

3.7 Sec. 3. Minnesota Statutes 2012, section 13.386, subdivision 3, is amended to read:

3.8 Subd. 3. **Collection, storage, use, and dissemination of genetic information.** (a)

3.9 Unless otherwise expressly provided by law, genetic information about an individual:

3.10 (1) may be collected by a government entity, as defined in section 13.02, subdivision
3.11 7a, or any other person only with the written informed consent of the individual;

3.12 (2) may be used only for purposes to which the individual has given written
3.13 informed consent;

3.14 (3) may be stored only for a period of time to which the individual has given written
3.15 informed consent; and

3.16 (4) may be disseminated only:

3.17 (i) with the individual's written informed consent; or

3.18 (ii) if necessary in order to accomplish purposes described by clause (2). A consent
3.19 to disseminate genetic information under item (i) must be signed and dated. Unless
3.20 otherwise provided by law, such a consent is valid for one year or for a lesser period
3.21 specified in the consent.

3.22 (b) Newborn screening activities conducted under sections 144.125 to 144.128 are
3.23 subject to paragraph (a). Other programs and activities governed under section 144.192
3.24 are not subject to paragraph (a).

3.25 **EFFECTIVE DATE.** This section is effective July 1, 2013.

3.26 Sec. 4. Minnesota Statutes 2012, section 13.43, subdivision 2, is amended to read:

3.27 Subd. 2. **Public data.** (a) Except for employees described in subdivision 5 and
3.28 subject to the limitations described in subdivision 5a, the following personnel data on
3.29 current and former employees, volunteers, and independent contractors of a government
3.30 entity is public:

3.31 (1) name; employee identification number, which must not be the employee's Social
3.32 Security number; actual gross salary; salary range; terms and conditions of employment
3.33 relationship; contract fees; actual gross pension; the value and nature of employer paid

4.1 fringe benefits; and the basis for and the amount of any added remuneration, including
4.2 expense reimbursement, in addition to salary;

4.3 (2) job title and bargaining unit; job description; education and training background;
4.4 and previous work experience;

4.5 (3) date of first and last employment;

4.6 (4) the existence and status of any complaints or charges against the employee,
4.7 regardless of whether the complaint or charge resulted in a disciplinary action;

4.8 (5) the final disposition of any disciplinary action together with the specific reasons
4.9 for the action and data documenting the basis of the action, excluding data that would
4.10 identify confidential sources who are employees of the public body;

4.11 (6) the complete terms of any agreement settling any dispute arising out of an
4.12 employment relationship, including a buyout agreement as defined in section 123B.143,
4.13 subdivision 2, paragraph (a); except that the agreement must include specific reasons for
4.14 the agreement if it involves the payment of more than \$10,000 of public money;

4.15 (7) work location; a work telephone number; badge number; work-related continuing
4.16 education; and honors and awards received; and

4.17 (8) payroll time sheets or other comparable data that are only used to account for
4.18 employee's work time for payroll purposes, except to the extent that release of time sheet
4.19 data would reveal the employee's reasons for the use of sick or other medical leave
4.20 or other not public data.

4.21 (b) For purposes of this subdivision, a final disposition occurs when the government
4.22 entity makes its final decision about the disciplinary action, regardless of the possibility of
4.23 any later proceedings or court proceedings. Final disposition includes a resignation by an
4.24 individual when the resignation occurs after the final decision of the government entity,
4.25 or arbitrator. In the case of arbitration proceedings arising under collective bargaining
4.26 agreements, a final disposition occurs at the conclusion of the arbitration proceedings,
4.27 or upon the failure of the employee to elect arbitration within the time provided by the
4.28 collective bargaining agreement. A disciplinary action does not become public data if an
4.29 arbitrator sustains a grievance and reverses all aspects of any disciplinary action.

4.30 (c) The government entity may display a photograph of a current or former employee
4.31 to a prospective witness as part of the government entity's investigation of any complaint
4.32 or charge against the employee.

4.33 (d) A complainant has access to a statement provided by the complainant to a
4.34 government entity in connection with a complaint or charge against an employee.

4.35 (e) Notwithstanding paragraph (a), clause (5), and subject to paragraph (f), upon
4.36 completion of an investigation of a complaint or charge against a public official, or if a

5.1 public official resigns or is terminated from employment while the complaint or charge is
5.2 pending, all data relating to the complaint or charge are public, unless access to the data
5.3 would jeopardize an active investigation or reveal confidential sources. For purposes
5.4 of this paragraph, "public official" means:

5.5 (1) the head of a state agency and deputy and assistant state agency heads;

5.6 (2) members of boards or commissions required by law to be appointed by the
5.7 governor or other elective officers;

5.8 (3) executive or administrative heads of departments, bureaus, divisions, or
5.9 institutions within state government; and

5.10 (4) the following employees:

5.11 (i) the chief administrative officer, or the individual acting in an equivalent position,
5.12 in all political subdivisions;

5.13 (ii) individuals required to be identified by a political subdivision pursuant to section
5.14 471.701;

5.15 (iii) in a city with a population of more than 7,500 or a county with a population
5.16 of more than 5,000, ~~individuals in a management capacity reporting directly to the chief~~
5.17 ~~administrative officer or the individual acting in an equivalent position:~~ managers; chiefs;
5.18 heads or directors of departments, divisions, bureaus, or boards; and any equivalent
5.19 position; and

5.20 (iv) in a school district; business managers; human resource directors; and athletic
5.21 directors whose duties include at least 50 percent of their time spent in administration,
5.22 personnel, supervision, and evaluation; chief financial officers; directors; individuals
5.23 defined as superintendents; and principals; and directors under Minnesota Rules, part
5.24 3512.0100; and in a charter school, individuals employed in comparable positions.

5.25 (f) Data relating to a complaint or charge against an employee identified under
5.26 paragraph (e), clause (4), are public only if:

5.27 (1) the complaint or charge results in disciplinary action or the employee resigns or
5.28 is terminated from employment while the complaint or charge is pending; or

5.29 (2) potential legal claims arising out of the conduct that is the subject of the
5.30 complaint or charge are released as part of a settlement agreement ~~with another person.~~

5.31 This paragraph and paragraph (e) do not authorize the release of data that are made
5.32 not public under other law.

5.33 **EFFECTIVE DATE.** This section is effective the day following final enactment.

5.34 Sec. 5. Minnesota Statutes 2012, section 13.43, subdivision 14, is amended to read:

6.1 Subd. 14. **Maltreatment data.** (a) When a report of alleged maltreatment of a
6.2 student in a school facility, as defined in section 626.556, subdivision 2, paragraph (f), is
6.3 made to the commissioner of education under section 626.556, data that are relevant to a
6.4 report of maltreatment and are collected by the school facility about the person alleged to
6.5 have committed maltreatment must be provided to the commissioner of education upon
6.6 request for purposes of an assessment or investigation of the maltreatment report. Data
6.7 received by the commissioner of education pursuant to these assessments or investigations
6.8 are classified under section 626.556.

6.9 (b) Personnel data may be released for purposes of providing information to a parent,
6.10 legal guardian, or custodian of a child under section 626.556, subdivision 7.

6.11 Sec. 6. Minnesota Statutes 2012, section 13.4965, subdivision 3, is amended to read:

6.12 Subd. 3. **Homestead and other applications.** The classification and disclosure
6.13 of certain information collected to determine eligibility of property for a homestead or
6.14 other classification or benefit are governed by section sections 273.124, subdivision
6.15 subdivisions 13, 13a, 13b, 13c, and 13d; 273.1245; and 273.1315.

6.16 **EFFECTIVE DATE.** This section is effective the day following final enactment.

6.17 Sec. 7. Minnesota Statutes 2012, section 13.64, subdivision 2, is amended to read:

6.18 Subd. 2. **Department of Administration.** (a) Security features of building
6.19 plans, building specifications, and building drawings of state-owned facilities and
6.20 non-state-owned facilities leased by the state are classified as nonpublic data when
6.21 maintained by the Department of Administration and may be shared with anyone as
6.22 needed to perform duties of the commissioner.

6.23 (b) Data maintained by the Department of Administration that identify an individual
6.24 with a disability or a family member of an individual with a disability related to services
6.25 funded by the federal Assistive Technology Act, United States Code, title 29, sections
6.26 3001 to 3007, for assistive technology device demonstrations, transition training, loans,
6.27 reuse, or alternative financing are private data on individuals.

6.28 Sec. 8. Minnesota Statutes 2012, section 13.72, subdivision 10, is amended to read:

6.29 Subd. 10. **Transportation service data.** Personal, medical, financial, familial, or
6.30 locational information data pertaining to applicants for or users of services providing
6.31 transportation for the disabled or elderly, ~~with the exception of the name of the applicant~~
6.32 ~~or user of the service,~~ are private.

7.1 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.2 Sec. 9. Minnesota Statutes 2012, section 13.72, is amended by adding a subdivision to
7.3 read:

7.4 Subd. 19. **Construction manager/general contractor data.** (a) When the
7.5 Department of Transportation undertakes a construction manager/general contractor
7.6 contract, as defined and authorized in sections 161.3207 to 161.3209, the provisions
7.7 of this subdivision apply.

7.8 (b) When the commissioner of transportation solicits a request for qualifications:

7.9 (1) the following data are classified as protected nonpublic:

7.10 (i) the statement of qualifications scoring evaluation manual; and

7.11 (ii) the statement of qualifications evaluations;

7.12 (2) the statement of qualifications submitted by a potential construction
7.13 manager/general contractor is classified as nonpublic data; and

7.14 (3) identifying information concerning the members of the Technical Review
7.15 Committee is classified as private data.

7.16 (c) When the commissioner of transportation announces the short list of qualified
7.17 construction managers/general contractors, the following data become public:

7.18 (1) the statement of qualifications scoring evaluation manual; and

7.19 (2) the statement of qualifications evaluations.

7.20 (d) When the commissioner of transportation solicits a request for proposals:

7.21 (1) the proposal scoring manual is classified as protected nonpublic data; and

7.22 (2) the following data are classified as nonpublic data:

7.23 (i) the proposals submitted by a potential construction manager/general contractor;

7.24 and

7.25 (ii) the proposal evaluations.

7.26 (e) When the commissioner of transportation has completed the ranking of proposals
7.27 and announces the selected construction manager/general contractor, the proposal
7.28 evaluation score or rank and proposal evaluations become public data.

7.29 (f) When the commissioner of transportation conducts contract negotiations
7.30 with a construction manager/general contractor, government data created, collected,
7.31 stored, and maintained during those negotiations are nonpublic data until a construction
7.32 manager/general contractor contract is fully executed.

7.33 (g) When the construction manager/general contractor contract is fully executed or
7.34 when the commissioner of transportation decides to use another contract procurement
7.35 process, other than the construction manager/general contractor authority, authorized

8.1 under section 161.3209, subdivision 3, paragraph (b), all remaining data not already made
8.2 public under this subdivision become public.

8.3 (h) If the commissioner of transportation rejects all responses to a request for
8.4 proposals before a construction manager/general contractor contract is fully executed, all
8.5 data, other than that data made public under this subdivision, retains its classification
8.6 until a resolicitation of the request for proposals results in a fully executed construction
8.7 manager/general contractor contract or a determination is made to abandon the project. If
8.8 a resolicitation of proposals does not occur within one year of the announcement of the
8.9 request for proposals, the remaining data become public.

8.10 Sec. 10. Minnesota Statutes 2012, section 13.72, is amended by adding a subdivision
8.11 to read:

8.12 Subd. 20. **Transit customer data.** (a) Data on applicants, users, and customers
8.13 of public transit collected by or through the Metropolitan Council's personalized Web
8.14 services or the regional fare collection system are private data on individuals. As used in
8.15 this subdivision, the following terms have the meanings given them:

8.16 (1) "regional fare collection system" means the fare collection system created and
8.17 administered by the council that is used for collecting fares or providing fare cards or
8.18 passes for transit services which includes:

8.19 (i) regular route bus service within the metropolitan area and paratransit service,
8.20 whether provided by the council or by other providers of regional transit service;

8.21 (ii) light rail transit service within the metropolitan area;

8.22 (iii) rideshare programs administered by the council;

8.23 (iv) special transportation services provided under section 473.386; and

8.24 (v) commuter rail service;

8.25 (2) "personalized Web services" means services for which transit service applicants,
8.26 users, and customers must establish a user account; and

8.27 (3) "metropolitan area" means the area defined in section 473.121, subdivision 2.

8.28 (b) The council may disseminate data on user and customer transaction history
8.29 and fare card use to government entities, organizations, school districts, educational
8.30 institutions, and employers that subsidize or provide fare cards to their clients, students, or
8.31 employees. "Data on user and customer transaction history and fare card use" means:

8.32 (1) the date a fare card was used;

8.33 (2) the time a fare card was used;

8.34 (3) the mode of travel;

8.35 (4) the type of fare product used; and

9.1 (5) information about the date, time, and type of fare product purchased.
9.2 Government entities, organizations, school districts, educational institutions, and
9.3 employers may use customer transaction history and fare card use data only for purposes
9.4 of measuring and promoting fare card use and evaluating the cost-effectiveness of their
9.5 fare card programs. If a user or customer requests in writing that the council limit the
9.6 disclosure of transaction history and fare card use, the council may disclose only the card
9.7 balance and the date a card was last used.

9.8 (c) The council may disseminate transit service applicant, user, and customer data
9.9 to another government entity to prevent unlawful intrusion into government electronic
9.10 systems, or as otherwise provided by law.

9.11 **EFFECTIVE DATE.** This section is effective the day following final enactment.

9.12 Sec. 11. **[144.192] TREATMENT OF BIOLOGICAL SPECIMENS AND**
9.13 **HEALTH DATA HELD BY THE DEPARTMENT OF HEALTH AND HEALTH**
9.14 **BOARDS.**

9.15 Subdivision 1. **Definitions.** (a) For purposes of this section, the following terms
9.16 have the meanings given.

9.17 (b) "Biological specimen" means tissue, fluids, excretions, or secretions that contain
9.18 human DNA originating from an identifiable individual, either living or deceased.
9.19 Biological specimen does not include infectious agents or chemicals that are isolated from a
9.20 specimen. Nothing in this section or section 13.386 is intended to limit the commissioner's
9.21 ability to collect, use, store, or disseminate such isolated infectious agents or chemicals.

9.22 (c) "Health data" has the meaning given in section 13.3805, subdivision 1, paragraph
9.23 (a), clause (2).

9.24 (d) "Health oversight" means oversight of the health care system for activities
9.25 authorized by law, limited to the following:

9.26 (1) audits;

9.27 (2) civil, administrative, or criminal investigations;

9.28 (3) inspections;

9.29 (4) licensure or disciplinary actions;

9.30 (5) civil, administrative, or criminal proceedings or actions; and

9.31 (6) other activities necessary for appropriate oversight of the health care system and
9.32 persons subject to such governmental regulatory programs for which biological specimens
9.33 or health data are necessary for determining compliance with program standards.

9.34 (e) "Individual" has the meaning given in section 13.02, subdivision 8. In addition,
9.35 for a deceased individual, individual also means the representative of the decedent.

10.1 (f) "Person" has the meaning given in section 13.02, subdivision 10.

10.2 (g) "Program operations" means actions, testing, and procedures directly related to
10.3 the operation of department programs, limited to the following:

10.4 (1) diagnostic and confirmatory testing;

10.5 (2) laboratory quality control assurance and improvement;

10.6 (3) calibration of equipment;

10.7 (4) evaluation and improvement of test accuracy;

10.8 (5) method development and validation;

10.9 (6) compliance with regulatory requirements; and

10.10 (7) continuity of operations to ensure that testing continues in the event of an
10.11 emergency.

10.12 (h) "Public health practice" means actions related to disease, conditions, injuries,
10.13 risk factors, or exposures taken to protect public health, limited to the following:

10.14 (1) monitoring the health status of a population;

10.15 (2) investigating occurrences and outbreaks;

10.16 (3) comparing patterns and trends;

10.17 (4) implementing prevention and control measures;

10.18 (5) conducting program evaluations and making program improvements;

10.19 (6) making recommendations concerning health for a population;

10.20 (7) preventing or controlling known or suspected diseases and injuries; and

10.21 (8) conducting other activities necessary to protect or improve the health of

10.22 individuals and populations for which biological specimens or health data are necessary.

10.23 (i) "Representative of the decedent" has the meaning given in section 13.10,
10.24 subdivision 1, paragraph (c).

10.25 (j) "Research" means activities that are not program operations, public health
10.26 practice, or health oversight and is otherwise defined in Code of Federal Regulations, title
10.27 45, part 46, subpart A, section 46.102(d).

10.28 **Subd. 2. Collection, use, storage, and dissemination.** (a) The commissioner may
10.29 collect, use, store, and disseminate biological specimens and health data, genetic or other,
10.30 as provided in this section and as authorized under any other provision of applicable law,
10.31 including any rules adopted on or before June 30, 2013. Any rules adopted after June 30,
10.32 2013, must be consistent with the requirements of this section.

10.33 (b) The provisions in this section supplement other provisions of law and do not
10.34 supersede or repeal other provisions of law applying to the collection, use, storage, or
10.35 dissemination of biological specimens or health data.

11.1 (c) For purposes of this section, genetic information is limited to biological
11.2 specimens and health data.

11.3 Subd. 3. **Biological specimens and health data for program operations, public**
11.4 **health practice, and health oversight.** (a) The commissioner may collect, use, store, and
11.5 disseminate biological specimens and health data to conduct program operations activities,
11.6 public health practice activities, and health oversight activities. Unless required under
11.7 other applicable law, consent of an individual is not required under this subdivision.

11.8 (b) With the approval of the commissioner, biological specimens may be
11.9 disseminated to establish a diagnosis, to provide treatment, to identify persons at risk of
11.10 illness, or to conduct an epidemiologic investigation to control or prevent the spread of
11.11 serious disease, or to diminish an imminent threat to the public health.

11.12 (c) For purposes of Clinical Laboratory Improvement Amendments proficiency
11.13 testing, the commissioner may disseminate de-identified biological specimens to state
11.14 public health laboratories that agree, pursuant to contract, not to attempt to re-identify
11.15 the biological specimens.

11.16 (d) Health data may be disseminated as provided in section 13.3805, subdivision 1,
11.17 paragraph (b).

11.18 Subd. 4. **Research.** The commissioner may collect, use, store, and disseminate
11.19 biological specimens and health data to conduct research in a manner that is consistent
11.20 with the federal common rule for the protection of human subjects in Code of Federal
11.21 Regulations, title 45, part 46.

11.22 Subd. 5. **Storage of biological specimens and health data according to storage**
11.23 **schedules.** (a) The commissioner shall store health data according to section 138.17.

11.24 (b) The commissioner shall store biological specimens according to a specimen
11.25 storage schedule. The commissioner shall develop the storage schedule by July 1, 2013,
11.26 and post it on the department's Web site.

11.27 Subd. 6. **Secure storage of biological specimens.** The commissioner shall establish
11.28 appropriate security safeguards for the storage of biological specimens, with regard for
11.29 the privacy of the individuals from whom the biological specimens originated, and store
11.30 the biological specimens accordingly. When a biological specimen is disposed of, it
11.31 must be destroyed in a way that prevents determining the identity of the individual from
11.32 whom it originated.

11.33 Subd. 7. **Applicability to health boards.** The provisions of subdivisions 2; 3,
11.34 paragraphs (a), (c), and (d); and 4 to 6 pertaining to the commissioner also apply to boards
11.35 of health and community health boards organized under chapter 145A. These boards

12.1 may also disseminate health data pursuant to section 13.3805, subdivision 1, paragraph
12.2 (b), clause (2).

12.3 **EFFECTIVE DATE.** This section is effective July 1, 2013.

12.4 Sec. 12. **[144.193] INVENTORY OF BIOLOGICAL AND HEALTH DATA.**

12.5 By February 1, 2014, and annually after that date, the commissioner shall prepare
12.6 an inventory of biological specimens, registries, and health data and databases collected
12.7 or maintained by the commissioner. In addition to the inventory, the commissioner
12.8 shall provide the schedules for storage of health data and biological specimens. The
