1.2 relating to capital investment; authorizing spending to acquire and better public

1.3 land and buildings and for other improvements of a capital nature with certain

1.4 conditions; establishing new programs and modifying existing programs; modifying

1.5 prior appropriations; authorizing the sale and issuance of state bonds; authorizing

1.6 the conveyance of state bond-financed property; requiring reports; appropriating

1.7 money; amending Minnesota Statutes 2022, sections 16A.966, subdivision 2;

1.17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.18 ARTICLE 1

1.19 APPROPRIATIONS

1.20 Section 1. CAPITAL IMPROVEMENT APPROPRIATIONS.

1.21 (a) The sums shown in the column under "Appropriations" are appropriated from the

1.22 bond proceeds fund, or another named fund, to the state agencies or officials indicated, to

1.23 be spent for public purposes. Appropriations of bond proceeds must be spent as authorized

1.24 by the Minnesota Constitution, article XI, section 5, clause (a), to acquire and better public

1.25 land and buildings and other public improvements of a capital nature, or as authorized by

1.26 the Minnesota Constitution, article XI, section 5, clauses (b) to (j), or article XIV. Unless

1.27 otherwise specified, money appropriated in this act:

2.1 (1) may be used to pay state agency staff costs that are attributed directly to the capital
 2.2 program or project in accordance with accounting policies adopted by the commissioner of
 2.3 management and budget;

2.4 (2) is available until the project is completed or abandoned subject to Minnesota Statutes,
 2.5 section 16A.642;

2.6 (3) for activities under Minnesota Statutes, sections 16B.307, 84.946, and 135A.046,
 2.7 should not be used for projects that can be financed within a reasonable time frame under
 2.8 Minnesota Statutes, section 16B.322 or 16C.144;

2.9 (4) is subject to the policies and procedures adopted by the commissioner of management
 2.10 and budget or otherwise specified in applicable law; and

2.11 (5) is available for a grant to a political subdivision after the commissioner of management
 2.12 and budget determines that an amount sufficient to complete the project as described in this
 2.13 act has been committed to the project, as required by Minnesota Statutes, section 16A.502.

2.14 (b) Unless otherwise specified, appropriations in this article from the general fund are
 2.15 made in fiscal year 2024 and are onetime appropriations.

2.16 (c) Recipients of grants from money appropriated in this article must demonstrate to the
 2.17 commissioner of the agency making the grant that the recipient has the ability and a plan
 2.18 to fund the program intended for the facility. This paragraph does not apply to state agencies.

3.5 **Subd. 4. University Share**

3.6 Except for the appropriations for HEAPR, the
 3.7 appropriations in this section are intended to
 3.8 cover approximately two-thirds of the cost of
 3.9 each project. The remaining costs must be paid
 3.10 from university sources.

3.11 **Subd. 5. Unspent Appropriations**

3.12 Upon substantial completion of a project
 3.13 authorized in this section and after written
 3.14 notice to the commissioner of management
 3.15 and budget, the Board of Regents must use
 3.16 any money remaining in the appropriation for
 3.17 that project for HEAPR under Minnesota
 3.18 Statutes, section 135A.046. The Board of
 3.19 Regents must report by February 1 of each
 3.20 even-numbered year to the chairs of the house
 3.21 of representatives and senate committees with
 3.22 jurisdiction over capital investment and higher
 3.23 education finance, and to the chairs of the
 3.24 house of representatives Ways and Means
 3.25 Committee and the senate Finance Committee,
 3.26 on how the remaining money has been
 3.27 allocated or spent.

- 6.30 (b) The board need not pay debt service on
- 6.31 bonds sold to finance HEAPR. Where a
- 6.32 nonstate match is required, the debt service is

7.3 (c) The commissioner of management and
7.4 budget shall reduce the board's assessment
7.5 each year by one-third of the net income from
7.6 investment of general obligation bond
7.7 proceeds in proportion to the amount of
7.8 principal and interest otherwise required to be
7.9 paid by the board. The board shall pay its
7.10 resulting net assessment to the commissioner
7.11 of management and budget by December 1
7.12 each year. If the board fails to make a payment
7.13 when due, the commissioner of management
7.14 and budget shall reduce allotments for
7.15 appropriations from the general fund otherwise
7.16 available to the board and apply the amount
7.17 of the reduction to cover the missed debt
7.18 service payment. The commissioner of
7.19 management and budget shall credit the
7.20 payments received from the board to the bond
7.21 debt service account in the state bond fund
7.22 each December 1 before money is transferred
7.23 from the general fund under Minnesota
7.24 Statutes, section 16A.641, subdivision 10.

7.26 (a) Upon substantial completion of a project
7.27 authorized in this section and after written

7.32 135A.046. The Board of Trustees must report
7.33 by February 1 of each even-numbered year to
7.34 the chairs of the house of representatives and
7.35 senate committees with jurisdiction over

8.1 capital investment and higher education
 8.2 finance and to the chairs of the house of
 8.3 representatives Ways and Means Committee
 8.4 and the senate Finance Committee, on how
 8.5 the remaining money has been allocated or
 8.6 spent.

8.7 (b) The unspent portion of an appropriation
 8.8 for a project in this section that is complete is
 8.9 available for HEAPR under this subdivision,
 8.10 at the same campus as the project for which
 8.11 the original appropriation was made and the
 8.12 debt service requirement under this section is
 8.13 reduced accordingly. Minnesota Statutes,
 8.14 section 16A.642, applies from the date of the
 8.15 original appropriation to the unspent amount
 8.16 transferred.

81.23 bond-financed property in compliance with Minnesota Statutes, section 16A.695, and all
81.24 applicable state and federal laws, and in a manner that will not cause the interest on the state
81.25 general obligation bonds to be subject to federal income taxation for any reason.

81.26 (b) The conveyance shall be in a form approved by the attorney general. The attorney
81.27 general may make changes to the legal description to correct errors and ensure accuracy.

81.28 (c) The commissioner of natural resources has determined that the parcels are no longer
81.29 needed for any state purpose and that the state's interests would best be served if the parcels
81.30 were conveyed to the city of Two Harbors.

81.31 Subd. 2. **Parcels.** The two parcels of property conveyed in subdivision 1 are as follows:

81.32 (1) that part of Government Lot 1, Section 1, Township 52 North, Range 11 West of the

82.21 minutes 09 seconds East along the north line of said Government Lot 3 a distance of 485.19

82.32 **EXEMPTION FOR CONSTRUCTION MATERIALS.**

82.33 **Subdivision 1. Exemption; refund.** (a) Materials and supplies used in and equipment
82.34 incorporated into the construction, reconstruction, upgrade, expansion, or remodeling of
82.35 the River Place Arts, Culture, and Event Center in the city of Warroad, are exempt from

83.1 sales and use tax imposed under Minnesota Statutes, chapter 297A, if materials, supplies,
83.2 and equipment are purchased after May 31, 2023, and before January 1, 2026.

83.3 (b) The tax must be imposed and collected as if the rate under Minnesota Statutes, section
83.4 297A.62, subdivision 1, applied and then refunded in the same manner provided for projects
83.5 under Minnesota Statutes, section 297A.75, subdivision 2, clause (7). Refunds for eligible
83.6 purchases must not be issued until after June 30, 2023.

83.7 Subd. 2. **Appropriation.** \$500,000 is appropriated in fiscal year 2024 from the general
83.8 fund to the commissioner of revenue to pay the refunds under subdivision 1, on a first come,
83.9 first served basis. This appropriation is available until June 30, 2027.

83.10 **EFFECTIVE DATE.** This section is effective the day following final enactment and
83.11 applies to sales and purchases made after May 30, 2023, and before January 1, 2026.

83.12 Sec. 34. **REVISOR INSTRUCTION.**

83.13 The revisor of statutes shall codify Laws 2023, chapter 37, article 2, section 7, in
83.14 Minnesota Statutes, chapter 462A.

83.15 Sec. 35. **EFFECTIVE DATE.**

83.16 Except as otherwise specified, this article is effective the day following final enactment.
