1.3 pathology assistants; setting registration fees; amending Minnesota Statutes 2016,

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2016, section 148.512, subdivision 4, is amended to read:

1.10 Subd. 4. **Applicant.** "Applicant" means a person who applies to the commissioner for
1.11 licensure or licensure renewal, or registration or registration renewal.

1.12 **EFFECTIVE DATE.** This section is effective July 1, 2018.

1.13 Sec. 2. Minnesota Statutes 2016, section 148.512, is amended by adding a subdivision to
1.14 read:

1.15 Subd. 16a. **Register or registered.** "Register" or "registered" means the act or status of
1.16 a person who meets the requirements of section 148.5185.

1.17 **EFFECTIVE DATE.** This section is effective July 1, 2018.

 3.27 **ASSISTANTS.**

3.28 **Subdivision 1. Qualifications for registration.** To be eligible for registration as a
 3.29 speech-language pathology assistant, an applicant must satisfy one of the qualifications
 3.30 listed in section 148.5192, subdivision 1, and must complete at least 100 hours of supervised

4.1 field work experience that meets the requirements of section 148.5192, subdivisions 2 and
 4.2 3.

4.3 Subd. 2. **Scope of practice.** Scope of practice for speech-language pathology assistants
 4.4 is governed by section 148.5192, subdivision 2.

4.5 Subd. 3. **Application procedures.** Application procedures for registration are governed
 4.6 by section 148.519, subdivision 1a.

4.7 Subd. 4. **Action on registration applications.** The commissioner's actions on registration
 4.8 applications are governed by section 148.519, subdivision 2.

4.9 Subd. 5. **Change of name, employment, and address.** Changes to a registered
 4.10 speech-language pathology assistant's name, employment, and address are governed by
 4.11 section 148.519, subdivision 3.

4.12 Subd. 6. **Registration renewal.** Renewal of a speech-language pathology assistant
 4.13 registration is governed by section 148.5191.

4.14 Subd. 7. **Continuing education.** An applicant for registration renewal must meet
 4.15 continuing education requirements established by the commissioner.

4.16 Subd. 8. **Investigation procedures and disciplinary actions.** Complaint investigations
 4.17 and disciplinary actions against registered speech-language pathology assistants are governed
 4.18 by section 148.5195.

4.21 **148.519 LICENSURE AND REGISTRATION PROCEDURES.**

4.22 Subdivision 1. **Applications for licensure.** (a) An applicant for licensure must:

4.23 (1) submit a completed application for licensure on forms provided by the commissioner.
 4.24 The application must include the applicant's name, certification number under chapter 153A,
 4.25 if applicable, business address and telephone number, or home address and telephone number
 4.26 if the applicant practices speech-language pathology or audiology out of the home, and a
 4.27 description of the applicant's education, training, and experience, including previous work
 4.28 history for the five years immediately preceding the date of application. The commissioner
 4.29 may ask the applicant to provide additional information necessary to clarify information
 4.30 submitted in the application; and

5.1 (2) submit documentation of the certificate of clinical competence issued by the American
 5.2 Speech-Language-Hearing Association, board certification by the American Board of
 5.3 Audiology, or satisfy the following requirements:

5.4 (i) submit a transcript showing the completion of a master's or doctoral degree or its
 5.5 equivalent meeting the requirements of section 148.515, subdivision 2;

5.6 (ii) submit documentation of the required hours of supervised clinical training;

5.7 (iii) submit documentation of the postgraduate clinical or doctoral clinical experience
 5.8 meeting the requirements of section 148.515, subdivision 4; and

5.9 (iv) submit documentation of receiving a qualifying score on an examination meeting
 5.10 the requirements of section 148.515, subdivision 6.

5.11 (b) In addition, an applicant must:

5.12 (1) sign a statement that the information in the application is true and correct to the best
 5.13 of the applicant's knowledge and belief;

5.14 (2) submit with the application all fees required by section 148.5194; and

5.15 (3) sign a waiver authorizing the commissioner to obtain access to the applicant's records
 5.16 in this or any other state in which the applicant has engaged in the practice of speech-language
 5.17 pathology or audiology.

5.18 Subd. 1a. **Applications for registration.** An applicant for registration must submit to
 5.19 the commissioner:

5.20 (1) a completed registration application on forms provided by the commissioner. The
 5.21 application must include the applicant's name, business address and telephone number,
 5.22 home address and telephone number, and a description of the applicant's education, training,
 5.23 and experience, including previous work history for the five years immediately preceding
 5.24 the application date. The commissioner may ask the applicant to provide additional
 5.25 information needed to clarify information submitted in the application;

5.26 (2) documentation that the applicant satisfied one of the qualifications listed in section
 5.27 148.5192, subdivision 1, and that the applicant completed at least 100 hours of supervised
 5.28 field work experience that meets the requirements of section 149.5192, subdivisions 2 and
 5.29 3;

5.30 (3) a signed statement that the information in the application is true and correct to the
 5.31 best of the applicant's knowledge and belief;

5.32 (4) all fees required under section 148.5194; and

6.1 (5) a signed waiver authorizing the commissioner to obtain access to the applicant's
6.2 records in this or any other state in which the applicant has worked as a speech-language
6.3 pathology assistant.

6.4 **Subd. 2. Action on applications for licensure or registration.** (a) The commissioner
6.5 shall act on an application for licensure or registration according to paragraphs (b) to (d).

6.6 (b) The commissioner shall determine if the applicant meets the requirements for licensure
6.7 or registration. The commissioner or advisory council may investigate information provided
6.8 by an applicant to determine whether the information is accurate and complete.

6.9 (c) The commissioner shall notify an applicant, via certified mail, of action taken on the
6.10 application and of the grounds for denying licensure or registration if licensure or registration
6.11 is denied.

6.12 (d) An applicant denied licensure or registration may make a written request to the
6.13 commissioner, within 30 days of the date of notification to the applicant, for reconsideration
6.14 of the denial. Individuals requesting reconsideration may submit information that the
6.15 applicant wants considered in the reconsideration. After reconsideration of the commissioner's
6.16 determination to deny licensure or registration, the commissioner shall determine whether
6.17 the original determination should be affirmed or modified. An applicant may make only
6.18 one request in any one biennial license or registration period for reconsideration of the
6.19 commissioner's determination to deny licensure or registration.

6.20 **Subd. 3. Change of name, employment, and addresses.** A licensee or registrant who
6.21 changes addresses must inform the commissioner, in writing, of the change of name,
6.22 employment, or address within 30 days. A change in name must be accompanied by a copy
6.23 of a marriage certificate or court order. All notices or other correspondence mailed to or
6.24 served on a licensee or registrant by the commissioner at the licensee's or registrant's address
6.25 on file with the commissioner shall be considered as having been received by the licensee
6.26 or registrant.

6.27 **EFFECTIVE DATE.** This section is effective July 1, 2018.

6.28 Sec. 9. Minnesota Statutes 2016, section 148.5191, is amended to read:

6.29 **148.5191 LICENSURE AND REGISTRATION RENEWAL.**

6.30 Subdivision 1. **Renewal requirements.** To renew licensure or registration, an applicant
6.31 must:

7.1 (1) biennially complete a renewal application on a form provided by the commissioner
7.2 and submit the biennial renewal fee;

7.3 (2) for license renewal, meet the continuing education requirements of section 148.5193
7.4 and submit evidence of attending continuing education courses, as required in section
7.5 148.5193, subdivision 6, and for registration renewal, meet the continuing education
7.6 requirements of section 148.5185, subdivision 7, and submit evidence of attending continuing
7.7 education courses; and

7.8 (3) submit additional information if requested by the commissioner to clarify information
7.9 presented in the renewal application. The information must be submitted within 30 days
7.10 after the commissioner's request.

7.11 Subd. 2. **Late fee.** An application submitted after the renewal deadline date must be
7.12 accompanied by a late fee as provided in section 148.5194, subdivision 4.

7.13 Subd. 3. **Licensure and registration renewal notice.** Licensure renewal and registration
7.14 renewal is on a biennial basis. At least 60 days before the licensure or registration expiration
7.15 date, the commissioner shall send out a renewal notice to the licensee's or registrant's last
7.16 known address. The notice shall include a renewal application and notice of fees required
7.17 for renewal. If the licensee or registrant does not receive the renewal notice, the licensee or
7.18 registrant is still required to meet the deadline for renewal to qualify for continuous licensure
7.19 or registration status.

7.20 Subd. 4. **Renewal deadline.** Each license or registration, including a temporary license
7.21 provided under section 148.5161, must state an expiration date. An application for licensure
7.22 renewal or registration renewal must be received by the Department of Health or postmarked
7.23 at least 30 days before the expiration date. If the postmark is illegible, the application shall
7.24 be considered timely if received at least 21 days before the expiration date.

7.25 When the commissioner establishes the renewal schedule for an applicant, licensee, ~~or~~
7.26 temporary licensee, or registrant, if the period before the expiration date is less than two
7.27 years, the fee shall be prorated.

8.3 Subd. 8. **Penalty fees.** (a) The penalty fee for practicing speech-language pathology or
8.4 audiology or using protected titles without a current license after the credential has expired
8.5 and before it is renewed is the amount of the license renewal fee for any part of the first
8.6 month, plus the license renewal fee for any part of any subsequent month up to 36 months.
8.7 The penalty fee for a speech-language pathology assistant who uses protected titles without
8.8 a current registration after the registration has expired and before it is renewed is the amount
8.9 of the registration renewal fee for any part of the first month, plus the registration renewal
8.10 fee for any part of any subsequent month up to 36 months.

8.11 (b) The penalty fee for applicants who engage in the unauthorized practice of
8.12 speech-language pathology or audiology or using protected titles before being issued a
8.13 license is the amount of the license application fee for any part of the first month, plus the
8.14 license application fee for any part of any subsequent month up to 36 months. The penalty
8.15 fee for a speech-language pathology assistant who uses protected titles without being issued
8.16 a registration is the amount of the registration application fee for any part of the first month,
8.17 plus the registration application fee for any part of any subsequent month up to 36 months.
8.18 This paragraph does not apply to applicants not qualifying for a license who engage in the
8.19 unauthorized practice of speech language pathology or audiology.

8.20 (c) The penalty fee for practicing speech-language pathology or audiology and failing
8.21 to submit a continuing education report by the due date with the correct number or type of
8.22 hours in the correct time period is \$100 plus \$20 for each missing clock hour. The penalty
8.23 fee for a registered speech-language pathology assistant who fails to submit a continuing
8.24 education report by the due date with the correct number or type of hours in the correct time
8.25 period is \$100 plus \$20 for each missing clock hour. "Missing" means not obtained between
8.26 the effective and expiration dates of the certificate, the one-month period following the
8.27 certificate expiration date, or the 30 days following notice of a penalty fee for failing to
8.28 report all continuing education hours. The licensee or registrant must obtain the missing
8.29 number of continuing education hours by the next reporting due date.

8.30 (d) Civil penalties and discipline incurred by licensees prior to August 1, 2005, for
8.31 conduct described in paragraph (a), (b), or (c) shall be recorded as nondisciplinary penalty
8.32 fees. For conduct described in paragraph (a) or (b) occurring after August 1, 2005, and
8.33 exceeding six months, payment of a penalty fee does not preclude any disciplinary action
8.34 reasonably justified by the individual case.

9.13 (2) failed, within 30 days, to provide information in response to a written request by the

9.15 (3) performed services of a speech-language pathologist ~~or~~, audiologist, or
 9.16 speech-language pathology assistant in an incompetent or negligent manner;

9.17 (4) violated sections 148.511 to 148.5198;

9.18 (5) failed to perform services with reasonable judgment, skill, or safety due to the use
 9.19 of alcohol or drugs, or other physical or mental impairment;

9.20 (6) violated any state or federal law, rule, or regulation, and the violation is a felony or

10.5 a willful or careless disregard for the health, welfare, or safety of a client;

10.6 (12) failed to disclose to the consumer any fee splitting or any promise to pay a portion
10.7 of a fee to any other professional other than a fee for services rendered by the other
10.8 professional to the client;

10.9 (13) engaged in abusive or fraudulent billing practices, including violations of federal
10.10 Medicare and Medicaid laws, Food and Drug Administration regulations, or state medical
10.11 assistance laws;

10.12 (14) obtained money, property, or services from a consumer through the use of undue
10.13 influence, high pressure sales tactics, harassment, duress, deception, or fraud;

10.14 (15) performed services for a client who had no possibility of benefiting from the services;

10.15 (16) failed to refer a client for medical evaluation or to other health care professionals
10.16 when appropriate or when a client indicated symptoms associated with diseases that could
10.17 be medically or surgically treated;

10.18 (17) had the certification required by chapter 153A denied, suspended, or revoked
10.19 according to chapter 153A;

10.20 (18) used the term doctor of audiology, doctor of speech-language pathology, AuD, or
10.21 SLPD without having obtained the degree from an institution accredited by the North Central
10.22 Association of Colleges and Secondary Schools, the Council on Academic Accreditation
10.23 in Audiology and Speech-Language Pathology, the United States Department of Education,
10.24 or an equivalent;

10.25 (19) failed to comply with the requirements of section 148.5192 regarding supervision
10.26 of speech-language pathology assistants; or

10.27 (20) if the individual is an audiologist or certified hearing instrument dispenser:

10.28 (i) prescribed or otherwise recommended to a consumer or potential consumer the use
10.29 of a hearing instrument, unless the prescription from a physician or recommendation from
10.30 an audiologist or certified dispenser is in writing, is based on an audiogram that is delivered
10.31 to the consumer or potential consumer when the prescription or recommendation is made,
10.32 and bears the following information in all capital letters of 12-point or larger boldface type:

11.8 (iv) failed to comply with restrictions on sales of hearing instruments in sections
 11.9 148.5197, subdivision 3, and 148.5198;

11.10 (v) failed to return a consumer's hearing instrument used as a trade-in or for a discount
 11.11 in the price of a new hearing instrument when requested by the consumer upon cancellation
 11.12 of the purchase agreement;

11.13 (vi) failed to follow Food and Drug Administration or Federal Trade Commission
 11.14 regulations relating to dispensing hearing instruments;

11.15 (vii) failed to dispense a hearing instrument in a competent manner or without appropriate
 11.16 training;

11.17 (viii) delegated hearing instrument dispensing authority to a person not authorized to
 11.18 dispense a hearing instrument under this chapter or chapter 153A;

11.19 (ix) failed to comply with the requirements of an employer or supervisor of a hearing
 11.20 instrument dispenser trainee;

11.31 (2) suspend licensure or registration for a period not exceeding one year;

12.17 (1) three public members, as defined in section 214.02. Two of the public members shall
12.18 be either persons receiving services of a speech-language pathologist or audiologist, or
