1.5	Section 1. Minnesota Statutes 2022, section 179A.03, subdivision 14, is amended to read:
1.6	Subd. 14. Public employee or employee. (a) "Public employee" or "employee" means
1.7	any person appointed or employed by a public employer except:
1.8	(1) elected public officials;
1.9	(2) election officers;
1.10	(3) commissioned or enlisted personnel of the Minnesota National Guard;
1.11	(4) emergency employees who are employed for emergency work caused by natural
1.12	disaster;
1.13	(5) part-time employees whose service does not exceed the lesser of 14 hours per week
1.14	or 35 percent of the normal work week in the employee's appropriate unit;
1.15	(6) employees whose positions are basically temporary or seasonal in character and: (i)
1.16	are not for more than 67 working days in any calendar year; or (ii) are not for more than
1.17	100 working days in any calendar year and the employees are under the age of 22, are
1.18	full-time students enrolled in a nonprofit or public educational institution prior to being
